PUBLIC NOTICE**Announcing the Modification of the Phase I Municipal Stormwater General Permit**

The Washington state department of ecology (ecology) is modifying the Phase I Municipal Stormwater National Pollutant Discharge Elimination System and State Waste Discharge General Permit (permit) on October 20, 2021. The permit modification becomes effective on October 20, 2021, and expires on July 31, 2024.

Purpose of the Permit: The Phase I Municipal Stormwater General Permit regulates the discharges from storm sewer systems owned or operated by Clark, King, Pierce, and Snohomish counties; the cities of Seattle and Tacoma; and public entities located in these cities and counties. The permit requires these municipalities and secondary permittees to protect surface water and groundwater quality by developing and implementing a stormwater management program to control stormwater runoff into and from their storm sewer systems.

Modifications to the Permit: One of the Phase I Municipal Stormwater Permit requirements is for Phase I municipalities to adopt a stormwater program that will provide equal or similar protection of receiving waters and pollutant control as compared to Appendix 1 of the permit. This modification will incorporate, in Appendix 10 of the permit, ecology's determination of equivalency for these stormwater programs.

Public Notice Process and Comments: Ecology accepted public comments on the draft permit and fact sheet from July 21, 2021, *through* August 27, 2021. Ecology held informational public workshops and hearings during this time via online statewide webinars on August 24, 2021, at both 9:00 a.m. and 5:00 p.m. Ecology received written public comments and emails. The comments and ecology's responses are included as Appendix D of the fact sheet.

QUESTIONS:

SET ONE:

1. Do RCW 71.05.150 and RCW 71.05.153 establish a legal duty for peace officers? And would the decision to not respond pursuant to these provisions constitute a breach of a legal duty?

2. If a peace officer is not authorized to use physical force to conduct an investigatory detention where there is reasonable suspicion, but not probable cause as required by RCW 10.120.020(1), that the person is involved in criminal activity, then can the person lawfully evade or flee the officer attempting to conduct the investigation? In the absence of the circumstances delineated in RCW 10.120.020(1), under what authority, if any, could the officer pursue a fleeing suspect? Can the officer use physical force to stop or detain a fleeing suspect?

3. Does RCW 10.120.020 (2)(a) require peace officers to leave the scene where there is a high likelihood of the use of

physical force and where there is no threat of imminent harm and no reasonable suspicion of criminal activity? If a peace officer is required to leave a scene under such circumstances, would it be reasonable for a peace officer to not respond to a scene because information known to the peace officer indicates that there is a high likelihood of the use of physical force and that there is no threat of imminent harm and no reasonable suspicion of criminal activity? Would the refusal to respond to such a scene breach a legal duty? And would that constitute an exception to the Public Duty Doctrine?

4. How should RCW 10.120.020 (1)(b) be read together with RCW 9A.16.040?

5. How should RCW 10.120.020 be read in context of the Court's ruling in *Graham v. Connor*?

6. Is RCW 10.120.020 consistent with the Court's "objectively reasonable" standard in *Graham v. Connor*?

7. Is a peace officer's use of force lawful if it is consistent with the Court's ruling in *Graham v. Connor* but is not consistent with RCW 10.120.020?

SET TWO:

1. Do the restrictions on the acquisition and use of "firearms and ammunition of .50 caliber or greater" in RCW 10.116.040 apply only to pistols, rifles, and conventional ammunition typically measured by caliber? Put another way, does the same provision prohibit the acquisition and use of a firearm or conventional ammunition measuring at .50 inches or greater even if the particular firearm or conventional ammunition is not typically measured by caliber, including, for example, shotguns and shotgun slugs?

2. Does RCW 10.116.040 prohibit law enforcement agencies from acquiring and/or using any firearm with a barrel diameter of .50 inches or greater even if the device is being acquired and/or used for the purpose of deploying less lethal alternatives?

3. Does RCW 10.116.040 prohibit law enforcement agencies from acquiring and/or using less lethal alternatives (i.e. rubber bullets, beanbag rounds, tear gas rounds, flash bang rounds, baton rounds, and other less lethal projectiles) with a diameter of .50 inches or greater?

Effective Date: November 1, 2021.

Description: The health care authority (HCA) intends to submit medicaid SPA 21-0032 in order to obtain medicaid funds to reimburse birthing hospitals to support the "rooming in" of the birth parent with their newborn following an in-utero exposure to substances that may lead to physiologic dependence, until the newborn is recovered from neonatal abstinence syndrome (NAS) or neonatal opioid withdrawal syndrome (NOWS) and/or is otherwise ready to be medically discharged. The intent is to provide a newborn administrative day rate or daily reimbursement to help offset the cost of providing the postpartum parent with room and board and limited additional services that are centered on the care and well-being of the newborn.

This SPA reflects HCA's response to SSB 5380 which directed HCA to make recommendations on ways to improve the care of birth parents with opioid use disorder and their newborns. Substantial research indicates that keeping the birth parent with the newborn during the exposed newborn's period of observation and potential withdrawal of NAS/

NOWS as the first-line non-medication treatment is associated with better outcomes for both the birth parent and the newborn.

Based on this evidence, HCA recommended that the state authorize HCA to provide funds for the first-line non-medication treatment of newborns by reimbursing birthing hospitals to support the "rooming in" and continuous care from the birth parent for their newborn when there has been in-utero exposure to substances that may lead to physiologic dependence.

SPA 21-0032 is expected to have no effect on the annual aggregate payment for this service. HCA anticipates the increased payment for the administrative day to be offset by a reduction in the length of stay required for infants with NAS/NOWS. Studies published by the National Association of Neonatal Nurses report a reduction in hospital stay days ranging from 35-74 percent. HCA anticipates shorter stays with a higher payment creating a net of effect of \$0.

SPA 21-0032 is in the development process; therefore, a copy is not yet available for review. HCA would appreciate any input or concerns regarding this SPA.
