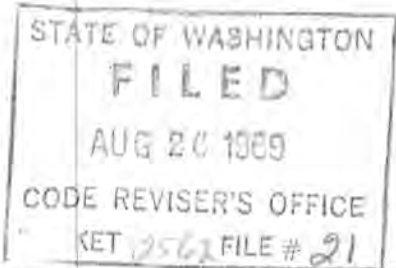

Administrative Order No. 1  
WTFRC Order Register (WAC 1-12-040)

A RESOLUTION Relating to emergency regulations of the Washington Tree Fruit Research Commission.

BE IT RESOLVED BY THE WASHINGTON TREE FRUIT RESEARCH COMMISSION, STATE OF WASHINGTON:

Section 1. That the adoption of the annexed emergency regulations is necessary for the preservation of the public health, safety, or general welfare.

Section 2. The annexed emergency regulations, to wit: Order No. 1 relating to the payment and collection of assessments by producers of tree fruit, subject to the provisions of Chapter 129, Laws of 1969, are hereby approved and adopted as emergency regulations of the Washington Tree Fruit Research Commission.

Section 3. This resolution and annexed emergency regulations, after being first recorded as an emergency administrative order in the Order Register of the Washington Tree Fruit Research Commission, shall be forwarded to the Code Reviser for filing pursuant to RCW 34.04 and WAC 1-12-040.

EMERGENCY REGULATIONS OF THE  
WASHINGTON TREE FRUIT RESEARCH COMMISSION

Regulation No. 1. TIME, PLACE, METHOD FOR PAYMENT AND COLLECTION OF ASSESSMENTS. All persons purchasing, or receiving commercial tree fruit for sale, processing, or shipment anywhere, shall withhold the assessment due and payable the Washington Tree Fruit Research Commission by producers of such commercial tree fruit and remit such assessment, (1) to the Washington State Apple Advertising Commission, when such assessment has been withheld for apples. Such remittance shall be made in the same manner and time as assessments due the said Washington State Apple Advertising Commission for apple advertising assessments, and (2) to the Washington State Fruit Commission, when such assessment has been withheld for any other tree fruit including winter pears. Such remittance shall be made in the same manner and time as assessments due the said Washington State Fruit Commission.

Regulation No. 2. The Washington State Department of Agriculture may upon request of the Washington Tree Fruit Research Commission collect any or all assessments due and payable to the Washington Tree Fruit Research Commission.

Regulation No. 3. All assessments collected by the Washington State Apple Advertising Commission, the Washington State Fruit Commission and the Washington State Department of Agriculture shall be paid to the Washington Tree Fruit Research Commission within thirty days of such collection.
