

N O T I C E

The following resolution and regulation was duly and regularly passed and adopted at a regular meeting, April 10, 1967, of the State Game Commission for the State of Washington.

RESOLVED: That the Temporary Rule and Regulation hereinafter set forth was duly ordered, adopted and promulgated by vote of the State Game Commission to be effective as of date of first publication.

RESOLVED FURTHER: That the following restriction on applicants for controlled elk hunts is hereby established until further notice by the State Game Commission:

It shall be unlawful for a person to apply for an elk hunting permit for the next two consecutive elk seasons following the drawing of such a permit by said person. This restriction shall become effective with permittees drawn for the 1967 elk hunting season. This restriction does not apply to permittees drawn prior to 1967.

The foregoing Temporary Rule and Regulation shall be forthwith entered and recorded in the minutes of the Commission and published in Olympia, Thurston County, Washington, as provided by law.
