The following resolution and regulation was duly and regularly passed and adopted at a regular meeting, January 12, 1970, of the State Game Commission for the State of Washington.

RESOLVED: That the Permanent and Emergency Rule and Regulation hereinafter set forth was duly ordered, adopted and promulgated by vote of the State Game Commission.

RESOLVED FURTHER: That Permanent and Emergency Regulation WAC 232-12-580 shall read as follows:

WAC 232-12-580 REGISTRATION OF SNOWMOBILES. (1) It shall be unlawful for any person to use any snowmobile, snow cat, or similar motor driven snow sledge on land owned, leased or held by the department of game unless such vehicle has first been registered with the department and an identifying number assigned to said snow vehicle. Such numbers shall be supplied by the department and visibly displayed on the snow vehicle.

(2) A fee of 50 cents for cost reimbursement of registration shall be paid by the registrant.

(3) Registration, as provided herein, shall be valid until there is a change of ownership of such vehicle.

The foregoing Permanent and Emergency Rule and Regulation WAC 232-12-580 shall be forthwith entered and recorded in the minutes of the Commission and published in Olympia, Thurston County, Washington, as provided by law.
