1 AN ACT Relating to livestock; amending RCW 16.57.080, 16.57.160,
2 16.57.240, 16.57.280, 16.57.360, and 16.57.380; and prescribing
3 penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 16.57.080 and 1974 ex.s. c 64 s 2 are each amended to
6 read as follows:

7 ~~((The director shall, on or before the first day of September 1975,~~
8 ~~and every two years thereafter, notify by letter the owners of brands~~
9 ~~then of record, that on the payment of twenty-five dollars and~~
10 ~~application of renewal, the director shall issue written proof of~~
11 ~~payment allowing the brand owner exclusive ownership and use of such~~
12 ~~brand for another two year period.)) The director shall establish by
13 rule a schedule for the renewal of registered brands. The fee for
14 renewal of the brands shall be twenty-five dollars for each two-year
15 period of brand ownership, except that the director may, in adopting a~~

1 renewal schedule, provide for the collection of renewal fees on a
2 prorated basis. At least one hundred twenty days before the expiration
3 of a registered brand, the director shall notify by letter the owner of
4 record of the brand that on the payment of the requisite application
5 fee and application of renewal the director shall issue the proof of
6 payment allowing the brand owner exclusive ownership and use of the
7 brand for the subsequent registration period. The failure of the
8 registered owner to pay the renewal fee by ~~((December 31st of the~~
9 ~~renewal year))~~ the date required by rule shall cause such owner's brand
10 to revert to the department. The director may for a period of one year
11 following such reversion, reissue such brand only to the prior
12 registered owner upon payment of twenty-five dollars and an additional
13 fee of ten dollars for renewal subsequent to the regular renewal
14 period. The director may at his discretion, if such brand is not
15 reissued within one year to the prior registered owner, issue such
16 brand to any other applicant.

17 **Sec. 2.** RCW 16.57.160 and 1981 c 296 s 16 are each amended to read
18 as follows:

19 ~~((Brand inspection of cattle shall be mandatory at the following~~

21 ~~(1) Prior to being moved out of state to any point where brand~~
22 ~~inspection is not maintained by the director, directly or in agreement~~

26 ~~from brand inspection by law or regulation adopted by the director in~~

1 ~~(3) Prior to slaughter at any point of slaughter unless such cattle~~
2 ~~are exempt from such brand inspection by law or regulations adopted by~~

4 ~~immediate slaughter cattle shipped directly to a point of slaughter~~
5 ~~from another state and accompanied by a brand inspection certificate~~
6 ~~specifically identifying such cattle issued by the state of origin or~~
7 ~~a lawful agency thereof.~~

8 ~~(4) Prior to the branding of any cattle except as otherwise~~
9 ~~provided by law or regulation.~~

10 ~~(5) Prior to the sale of any cattle except as otherwise provided by~~
11 ~~law or regulation.))~~

12 The director may by ~~((regulation))~~ rule adopted subsequent to a
13 public hearing designate any ~~((other))~~ point for mandatory brand
14 inspection of cattle or the furnishing of proof that cattle passing or
15 being transported through such points have been brand inspected and are
16 lawfully being moved. Further, the director may stop vehicles carrying
17 cattle to determine if such cattle are identified ~~((or))~~, branded ((as
18 ~~immediate slaughter cattle, and if so that such cattle are not being~~
19 ~~diverted for other purposes to points other than the specified point of~~
20 ~~slaughter))~~, or accompanied by the form prescribed by the director
21 under RCW 16.57.240 or a brand certificate issued by the department.

22 **Sec. 3.** RCW 16.57.240 and 1985 c 415 s 8 are each amended to read
23 as follows:

24 Any person purchasing, selling, holding for sale, trading,
25 bartering, transferring title, slaughtering, handling, or transporting
26 cattle shall keep a record on forms prescribed by the director. Such
27 forms shall show the number, specie, brand or other method of
28 identification of such cattle and any other necessary information
29 required by the director. ~~((Such records shall be made in~~

1 ~~triplicate;~~) The original shall be kept for a period of three years
2 ((and)) or shall be furnished to the director upon demand or as
3 prescribed by rule, one copy shall accompany the cattle to their
4 destination ((and one copy shall be kept by the person handling the
5 transaction for a period of at least twelve months following the
6 transaction)) and shall be subject to inspection at any time by the
7 director or any peace officer or member of the state patrol: PROVIDED,
8 That in the following instances only, cattle may be moved or
9 transported within this state without being accompanied by a
10 certificate of permit or an official brand inspection certificate or
11 bill of sale:

12 (1) When such cattle are moved or transported upon lands under the
13 exclusive control of the person moving or transporting such cattle;

14 (2) When such cattle are being moved or transported for temporary
15 grazing or feeding purposes and have the registered brand of the person
16 having or transporting such cattle.

17 **Sec. 4.** RCW 16.57.280 and 1959 c 54 s 28 are each amended to read
18 as follows:

19 No person shall knowingly have ((in his)) unlawful possession of
20 any livestock marked with a recorded brand or tattoo of another person
21 unless:

22 (1) Such livestock lawfully bears ((his)) the person's own healed
23 recorded brand, or

24 (2) Such livestock is accompanied by a certificate of permit from
25 the owner of the recorded brand or tattoo, or

26 (3) Such livestock is accompanied by a brand inspection
27 certificate, or

28 (4) Such livestock is accompanied by a bill of sale from the
29 previous owner or other satisfactory proof of ownership.

1 A violation of this section constitutes a gross misdemeanor.

2 **Sec. 5.** RCW 16.57.360 and 1959 c 54 s 36 are each amended to read
3 as follows:

4 The department is authorized to issue notices of and enforce civil
5 infractions in the manner prescribed under chapter 7.80 RCW.

6 The violation of any provision of this chapter and/or rules and
7 regulations adopted hereunder shall constitute a ((misdemeanor)) class
8 I civil infraction as provided under chapter 7.80 RCW unless otherwise
9 specified herein.

10 **Sec. 6.** RCW 16.57.380 and 1981 c 296 s 22 are each amended to read
11 as follows:

3 The director may by ~~((regulation))~~ rule adopted subsequent to a
4 public hearing designate any ~~((other))~~ point for mandatory brand
5 inspection of horses or the furnishing of proof that horses passing or
6 being transported through such points have been brand inspected and are
7 lawfully being moved. Further, the director may stop vehicles carrying
8 horses to determine if such horses are identified or branded ~~((as~~
9 ~~immediate slaughter horses, and if so that such horses are not being~~
10 ~~diverted for other purposes to points other than the specified point of~~
11 ~~slaughter))~~.
