- 1 AN ACT Relating to fire protection sprinkler systems; amending RCW
- 2 18.160.030; adding a new section to chapter 9.45 RCW; adding new
- 3 sections to chapter 18.160 RCW; prescribing penalties; and declaring an
- 4 emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9.45 RCW
- 7 to read as follows:
- 8 Any fire protection sprinkler system contractor, defined under RCW
- 9 18.160.010, who willfully and maliciously constructs, installs, or
- 10 maintains a fire protection sprinkler system in any structure so as to
- 11 threaten the safety of any occupant or user of the structure in the
- 12 event of a fire, is guilty of a class C felony. This section may not
- 13 be construed to create any criminal liability for a prime contractor or
- 14 an owner of a structure unless it is proved that the prime contractor

- 1 or owner had actual knowledge of an illegal construction, installation,
- 2 or maintenance of a fire protection sprinkler system by a fire
- 3 protection sprinkler system contractor.
- 4 Sec. 2. RCW 18.160.030 and 1990 c 177 s 4 are each amended to read
- 5 as follows:
- 6 (1) This chapter shall be administered by the state director of
- 7 fire protection.
- 8 (2) The state director of fire protection shall have the authority,
- 9 and it shall be his or her duty to:
- 10 (a) Issue such administrative regulations as necessary for the
- 11 administration of this chapter;
- 12 (b)(i) Set reasonable fees for licenses, certificates, testing, and
- 13 other aspects of the administration of this chapter. However, the
- 14 license fee for fire protection sprinkler system contractors engaged
- 15 solely in the installation, inspection, maintenance, or servicing of
- 16 NFPA 13-D fire protection sprinkler systems shall not exceed one
- 17 hundred dollars, and the license fee for fire protection sprinkler
- 18 system contractors engaged solely in the installation, inspection,
- 19 maintenance, or servicing of NFPA 13-R fire protection sprinkler
- 20 systems shall not exceed three hundred dollars;
- 21 (ii) Adopt rules establishing a special category restricted to
- 22 <u>contractors registered under chapter 18.27 RCW who install underground</u>
- 23 systems that service fire protection sprinkler systems. The rules
- 24 shall be adopted within ninety days of the effective date of this act;
- 25 (c) Enforce the provisions of this chapter;
- 26 (d) Conduct investigations of complaints to determine if any
- 27 infractions of this chapter or the regulations developed under this
- 28 chapter have occurred;

- 1 (e) Work with the fire sprinkler advisory committee consisting of
- 2 fire protection sprinkler system contractors and other related
- 3 officials;
- 4 (f) Assign a certificate number to each certificate of competency
- 5 holder; and
- 6 (g) Adopt rules necessary to implement and administer a program
- 7 which requires the affixation of a seal any time a fire protection
- 8 sprinkler system is installed, which seal shall include the certificate
- 9 number of any certificate of competency holder who installs, in whole
- 10 or in part, the fire protection sprinkler system.
- 11 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 18.160 RCW
- 12 to read as follows:
- 13 Any fire protection sprinkler system contractor who constructs,
- 14 installs, or maintains a fire protection sprinkler system in any
- 15 occupancy, except an owner-occupied single-family dwelling, without
- 16 first obtaining a fire sprinkler contractor's license from the state of
- 17 Washington, is guilty of a gross misdemeanor. This section may not be
- 18 construed to create any criminal liability for a prime contractor or an
- 19 owner of an occupancy unless it is proved that the prime contractor or
- 20 owner had actual knowledge of an illegal construction, installation, or
- 21 maintenance of a fire protection sprinkler system by a fire protection
- 22 sprinkler system contractor.
- NEW SECTION. Sec. 4. A new section is added to chapter 18.160 RCW
- 24 to read as follows:
- 25 Civil proceedings to enforce this chapter may be brought by the
- 26 attorney general or the prosecuting attorney of any county where a
- 27 violation occurs on his or her own motion or at the request of the
- 28 state director of fire protection.

- 1 <u>NEW SECTION.</u> **Sec. 5.** This act is necessary for the immediate
- 2 preservation of the public peace, health, or safety, or support of the
- 3 state government and its existing public institutions, and shall take
- 4 effect immediately.
