- AN ACT Relating to Washington public employees' retirement system;
- 2 amending RCW 41.40.150; creating a new section; and providing an
- 3 effective date.

Means.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 Sec. 1. RCW 41.40.150 and 1990 c 249 s 17 are each amended to read
- 6 as follows:
- 7 Should any member die, or should the individual separate or be
- 8 separated from service without leave of absence before attaining age
- 9 sixty years, or should the individual become a beneficiary, except a
- 10 beneficiary of an optional retirement allowance as provided by RCW
- 11 41.40.188, the individual shall thereupon cease to be a member except;
- 12 (1) As provided in RCW 41.40.170.
- 13 (2) An employee not previously retired who reenters service shall
- 14 upon completion of six months of continuous service and upon the
- 15 restoration, in one lump sum or in annual installments, of all

- 1 withdrawn contributions with interest as computed by the director,
- 2 which restoration must be completed within a total period of five years
- 3 of membership service following the member's first resumption of
- 4 employment, be returned to the status, either as an original member or
- 5 new member which the member held at time of separation.
- 6 (3) Within the ninety days following the employee's resumption of
- 7 employment, the employer shall notify the department of the resumption
- 8 and the department shall then return to the employer a statement of the
- 9 potential service credit to be restored, the amount of funds required
- 10 for restoration, and the date when the restoration must be
- 11 accomplished. The employee shall be given a copy of the statement and
- 12 shall sign a copy of the statement which signed copy shall be placed in
- 13 the employee's personnel file.
- 14 (4) A member who separates or has separated after having completed
- 15 at least five years of service shall remain a member during the period
- 16 of absence from service for the exclusive purpose of receiving a
- 17 retirement allowance to begin at attainment of age sixty-five, however,
- 18 such a member may on written notice to the director elect to receive a
- 19 reduced retirement allowance on or after age sixty which allowance
- 20 shall be the actuarial equivalent of the sum necessary to pay regular
- 21 retirement benefits as of age sixty-five: PROVIDED, That if such
- 22 member should withdraw all or part of the member's accumulated
- 23 contributions except those additional contributions made pursuant to
- 24 RCW 41.40.330(2), the individual shall thereupon cease to be a member
- 25 and this section shall not apply.
- 26 (5)(a) The recipient of a retirement allowance who is employed in
- 27 an eligible position other than under RCW 41.40.120(12) shall be
- 28 considered to have terminated his or her retirement status and shall
- 29 immediately become a member of the retirement system with the status of
- 30 membership the member held as of the date of retirement. Retirement

- 1 benefits shall be suspended during the period of eligible employment
- 2 and the individual shall make contributions and receive membership
- 3 credit. Such a member shall have the right to again retire if eligible
- 4 in accordance with RCW 41.40.180: PROVIDED, That where any such right
- 5 to retire is exercised to become effective before the member has
- 6 rendered two uninterrupted years of service the type of retirement
- 7 allowance the member had at the time of the member's previous
- 8 retirement shall be reinstated;
- 9 (b) The recipient of a retirement allowance elected to office or
- 10 appointed to office directly by the governor, and who shall apply for
- 11 and be accepted in membership as provided in RCW 41.40.120(3) shall be
- 12 considered to have terminated his or her retirement status and shall
- 13 become a member of the retirement system with the status of membership
- 14 the member held as of the date of retirement. Retirement benefits
- 15 shall be suspended from the date of return to membership until the date
- 16 when the member again retires and the member shall make contributions
- 17 and receive membership credit. Such a member shall have the right to
- 18 again retire if eligible in accordance with RCW 41.40.180: PROVIDED,
- 19 That where any such right to retire is exercised to become effective
- 20 before the member has rendered six uninterrupted months of service the
- 21 type of retirement allowance the member had at the time of the member's
- 22 previous retirement shall be reinstated, but no additional service
- 23 credit shall be allowed: AND PROVIDED FURTHER, That if such a
- 24 recipient of a retirement allowance does not elect to apply for reentry
- 25 into membership as provided in RCW 41.40.120(3), the member shall be
- 26 considered to remain in a retirement status and the individual's
- 27 retirement benefits shall continue without interruption.
- 28 (6) Any member who leaves the employment of an employer and enters
- 29 the employ of a public agency or agencies of the state of Washington,
- 30 other than those within the jurisdiction of the Washington public

- 1 employees' retirement system, and who establishes membership in a
- 2 retirement system or a pension fund operated by such agency or agencies
- 3 and who shall continue membership therein until attaining age sixty,
- 4 shall remain a member for the exclusive purpose of receiving a
- 5 retirement allowance without the limitation found in RCW 41.40.180(1)
- 6 to begin on attainment of age sixty-five; however, such a member may on
- 7 written notice to the director elect to receive a reduced retirement
- 8 allowance on or after age sixty which allowance shall be the actuarial
- 9 equivalent of the sum necessary to pay regular retirement benefits
- 10 commencing at age sixty-five: PROVIDED, That if such member should
- 11 withdraw all or part of the member's accumulated contributions except
- 12 those additional contributions made pursuant to RCW 41.40.330(2), the
- 13 individual shall thereupon cease to be a member and this section shall
- 14 not apply.
- 15 <u>NEW SECTION.</u> **Sec. 2.** The department of retirement systems
- 16 shall incorporate the development of individual member accounts
- 17 receivable into its information systems projects for fiscal years 1993
- 18 and 1994, so that by January 1, 1994, members of state retirement
- 19 systems who are otherwise eligible to restore previously withdrawn
- 20 contributions have the option to make the restoration in annual
- 21 installments.
- 22 <u>NEW SECTION.</u> **Sec. 3.** Section 1 of this act shall take effect
- 23 January 1, 1994.
