- 1 AN ACT Relating to employee payroll deductions; amending RCW
- 2 41.04.230; and adding a new section to chapter 41.04 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 41.04.230 and 1988 c 107 s 19 are each amended to read
- 5 as follows:
- 6 Any official of the state authorized to disburse funds in payment
- 7 of salaries and wages of public officers or employees is authorized,
- 8 upon written request of the officer or employee, to deduct from the
- 9 salaries or wages of the officers or employees, the amount or amounts
- 10 of subscription payments, premiums, contributions, or continuation
- 11 thereof, for payment of the following:
- 12 (1) Credit union deductions: PROVIDED, ((That the credit union is
- 13 organized solely for public employees: AND PROVIDED FURTHER,)) That
- 14 twenty-five or more employees of a single state agency or a total of

- 1 one hundred or more state employees of several agencies have authorized
- 2 such a deduction for payment to the same credit union. An agency may,
- 3 in its own discretion, establish a minimum participation requirement of
- 4 fewer than twenty-five employees.
- 5 (2) Parking fee deductions: PROVIDED, That payment is made for
- 6 parking facilities furnished by the agency or by the department of
- 7 general administration.
- 8 (3) U.S. savings bond deductions: PROVIDED, That a person within
- 9 the particular agency shall be appointed to act as trustee. The
- 10 trustee will receive all contributions; purchase and deliver all bond
- 11 certificates; and keep such records and furnish such bond or security
- 12 as will render full accountability for all bond contributions.
- 13 (4) Board, lodging or uniform deductions when such board, lodging
- 14 and uniforms are furnished by the state, or deductions for academic
- 15 tuitions or fees or scholarship contributions payable to the employing
- 16 institution.
- 17 (5) Dues and other fees deductions: PROVIDED, That the deduction is
- 18 for payment of membership dues to any professional organization formed
- 19 primarily for public employees or college and university professors:
- 20 AND PROVIDED, FURTHER, That twenty-five or more employees of a single
- 21 state agency, or a total of one hundred or more state employees of
- 22 several agencies have authorized such a deduction for payment to the
- 23 same professional organization.
- 24 (6) Labor or employee organization dues may be deducted in the
- 25 event that a payroll deduction is not provided under a collective
- 26 bargaining agreement under the provisions of RCW 41.06.150: PROVIDED,
- 27 That twenty-five or more officers or employees of a single agency, or
- 28 a total of one hundred or more officers or employees of several
- 29 agencies have authorized such a deduction for payment to the same labor
- 30 or employee organization: PROVIDED, FURTHER, That labor or employee

- 1 organizations with five hundred or more members in state government may
- 2 have payroll deduction for employee benefit programs.
- 3 (7) Voluntary deductions for political committees duly registered
- 4 with the public disclosure commission and/or the federal election
- 5 commission: PROVIDED, That twenty-five or more officers or employees
- 6 of a single agency or a total of one hundred or more officers or
- 7 employees of several agencies have authorized such a deduction for
- 8 payment to the same political committee.
- 9 (8) Insurance contributions to the authority for payment of
- 10 premiums under contracts authorized by the state health care authority.
- 11 (9) Deductions to a bank, savings bank, or savings and loan
- 12 <u>association if (a) the bank, savings bank, or savings and loan</u>
- 13 association is authorized to do business in this state; and (b) twenty-
- 14 <u>five or more employees of a single agency, or fewer, if a lesser number</u>
- 15 is established by such agency, or a total of one hundred or more state
- 16 employees of several agencies have authorized a deduction for payment
- 17 to the same bank, savings bank, or savings and loan association.
- 18 Deductions from salaries and wages of public officers and employees
- 19 other than those enumerated in this section or by other law, may be
- 20 authorized by the director of financial management for purposes clearly
- 21 related to state employment or goals and objectives of the agency and
- 22 for plans authorized by the state health care authority.
- 23 The authority to make deductions from the salaries and wages of
- 24 public officers and employees as provided for in this section shall be
- 25 in addition to such other authority as may be provided by law:
- 26 PROVIDED, That the state or any department, division, or separate
- 27 agency of the state shall not be liable to any insurance carrier or
- 28 contractor for the failure to make or transmit any such deduction.

- 1 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 41.04 RCW
- 2 to read as follows:
- 3 Any official of any local political subdivision of the state,
- 4 municipal corporation, or quasi-municipal corporation authorized to
- 5 disburse funds in payment of salaries and wages of employees is
- 6 authorized upon written request of any employee, to deduct all or part
- 7 of such employee's salary or wages for payment to any bank, savings
- 8 bank, credit union, or savings and loan association if (1) the bank,
- 9 savings bank, credit union, or savings and loan association is
- 10 authorized to do business in this state; and (2) twenty-five or more
- 11 employees of a single local political subdivision, or fewer, if a
- 12 lesser number is established by such local political subdivision,
- 13 authorize such a deduction for payment to the same bank, savings bank,
- 14 credit union, or savings and loan association.
