- 1 AN ACT Relating to community and urban forestry; and adding a new
- 2 chapter to Title 76 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature hereby finds and declares
- 5 that:
- 6 (1) Trees and other woody vegetation are a necessary and important
- 7 part of community and urban environments. Community and urban forests
- 8 have many values and uses including conserving energy, reducing air and
- 9 water pollution and soil erosion, contributing to property values,
- 10 attracting business, reducing glare and noise, providing aesthetic and
- 11 historical values, providing wood products, and affording comfort and
- 12 protection for humans and wildlife.
- 13 (2) As urban and community areas in Washington state grow, the need
- 14 to plan for and protect community and urban forests increases. Cities

- 1 and communities benefit from assistance in developing and maintaining
- 2 community and urban forestry programs that also address future growth.
- 3 (3) Assistance and encouragement in establishment, retention, and
- 4 enhancement of these forests and trees by local governments, citizens,
- 5 organizations, and professionals are in the interest of the state based
- 6 on the contributions these forests make in preserving and enhancing the
- 7 quality of life of Washington's municipalities and counties while
- 8 providing opportunities for economic development.
- 9 NEW SECTION. Sec. 2. The purpose of this chapter is to:
- 10 (1) Encourage planting and maintenance and management of trees in
- 11 the state's municipalities and counties and maximize the potential of
- 12 tree and vegetative cover in improving the quality of the environment.
- 13 (2) Encourage the coordination of state and local agency activities
- 14 and maximize citizen participation in the development and
- 15 implementation of community and urban forestry-related programs.
- 16 (3) Foster healthy economic activity for the state's community and
- 17 urban forestry-related businesses through cooperative and supportive
- 18 contracts with the private business sector.
- 19 (4) Facilitate the creation of employment opportunities related to
- 20 community and urban forestry activities including opportunities for
- 21 inner city youth to learn teamwork, resource conservation,
- 22 environmental appreciation, and job skills.
- 23 (5) Provide meaningful voluntary opportunities for the state's
- 24 citizens and organizations interested in community and urban forestry
- 25 activities.
- 26 <u>NEW SECTION.</u> **Sec. 3.** Unless the context clearly requires
- 27 otherwise, the definitions in this section apply throughout this
- 28 chapter.

- 1 (1) "Department" means the department of natural resources.
- 2 (2) "Person" means an individual, partnership, private or public
- 3 municipal corporation, Indian tribe, state entity, county or local
- 4 governmental entity, or association of individuals of whatever nature.
- 5 (3) "Community and urban forest" is that land in and around human
- 6 settlements ranging from small communities to metropolitan areas,
- 7 occupied or potentially occupied by trees and associated vegetation.
- 8 Community and urban forest land may be planted or unplanted, used or
- 9 unused, and includes public and private lands, lands along
- 10 transportation and utility corridors, and forested watershed lands
- 11 within populated areas.
- 12 (4) "Community and urban forestry" means the planning,
- 13 establishment, protection, care, and management of trees and associated
- 14 plants individually, in small groups, or under forest conditions within
- 15 municipalities and counties.
- 16 (5) "Municipality" means a city, town, port district, public school
- 17 district, community college district, irrigation district, weed control
- 18 district, park district, or other political subdivision of the state.
- 19 <u>NEW SECTION.</u> **Sec. 4.** (1) The department may establish and
- 20 maintain a program in community and urban forestry to accomplish the
- 21 purpose stated in section 2 of this act. The department may assist
- 22 municipalities and counties in establishing and maintaining community
- 23 and urban forestry programs and encourage persons to engage in
- 24 appropriate and improved tree management and care.
- 25 (2) The department may advise, encourage, and assist
- 26 municipalities, counties, and other public and private entities in the
- 27 development and coordination of policies, programs, and activities for
- 28 the promotion of community and urban forestry.

- 1 (3) The department may appoint a committee or council to advise the
- 2 department in establishing and carrying out a program in community and
- 3 urban forestry.
- 4 (4) The department may assist municipal and county tree maintenance
- 5 programs by making surplus equipment available on loan where feasible
- 6 for community and urban forestry programs and cooperative projects.
- 7 <u>NEW SECTION.</u> **Sec. 5.** The department may:
- 8 (1) Receive and disburse any and all moneys contributed, allotted,
- 9 or paid by the United States under authority of any act of congress for
- 10 the purposes of this chapter.
- 11 (2) Receive such gifts, grants, bequests, and endowments and
- 12 donations of labor, material, seedlings, and equipment from public or
- 13 private sources as may be made for the purpose of carrying out the
- 14 provisions of this chapter, and may spend the gifts, grants, bequests,
- 15 endowments, and donations as well as other moneys from public or
- 16 private sources.
- 17 (3) Charge fees for attendance at workshops and conferences, and
- 18 for various publications and other materials that the department may
- 19 prepare.
- 20 (4) Enter into agreements and contracts with persons having
- 21 community and urban forestry-related responsibilities.
- 22 <u>NEW SECTION.</u> **Sec. 6.** The department shall assume the primary
- 23 responsibility of carrying out this chapter and shall cooperate with
- 24 other private and public, state and federal persons, any agency of
- 25 another state, the United States, any agency of the United States, or
- 26 any agency or province of Canada.

- 1 <u>NEW SECTION.</u> **Sec. 7.** Sections 1 through 6 of this act shall
- 2 constitute a new chapter in Title 76 RCW.
