- 1 AN ACT Relating to commercial salmon fishing licenses; and creating
- 2 new sections.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The fishing capacity of the non-treaty
- 5 salmon industry in the state of Washington may exceed that required to
- 6 harvest non-treaty salmon allocations. This overcapacity can
- 7 negatively impact the economic stability of the salmon fishing industry
- 8 and in some instances impedes orderly fisheries. The legislature finds
- 9 that it is in the best interest of the long term economic stability of
- 10 the salmon industry to determine the optimum number of commercial
- 11 salmon licenses that should be available.
- 12 <u>NEW SECTION.</u> **Sec. 2.** The director of the department of
- 13 fisheries shall, in close cooperation with the salmon fishing industry,
- 14 investigate the requirements for issuance, retention, and transfer of

- 1 commercial salmon licenses, shall determine the optimum number of such
- 2 licenses for each existing gear type and licensing area, and shall
- 3 determine the best means for attaining that optimum number. The
- 4 director shall, in making this determination, consider the impacts of
- 5 all non-treaty fisheries on weak stocks of salmon including those
- 6 originating in Hood Canal. The director shall also consider possible
- 7 environmental factors contributing to the declining fishery in Hood
- 8 Canal. The director shall specifically evaluate the following issues
- 9 in Hood Canal:
- 10 (1) Whether commercial salmon fisheries in Hood Canal should be
- 11 restricted to certain areas;
- 12 (2) Whether guidelines pertaining to depth of nets and distance
- 13 from the shoreline for vessels or skiffs are necessary; and
- 14 (3) Whether more effective methods of minimizing incidental catch
- 15 in Hood Canal of blackmouth during commercial net fisheries and of coho
- 16 salmon during the chum salmon fishery are needed.
- 17 Based on this evaluation, the director shall determine whether
- 18 fishing regulations for Hood Canal commercial salmon fisheries should
- 19 be modified, and how to minimize environmental damage to the bottom and
- 20 aquatic plant life of Hood Canal.
- 21 <u>NEW SECTION</u>. **Sec. 3**. The director of the department of
- 22 fisheries shall, in determining the number of licenses that should be
- 23 issued, consider the impact of commercial incidental catch of fish on
- 24 the recreational fishery. The director shall evaluate the need for a
- 25 study for observing and documenting incidental catch of fish in non-
- 26 treaty commercial fisheries. If a study is determined to be necessary,
- 27 the director shall develop a study plan for observing and documenting
- 28 incidental catch. The director shall initiate discussions with tribal
- 29 representatives concerning evaluation of the incidental catch in tribal

- 1 fisheries. The department shall present its findings and
- 2 recommendations under sections 2 and 3 of this act to the legislature
- 3 on or before December 1, 1991.
- 4 The director shall invite members of the house fisheries and
- 5 wildlife committee and the senate committee on environment and natural
- 6 resources to attend meetings in which these recommendations are being
- 7 developed.
