1            AN ACT Relating to establishing the telecommunications devices for  
2 the deaf task force; and creating new sections.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            NEW SECTION.    **Sec. 1.**            The legislature finds that:

5            (1) Operation of the state-wide telecommunications devices for the  
6 deaf (TDD) relay service has become an integral and important part of  
7 the state's telecommunications network;

8            (2) The Washington state TDD relay service (WSTRS) has, since it  
9 began twenty-four-hour operation in November 1989, provided pioneering  
10 service to the deaf, hearing-impaired, and speech-impaired citizens of  
11 this state by utilizing the best available technology;

12            (3) In its report to the legislature in December 1990, the  
13 department of social and health services identified a number of major  
14 issues and alternative approaches for the continued operation of the  
15 WSTRS, including blockage rate, limitations on demand for system usage,

1 funding, operational structure, toll call billing, regional systems  
2 with other states, and technological changes;

3 (4) The federal Americans with disabilities act (ADA), enacted in  
4 July 1990, requires that state-wide TDD relay services must be  
5 available in every state by July 1993, and must comply with the  
6 requirements of the federal legislation and with regulations to be  
7 adopted by the federal communications commission by July 1991; and

8 (5) It is in the best interests of the citizens of this state that  
9 the provision of state-wide TDD relay services in Washington be  
10 assessed in light of the new federal requirements, the ongoing problems  
11 and issues identified in the department of social and health services  
12 report, and potentially cost-effective technological improvements.

13 NEW SECTION. **Sec. 2.** (1) The telecommunications devices for  
14 the deaf (TDD) task force is created, consisting of the secretary of  
15 the department of social and health services and the director of the  
16 department of information services, or their designees, and the chair  
17 of the utilities and transportation commission, or his or her designee.  
18 The department of information services shall serve as the lead agency  
19 of the task force.

20 (2) The task force shall create a working group that includes  
21 representatives of a broad range of affected interests, including  
22 telecommunications companies engaged in both interstate and intrastate  
23 communications, the hearing-impaired communities and agencies, and the  
24 speech-impaired community and agencies. To the extent possible, the  
25 members of the working group should be persons that have been or are  
26 members of the TDD advisory committee established under RCW 43.20A.730.  
27 The working group shall provide information, advice, and technical  
28 assistance to the task force.

1 (3) The task force shall report to the energy and utilities  
2 committees of the house of representatives and the senate by December  
3 15, 1991, on its findings and recommendations. The report shall, at a  
4 minimum, address the following:

5 (a) The requirements of the Americans with disabilities act, and  
6 the regulations promulgated by the federal communications commission to  
7 implement the act, including federal requirements as to funding  
8 mechanisms, blockage rate, and confidentiality;

9 (b) The issues identified in the December 1990 report of the  
10 department of social and health services with regard to the operation  
11 of the Washington state TDD relay service, and particularly alternative  
12 operation and management structures, the utility of new cost-effective  
13 technology, regional cooperation with other states, competition and  
14 access to a variety of local carriers, utilization of the state's SCAN  
15 lines, and line blockage;

16 (c) The advantages and disadvantages of allowing carriers to  
17 determine how they should meet the requirements of the Americans with  
18 disabilities act, or whether the state should take the lead in devising  
19 or maintaining a state-wide TDD relay system that would meet those  
20 requirements; and

21 (d) Whether the task force should continue its work on issues that  
22 are complex, where there appears to be no consensus on any proposed  
23 direction or solution, or where the requirements of federal law have  
24 not been made clear.

25 The report shall contain recommendations or alternatives for  
26 legislative action.
