Read first time February 14, 1991. Referred to Committee on Governmental Operations.

1 AN ACT Relating to a day of commemoration for the national guard;
2 amending RCW 1.16.050; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** The legislature finds that the
5 Washington army and air national guard comprise almost nine thousand
6 dedicated men and women who serve the state and nation on a voluntary
7 basis. The legislature also finds that the state of Washington
8 benefits from that dedication by immediate access to well-prepared
9 resources in time of natural disasters and public emergency. The
10 national guard has consistently and frequently responded to state and
11 local emergencies with people and equipment to provide enforcement
12 assistance, medical services, and overall support to emergency
13 management services.

14 The legislature further declares that an annual day of
15 commemoration should be observed in honor of the achievements,

1 sacrifices, and dedication of the men and women of the Washington army
2 and air national guard.

3 **Sec. 2.** RCW 1.16.050 and 1989 c 128 s 1 are each amended to read
4 as follows:

5 The following are legal holidays: Sunday; the first day of
6 January, commonly called New Year's Day; the third Monday of January,
7 being celebrated as the anniversary of the birth of Martin Luther King,
8 Jr.; the third Monday of February to be known as Presidents' Day and to
9 be celebrated as the anniversary of the births of Abraham Lincoln and
10 George Washington; the last Monday of May, commonly known as Memorial
11 Day; the fourth day of July, being the anniversary of the Declaration
12 of Independence; the first Monday in September, to be known as Labor
13 Day; the eleventh day of November, to be known as Veterans' Day; the
14 fourth Thursday in November, to be known as Thanksgiving Day; the day
15 immediately following Thanksgiving Day; and the twenty-fifth day of
16 December, commonly called Christmas Day.

17 Employees of the state and its political subdivisions, except
18 employees of school districts and except those nonclassified employees
19 of institutions of higher education who hold appointments or are
20 employed under contracts to perform services for periods of less than
21 twelve consecutive months, shall be entitled to one paid holiday per
22 calendar year in addition to those specified in this section. Each
23 employee of the state or its political subdivisions may select the day
24 on which the employee desires to take the additional holiday provided
25 for herein after consultation with the employer pursuant to guidelines
26 to be promulgated by rule of the appropriate personnel authority, or in
27 the case of local government by ordinance or resolution of the
28 legislative authority.

1 If any of the above specified state legal holidays are also federal
2 legal holidays but observed on different dates, only the state legal
3 holidays shall be recognized as a paid legal holiday for employees of
4 the state and its political subdivisions except that for port districts
5 and the law enforcement and public transit employees of municipal
6 corporations, either the federal or the state legal holiday, but in no
7 case both, may be recognized as a paid legal holiday for employees.

8 Whenever any legal holiday, other than Sunday, falls upon a Sunday,
9 the following Monday shall be the legal holiday.

10 Whenever any legal holiday falls upon a Saturday, the preceding
11 Friday shall be the legal holiday.

12 Nothing in this section shall be construed to have the effect of
13 adding or deleting the number of paid holidays provided for in an
14 agreement between employees and employers of political subdivisions of
15 the state or as established by ordinance or resolution of the local
16 government legislative authority.

17 The legislature declares that the twelfth day of October shall be
18 recognized as Columbus Day but shall not be considered a legal holiday
19 for any purposes.

20 The legislature declares that the ninth day of April shall be
21 recognized as former prisoner of war recognition day but shall not be
22 considered a legal holiday for any purposes.

23 The legislature declares that the twenty-sixth day of January shall
24 be recognized as Washington army and air national guard day but shall
25 not be considered a legal holiday for any purposes.
