- 1 AN ACT Relating to the state commission on Hispanic affairs;
- 2 amending RCW 43.115.010, 43.115.030, 43.115.040, 43.131.341, and
- 3 43.131.342; adding a new section to chapter 43.115 RCW; and repealing
- 4 RCW 43.115.050.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 43.115.010 and 1987 c 249 s 1 are each amended to read 7 as follows:
- 8 The legislature declares that the public policy of this state is to
- 9 insure equal opportunity for all of its citizens. ((The legislature
- 10 finds that Hispanics have unique and special problems. It is the
- 11 purpose of this chapter to improve the well-being of Hispanics by
- 12 insuring their participation in the fields of government, business, and
- 13 education. The legislature further finds that it is necessary to aid
- 14 Hispanics in obtaining governmental services in order to promote the
- 15 health, safety and welfare of all the residents of this state.)) The
- 16 <u>legislature</u> believes that it is the duty of the state to improve the
- 17 well-being of Hispanics by enabling them to participate fully in all
- 18 <u>fields of endeavor and assisting them in obtaining governmental</u>
- 19 services. The legislature further finds that the development of public

- 1 policy and the delivery of governmental services to meet the special
- 2 needs of Hispanics can be improved by establishing a focal point in
- 3 state government for the interests of Hispanics. Therefore the
- 4 legislature deems it necessary to create a commission to carry out the
- 5 purposes of this chapter.
- 6 **Sec. 2.** RCW 43.115.030 and 1987 c 249 s 3 are each amended to read 7 as follows:
- 8 (1) The commission shall consist of eleven members of Hispanic 9 origin appointed by the governor. ((The membership shall include:
- 10 (a) Two members from workers in the agricultural field;
- 11 (b) Three members from the general populace of Hispanics, but not 12 of Mexican American origin;
- 13 (c) One member from the field of education;
- (d) One member who is a professional from the business community, government employment, or public service;
- 16 (e) One member from among elected trade union officials; and
- 17 (f) Three members from the Mexican American community in the state.
- 18 (2) Members shall serve for four-year terms and until their
- 19 successors are chosen and qualified.)) To the extent practicable,
- 20 appointments to the commission shall be made to achieve a balanced
- 21 representation based on the Hispanic population distribution within the
- 22 state, geographic considerations, sex, age, and occupation. Members
- 23 shall serve three-year terms. No member shall serve more than two full
- 24 <u>consecutive terms.</u> Vacancies shall be filled in the same manner as the
- 25 original appointments.
- (((3))) <u>(2)</u> Members shall receive reimbursement for travel expenses
- 27 incurred in the performance of their duties in accordance with RCW
- 28 43.03.050 and 43.03.060 as now existing or hereafter amended.
- 29 (((4))) Six members of the commission shall constitute a quorum
- 30 for the purpose of conducting business.
- 31 **Sec. 3.** RCW 43.115.040 and 1987 c 249 s 4 are each amended to read
- 32 as follows:
- 33 The commission shall <u>have the following powers and duties</u>:
- 34 (1) Elect one of its members to serve as chairman;
- 35 (2) ((Appoint a full time director;
- 36 (3) Appoint a staff who shall be state employees pursuant to Title
- 37 41 RCW; and

- (4)) Adopt rules and regulations pursuant to chapter 34.05 RCW:
- 2 (3) Examine and define issues pertaining to the rights and needs of
- 3 Hispanics, and make recommendations to the governor and state agencies
- 4 for changes in programs and laws;
- 5 (4) Advise the governor and state agencies on the development and
- 6 implementation of policies, plans, and programs that relate to the
- 7 special needs of Hispanics;
- 8 <u>(5) Advise the legislature on issues of concern to the Hispanic</u>
- 9 <u>community;</u>
- 10 (6) Establish relationships with state agencies, local governments,
- 11 and private sector organizations that promote equal opportunity and
- 12 benefits for Hispanics; and
- 13 (7) Receive gifts, grants, and endowments from public or private
- 14 sources that are made for the use or benefit of the commission and
- 15 expend, without appropriation, the same or any income from the gifts,
- 16 grants, or endowments according to their terms.
- NEW SECTION. Sec. 4. A new section is added to chapter 43.115 RCW
- 18 to read as follows:
- 19 (1) The commission shall be administered by an executive director,
- 20 who shall be appointed by and serve at the pleasure of the governor.
- 21 The governor shall base the appointment of the executive director on
- 22 recommendations of the commission. The salary of the executive
- 23 director shall be set by the governor.
- 24 (2) The executive director shall employ a staff, who shall be state
- 25 employees pursuant to Title 41 RCW. The executive director shall
