- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 66.32.040 and 1955 c 39 s 6 are each amended to read 6 as follows:
- 7 All liquor seized pursuant to the authority of ((the)) a search
- 8 warrant or an arrest shall, upon adjudication that it was kept in
- 9 violation of this title, be forfeited and upon forfeiture be
- 10 ((delivered to the board)) disposed of by the agency seizing the
- 11 <u>liquor</u>.
- 12 **Sec. 2.** RCW 66.32.090 and 1987 c 202 s 223 are each amended to
- 13 read as follows:
- In every case in which liquor is seized by a sheriff or deputy of
- 15 any county or by a police officer of any municipality or by a member of
- 16 the Washington state patrol, or any other authorized peace officer or
- 17 inspector, it shall be the duty of the sheriff or deputy of any county,
- 18 or chief of police of the municipality, or the chief of the Washington

- 1 state patrol, as the case may be, to forthwith report in writing to the
- 2 board of particulars of such seizure((, and to immediately deliver over
- 3 such liquor to the board, or its duly authorized representative, at
- 4 such place as may be designated by it)).
- 5 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 66.08 RCW 6 to read as follows:
- 7 The liquor control board may provide liquor at no charge, including
- 8 liquor forfeited under chapter 66.32 RCW, to recognized law enforcement
- 9 agencies within the state when the law enforcement agency will be using
- 10 the liquor for bona fide law enforcement training or investigation
- 11 purposes.
