1            AN ACT Relating to students transferring to other school districts;  
2 amending RCW 28A.225.225; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            **Sec. 1.** RCW 28A.225.225 and 1990 1st ex.s. c 9 s 203 are each  
5 amended to read as follows:

6            (1) All districts accepting applications from nonresident students  
7 for admission to the district's schools shall consider equally all  
8 applications received. Each school district shall adopt a policy  
9 establishing rational, fair, and equitable standards for acceptance and  
10 rejection of applications by June 30, 1990. The policy may include  
11 rejection of nonresident students if acceptance of these students would  
12 result in the district experiencing a financial hardship.

13            (2) The district shall provide to applicants written notification  
14 of the approval or denial of the application in a timely manner. If  
15 the application is rejected, the notification shall include the reason  
16 or reasons for denial and the right to appeal under RCW 28A.225.230(3).

17            NEW SECTION. **Sec. 2.** The education committees of the senate and  
18 house of representatives shall analyze issues associated with the

1 payment of transfer fees for students who transfer to nonresident  
2 school districts under RCW 28A.225.200. The committees shall report  
3 their findings, with recommendations, to the legislature prior to  
4 December 31, 1994.
