Majority Report: Do pass as amended. Signed by 15 members: Representatives Reams, Chairman; Goldsmith, Vice Chairman; L. Background: Any county legislative authority may impose a sales and use tax of .1 percent to be used exclusively for criminal justice purposes. This sales and use tax is in addition to other local option sales and use taxes and the ordinance imposing this tax is subject to potential referendum action by county voters.

Criminal justice purpose is defined as activities that substantially assist the criminal justice system, which may include circumstances where ancillary benefit to the civil justice system occurs, and which includes domestic violence services.

Receipts from this additional tax are distributed to the county, and the cities located in that county, as follows: (1) The county receives 10 percent of the receipts; and (2) the

remaining 90 percent is distributed between the county and cities in that county ratably based upon the population of the county and cities in the county, where the population the county is considered to be the population residing in the unincorporated area of the county and the population of the city is the population of a city residing in that county.

The interlocal cooperation act allows any unit of local government, including counties and cities, to enter into interlocal agreements to jointly exercise any power or authority that each party to the agreement is authorized to perform.

Summary of Bill: Cities and counties, or any combination thereof, are expressly authorized to participate in interlocal agreements to jointly expend funds obtained from the additional .1 percent sales and use tax for criminal justice purposes of mutual benefit, including, but not limited to, the construction, improvement, and expansion of jails, court facilities, and juvenile justice facilities.

It is clarified that counties and cities are responsible for the disposition of misdemeanor and gross misdemeanor offenders using their own courts or entering into contracts to provide these services.

Effective Date of Bill: Ninety days after adjournment of session in which bill is passed.
