**Title:** An act relating to county auditor recording fees.

**Brief Description:** Providing for a new auditor's fee to help fund low-income housing projects.

### SENATE COMMITTEE ON WAYS & MEANS

**Majority Report:** That Substitute Senate Bill No. 6373 as recommended by Committee on Financial Institutions & Housing be substituted therefor, and the substitute bill do pass.

**Background:** Currently, individuals who record legal instruments with the county auditor or recording officer are required to pay \$5 for the first page and \$1 for each additional page of the document. This money is collected and retained by the county to cover the costs of this activity.

**Summary of Substitute Bill:** Individuals who record legal instruments with a county auditor or recording officer are required to pay an additional \$5 for this service. Previously recorded mortgages are exempt from the additional low-income housing recording fee. These funds are retained and used by the county for low-income housing activities that are eligible for assistance under the state's housing trust fund program.

**Substitute Bill Compared to Original Bill:** Previously recorded mortgages are exempt from the additional low-income housing recording fee.

**Appropriation:** None.

**Fiscal Note:** Available.

**Effective Date:** Ninety days after adjournment of session in which bill is passed.

**Testimony For (Financial Institutions & Housing):** This bill will provide a funding source for counties to use in the development of low-income housing and will replace the local option real estate excise tax that prior to December of 1995 was used for this purpose.
