- 1 AN ACT Relating to acquisition of public art; amending RCW
- 2 43.17.200, 28B.10.025, 43.17.205, 43.17.210, and 43.19.455; and
- 3 repealing RCW 28A.335.210.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 43.17.200 and 1983 c 204 s 4 are each amended to read 6 as follows:
- 7 (1) Except as provided in subsection (2) of this section, all state
- 8 agencies including all state departments, boards, councils,
- 9 commissions, and quasi public corporations shall allocate, as a
- 10 nondeductible item, out of any moneys appropriated for the original
- 11 construction of any public building, an amount of one-half of one
- 12 percent of the appropriation to be expended by the Washington state
- 13 arts commission for the acquisition of works of art <u>created by</u>
- 14 Washington state artists. The works of art may be placed on public
- 15 lands, integral to or attached to a public building or structure,
- 16 detached within or outside a public building or structure, part of a
- 17 portable exhibition or collection, part of a temporary exhibition, or
- 18 loaned or exhibited in other public facilities. In addition to the
- 19 cost of the works of art the one-half of one percent of the

- 1 appropriation as provided herein shall be used to provide for the
- 2 administration of the visual arts program by the Washington state arts
- 3 commission and all costs for installation of the works of art. For the
- 4 purpose of this section building shall not include highway construction
- 5 sheds, warehouses, or other buildings of a temporary nature.
- 6 (2) Subsection (1) of this section shall not apply to the
- 7 construction of any facility under the control of the department of
- 8 corrections and used for the incarceration, treatment, or
- 9 rehabilitation of convicted persons, or any facility under the control

- 16 The Washington state arts commission shall, in consultation with
- 17 the boards of regents of the University of Washington and Washington
- 18 State University and with the boards of trustees of the regional
- 19 universities, The Evergreen State College, and the community college
- 20 districts, determine the amount to be made available for the purchases
- 21 of art under RCW 28B.10.027, and payment therefor shall be made in
- 22 accordance with law. The designation of projects and sites, the
- 23 selection, contracting, purchase, commissioning, reviewing of design,
- 24 execution and placement, acceptance, maintenance, and sale, exchange,
- 25 or disposition of works of art shall be the responsibility of the
- 26 Washington state arts commission in consultation with the board of
- 27 regents or trustees. However, the costs to carry out the Washington
