1 AN ACT Relating to abolishing the Washington state arts commission;
2 creating a new section; and repealing RCW 28A.335.210, 28B.10.025,
3 28B.10.027, 43.17.200, 43.17.205, 43.17.210, 43.19.455, 43.46.005,
4 43.46.015, 43.46.030, 43.46.040, 43.46.045, 43.46.050, 43.46.055,
5 43.46.060, 43.46.070, 43.46.090, 43.46.095, and 43.46.900.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** (1) The Washington state arts commission is
8 hereby abolished.

9 (2)(a) All reports, documents, surveys, books, records, files,
10 papers, or written material in the possession of the Washington state
11 arts commission shall be delivered to the custody of the Washington
12 state historical society. All cabinets, furniture, office equipment,
13 motor vehicles, and other tangible property employed by the Washington
14 state arts commission shall be made available to the Washington state
15 historical society. All funds, credits, or other assets held by the
16 Washington state arts commission shall be assigned to the Washington
17 state historical society.

1 (b) Any appropriations made to the Washington state arts commission
2 shall, on the effective date of this section, be transferred and
3 credited to the Washington state historical society.

4 (c) If any question arises as to the transfer of any funds, books,
5 documents, records, papers, files, equipment, or other tangible
6 property used or held in the exercise of the powers and the performance
7 of the duties and functions transferred, the director of financial
8 management shall make a determination as to the proper allocation and
9 certify the same to the state agencies concerned.

10 (3) The transfer of assets of the Washington state arts commission
11 shall not affect the validity of any act performed before the effective
12 date of this section.
