1            AN ACT Relating to transportation appropriations; creating new  
2 sections; making appropriations; providing an effective date; and  
3 declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            NEW SECTION.    **Sec. 1.** The transportation budget of the state is  
6 hereby adopted and, subject to the provisions hereinafter set forth,  
7 the several amounts hereinafter specified, or as much thereof as may be  
8 necessary to accomplish the purposes designated, are hereby  
9 appropriated from the several accounts and funds hereinafter named to  
10 the designated state agencies and offices for salaries, wages, and  
11 other expenses, for capital projects, and for other specified purposes,  
12 including the payment of any final judgments arising out of such  
13 activities, for the period ending June 30, 1997.

15 committee membership established in the feasibility study, the LAMP  
16 project director, the LAMP contractor's project manager, the LAMP  
17 quality assurance consultant, and a representative of the Washington  
18 state patrol shall be ex officio members of the LAMP steering  
19 committee.

20 (4) The licensing application migration project (LAMP) quality  
21 assurance consultant shall provide the LAMP steering committee with  
22 bimonthly reports on the status of the LAMP project. The bimonthly  
23 reports shall be on alternate months from the bimonthly reports  
24 provided by the department of information services. The reports  
25 required in this subsection shall also be delivered to the senate and  
26 house of representatives transportation committee chairs.

27 (5) All service fees charged to customers for kiosk transactions,  
28 excluding the county auditor share, shall be returned to the department  
29 of licensing for reimbursing expenses and expanding kiosk or other  
30 electronic forms of direct service delivery.

28 shall not exceed \$155,372,807 plus a dollar amount, as prescribed by  
29 the office of financial management, that is equal to:

30 (a) Funding the monthly contributions for insurance benefit  
31 premiums not to exceed \$320.82 per eligible employee for fiscal year  
32 1996, and \$347.90 for fiscal year 1997;

6 management's policies, regulation, and procedures named under objects  
7 of expenditure "A" and "B" (7.2.6.2).

8 (3) Of the \$155,372,807 provided for compensation, plus the  
9 prescribed insurance benefit, pension, and salary increase dollar  
10 amounts; the maximum dollar amount that shall be allocated from the  
11 governor s compensation salary appropriation is in addition to the  
12 appropriation contained in this section and may be used to maintain or  
13 increase compensation costs, effective July 1, 1995 and effective July  
14 1, 1996.

15 (4) In no event may the June 30, 1996 hourly salary rate increase  
16 exceed any average hourly rate increase granted during the 1995-96

30 conditions and limitations:

31 (1) The motor vehicle account--state appropriation includes  
32 \$3,275,000 in proceeds from the sale of bonds authorized in RCW

18 NEW SECTION. **Sec. 32.** The department of transportation is  
19 authorized to transfer any balances available in the highway  
20 construction stabilization account to the motor vehicle account to fund  
21 the appropriations contained in this act.

22 NEW SECTION. **Sec. 33.** The motor vehicle account revenues are  
23 received at a relatively even flow throughout the year. Expenditures  
24 may exceed the revenue during the accelerated summer and fall highway  
25 construction season, creating a negative cash balance during the heavy  
26 construction season. Negative cash balances also may result from the  
27 use of state funds to finance federal advance construction projects  
28 prior to conversion to federal funding. The governor and the  
29 legislature recognize that the department of transportation may require  
30 interfund loans or other short-term financing to meet temporary  
31 seasonal cash requirements and additional cash requirements to fund  
32 federal advance construction projects.

33 NEW SECTION. **Sec. 34.** In addition to such other appropriations as  
34 are made by this act, there is appropriated to the department of  
35 transportation from legally available bond proceeds in the respective

1 construction or building accounts such amounts as are necessary to pay  
2 the expenses incurred by the state finance committee in the issuance  
3 and sale of the subject bonds.

4 NEW SECTION. **Sec. 35.** The department of transportation is  
5 authorized to undertake federal advance construction projects under the  
6 provisions of 23 U.S.C. Sec. 115 in order to maintain progress in  
7 meeting approved highway construction and preservation objectives. The  
8 legislature recognizes that the use of state funds may be required to  
9 temporarily fund expenditures of the federal appropriations for the

12 NEW SECTION. **Sec. 36.** ACQUISITION OF PROPERTIES AND FACILITIES  
13 THROUGH FINANCIAL CONTRACTS. (1) The department of licensing may lease  
14 develop with option to purchase or lease purchase new customer service  
15 centers to be paid for from operating revenues. Alternatively, a  
16 financing contract may be entered into on behalf of the department of  
17 licensing in the amounts indicated plus financing expenses and reserves  
18 pursuant to chapter 39.94 RCW. The locations and amounts for projects  
19 covered under this section are as follows:

- 20 (a) A new customer service center in Vancouver for \$2,629,700;
- 21 (b) A new customer service center in North Spokane for \$3,083,600;
- 22 (c) A new customer service center in Thurston County for  
23 \$3,152,500;
- 24 (d) A new customer service center is Yakima for \$3,026,500; and
- 25 (e) A new customer service center in Walla Walla for \$2,575,800.

16 requirements of RCW 43.105.190, titled "Major information technology

20 provide the office of financial management, the legislative

15 periodic increments will occur on the following periodic increment  
16 dates. Affected Washington Management Service (WMS) employees may  
17 receive increments as provided in the pertinent WMS rules after July 1,  
18 1995. Civil service exempt employees who are below step K may receive  
19 an increase at the discretion of the relevant appointing authority.

20 NEW SECTION. **Sec. 41.** If any provision of this act or its  
21 application to any person or circumstance is held invalid, the  
22 remainder of the act or the application of the provision to other  
23 persons or circumstances is not affected.

24 NEW SECTION. **Sec. 42.** This act is necessary for the immediate  
25 preservation of the public peace, health, or safety, or support of the  
26 state government and its existing public institutions, and shall take  
27 effect July 1, 1995.
