1 AN ACT Relating to tuition for students in programs leading to the
2 degree of doctor of pharmacy; reenacting and amending RCW 28B.15.202;
3 making appropriations; providing an effective date; and declaring an
4 emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 28B.15.202 and 1993 sp.s. c 18 s 8 and 1993 c 379 s
7 202 are each reenacted and amended to read as follows:

8 Tuition fees and maximum services and activities fees at the
9 University of Washington and at Washington State University for other
10 than the summer term shall be as follows:

11 (1) For full-time resident undergraduate students and all other
12 full-time resident students not in graduate study programs or enrolled
13 in programs leading to the degrees of doctor of medicine, doctor of
14 dental surgery, doctor of pharmacy, and doctor of veterinary medicine,
15 the total tuition fees for the 1993-94 academic year shall be thirty-
16 six and three-tenths percent and thereafter total tuition fees shall be
17 forty-one and one-tenth percent of the per student undergraduate
18 educational costs at the state universities computed as provided in RCW
19 28B.15.067 and 28B.15.070: PROVIDED, That the building fees for each

1 academic year shall be one hundred and twenty dollars. Beginning with
2 the 1995-96 academic year the building fee for each academic year shall
3 be a percentage of total tuition fees. This percentage shall be
4 calculated by the higher education coordinating board and be based on
5 the actual percentage the building fee is of total tuition in the 1994-
6 95 academic year, rounded up to the nearest half percent.

7 (2) For full-time resident graduate and law students and students
8 enrolled in programs leading to the degree of doctor of pharmacy, not
9 enrolled in programs leading to the degrees of doctor of medicine,
10 doctor of dental surgery, and doctor of veterinary medicine, the total
11 tuition fees for the 1993-94 academic year shall be twenty-five and
12 two-tenths percent and thereafter total tuition fees shall be twenty-
13 eight and four-tenths percent of the per student graduate educational
14 costs at the state universities computed as provided in RCW 28B.15.067
15 and 28B.15.070: PROVIDED, That the building fees for each academic
16 year shall be one hundred and twenty dollars. Beginning with the 1995-
17 96 academic year the building fee for each academic year shall be a
18 percentage of total tuition fees. This percentage shall be calculated
19 by the higher education coordinating board and be based on the actual
20 percentage the building fee is of total tuition in the 1994-95 academic
21 year, rounded up to the nearest half percent.

22 (3) For full-time resident students enrolled in programs leading to
23 the degrees of doctor of medicine, doctor of dental surgery, and doctor
24 of veterinary medicine, the total tuition fees shall be one hundred
25 sixty-seven percent of such fees charged in subsection (2) of this
26 section: PROVIDED, That the building fees for each academic year shall
27 be three hundred and forty-two dollars. Beginning with the 1995-96
28 academic year the building fee for each academic year shall be a
29 percentage of total tuition fees. This percentage shall be calculated
30 by the higher education coordinating board and be based on the actual
31 percentage the building fee is of total tuition in the 1994-95 academic
32 year, rounded up to the nearest half percent.

33 (4) For full-time nonresident undergraduate students and such other
34 full-time nonresident students not in graduate study programs or
35 enrolled in programs leading to the degrees of doctor of medicine,
36 doctor of dental surgery, doctor of pharmacy, or doctor of veterinary
37 medicine, the total tuition fees for the 1993-94 academic year shall be
38 one hundred nine and three-tenths percent and thereafter total tuition
39 fees shall be one hundred twenty-two and nine-tenths percent of the per

1 student undergraduate educational costs at the state universities
2 computed as provided in RCW 28B.15.067 and 28B.15.070: PROVIDED, That
3 the building fees for each academic year shall be three hundred and
4 fifty-four dollars. Beginning with the 1995-96 academic year the
5 building fee for each academic year shall be a percentage of total
6 tuition fees. This percentage shall be calculated by the higher
7 education coordinating board and be based on the actual percentage the
8 building fee is of total tuition in the 1994-95 academic year, rounded
9 up to the nearest half percent.

10 (5) For full-time nonresident graduate and law students and
11 students enrolled in programs leading to the degree of doctor of
12 pharmacy, not enrolled in programs leading to the degrees of doctor of
13 medicine, doctor of dental surgery, and doctor of veterinary medicine,
14 the total tuition fees for the 1993-94 academic year shall be sixty-
15 five and six-tenths percent and thereafter total tuition fees shall be
16 seventy-three and six-tenths percent of the per student graduate
17 educational costs at the state universities computed as provided in RCW
18 28B.15.067 and 28B.15.070: PROVIDED, That the building fees for each
19 academic year shall be three hundred and fifty-four dollars. Beginning
20 with the 1995-96 academic year the building fee for each academic year
21 shall be a percentage of total tuition fees. This percentage shall be
22 calculated by the higher education coordinating board and be based on
23 the actual percentage the building fee is of total tuition in the 1994-
24 95 academic year, rounded up to the nearest half percent.

25 (6) For full-time nonresident students enrolled in programs leading
26 to the degrees of doctor of medicine, doctor of dental surgery, and
27 doctor of veterinary medicine, the total tuition fees shall be one
28 hundred sixty-seven percent of such fees charged in subsection (5) of
29 this section: PROVIDED, That the building fees for each academic year
30 shall be five hundred and fifty-five dollars. Beginning with the 1995-
31 96 academic year the building fee for each academic year shall be a
32 percentage of total tuition fees. This percentage shall be calculated
33 by the higher education coordinating board and be based on the actual
34 percentage the building fee is of total tuition in the 1994-95 academic
35 year, rounded up to the nearest half percent.

36 (7) The governing boards of the state universities shall charge to
37 and collect from each student, a services and activities fee. The
38 governing board may increase the existing fee annually, consistent with
39 budgeting procedures set forth in RCW 28B.15.045, by a percentage not

1 to exceed the annual percentage increase in resident undergraduate
2 tuition fees: PROVIDED, That such percentage increase shall not apply
3 to that portion of the services and activities fee previously committed
4 to the repayment of bonded debt. For the 1993-94 academic year,
5 services and activities fees shall not exceed two hundred forty-three
6 dollars per student. For the 1994-95 academic year, services and
7 activities fees shall not exceed two hundred forty-nine dollars per
8 student. The services and activities fee committee provided for in RCW
9 28B.15.045 may initiate a request to the governing board for a fee
10 increase.

11 NEW SECTION. **Sec. 2.** (1) In consideration of the doctor of
12 pharmacy 1995-1997 biennial program costs of one million seventy
13 thousand dollars at the University of Washington and six hundred eighty
14 thousand dollars at Washington State University, participating
15 students' operating fees are expected to contribute two hundred ninety-
16 one thousand dollars at the University of Washington and two hundred
17 eighty-four thousand dollars at Washington State University.

18 (2) The sum of seven hundred seventy-nine thousand dollars, or as
19 much thereof as may be necessary, is appropriated for the biennium
20 ending June 30, 1997, from the general fund to the University of
21 Washington for the purposes of this act.

22 (3) The sum of three hundred ninety-six thousand dollars, or as
23 much thereof as may be necessary, is appropriated for the biennium
24 ending June 30, 1997, from the general fund to Washington State
25 University for the purposes of this act.

26 NEW SECTION. **Sec. 3.** This act is necessary for the immediate
27 preservation of the public peace, health, or safety, or support of the
28 state government and its existing public institutions, and shall take
29 effect July 1, 1995.
