1 AN ACT Relating to sharing of juvenile records among schools and
2 other agencies; amending RCW 13.50.050, 13.50.100, and 28A.225.330;
3 reenacting and amending RCW 13.40.215; adding a new section to chapter
4 13.50 RCW; adding a new section to chapter 28A.320 RCW; and adding a
5 new section to chapter 28A.300 RCW.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 13.40.215 and 1994 c 129 s 6 and 1994 c 78 s 1 are
8 each reenacted and amended to read as follows:

9 (1)(a) Except as provided in subsection (2) of this section, at the
10 earliest possible date, and in no event later than thirty days before
11 discharge, parole, or any other authorized leave or release, or before
12 transfer to a community residential facility, the secretary or the
13 administrator appointed under RCW 13.04.035 shall send written notice
14 of the discharge, parole, authorized leave or release, or transfer of
15 a juvenile found to have committed a violent offense, a sex offense, or
16 stalking, to the following:

17 (i) The chief of police of the city, if any, in which the juvenile
18 will reside; ((and))

1 (ii) The sheriff of the county in which the juvenile will reside;
2 and

3 (iii) The common school district board of directors of the district
4 in which the juvenile intends to reside or the district in which the
5 juvenile last attended school, whichever is appropriate.

6 (b) The same notice as required by (a) of this subsection shall be
7 sent to the following, if such notice has been requested in writing
8 about a specific juvenile:

9 (i) The victim of the offense for which the juvenile was found to
10 have committed or the victim's next of kin if the crime was a homicide;

11 (ii) Any witnesses who testified against the juvenile in any court
12 proceedings involving the offense; and

13 (iii) Any person specified in writing by the prosecuting attorney.
14 Information regarding victims, next of kin, or witnesses requesting the
15 notice, information regarding any other person specified in writing by
16 the prosecuting attorney to receive the notice, and the notice are
17 confidential and shall not be available to the juvenile. The notice to
18 the chief of police or the sheriff shall include the identity of the
19 juvenile, the residence where the juvenile will reside, the identity of
20 the person, if any, responsible for supervising the juvenile, and the
21 time period of any authorized leave.

22 (c) The thirty-day notice requirements contained in this subsection
23 shall not apply to emergency medical furloughs.

24 (d) The existence of the notice requirements in this subsection
25 will not require any extension of the release date in the event the
26 release plan changes after notification.

27 (2)(a) If a juvenile found to have committed a violent offense, a
28 sex offense, or stalking escapes from a facility of the department, the
29 secretary shall immediately notify, by the most reasonable and
30 expedient means available, the chief of police of the city and the
31 sheriff of the county in which the juvenile resided immediately before
32 the juvenile's arrest. If previously requested, the secretary shall
33 also notify the witnesses and the victim of the offense which the
34 juvenile was found to have committed or the victim's next of kin if the
35 crime was a homicide. If the juvenile is recaptured, the secretary
36 shall send notice to the persons designated in this subsection as soon
37 as possible but in no event later than two working days after the
38 department learns of such recapture.

1 (b) The secretary may authorize a leave, for a juvenile found to
2 have committed a violent offense, a sex offense, or stalking, which
3 shall not exceed forty-eight hours plus travel time, to meet an
4 emergency situation such as a death or critical illness of a member of
5 the juvenile's family. The secretary may authorize a leave, which
6 shall not exceed the time medically necessary, to obtain medical care
7 not available in a juvenile facility maintained by the department.
8 Prior to the commencement of an emergency or medical leave, the
9 secretary shall give notice of the leave to the appropriate law
10 enforcement agency in the jurisdiction in which the juvenile will be
11 during the leave period. The notice shall include the identity of the
12 juvenile, the time period of the leave, the residence of the juvenile
13 during the leave, and the identity of the person responsible for
14 supervising the juvenile during the leave. If previously requested,
15 the department shall also notify the witnesses and victim of the
16 offense which the juvenile was found to have committed or the victim's
17 next of kin if the offense was a homicide.

18 In case of an emergency or medical leave the secretary may waive
19 all or any portion of the requirements for leaves pursuant to RCW
20 13.40.205 (2)(a), (3), (4), and (5).

21 (3) If the victim, the victim's next of kin, or any witness is
22 under the age of sixteen, the notice required by this section shall be
23 sent to the parents or legal guardian of the child.

24 (4) The secretary shall send the notices required by this chapter
25 to the last address provided to the department by the requesting party.
26 The requesting party shall furnish the department with a current
27 address.

28 (5) Upon discharge, parole, or other authorized leave or release,
29 a convicted juvenile sex offender shall not attend a public elementary,
30 middle, or high school that is attended by a victim of the sex
31 offender. The parents or legal guardians of the convicted juvenile sex
32 offender shall be responsible for transportation or other costs
33 associated with or required by the sex offender's change in school that
34 otherwise would be paid by a school district. Upon discharge, parole,
35 or other authorized leave or release of a convicted juvenile sex
36 offender, the secretary shall send written notice of the discharge,
37 parole, or other authorized leave or release and the requirements of
38 this subsection to the common school district board of directors of the

1 district in which the sex offender intends to reside or the district in
2 which the sex offender last attended school, whichever is appropriate.

3 (6) For purposes of this section the following terms have the
4 following meanings:

5 (a) "Violent offense" means a violent offense under RCW 9.94A.030;

6 (b) "Sex offense" means a sex offense under RCW 9.94A.030;

7 (c) "Stalking" means the crime of stalking as defined in RCW
8 9A.46.110;

9 (d) "Next of kin" means a person's spouse, parents, siblings, and
10 children.

11 **Sec. 2.** RCW 13.50.050 and 1992 c 188 s 7 are each amended to read
12 as follows:

13 (1) This section governs records relating to the commission of
14 juvenile offenses, including records relating to diversions.

15 (2) The official juvenile court file of any alleged or proven
16 juvenile offender shall be open to public inspection, unless sealed
17 pursuant to subsection (11) of this section.

18 (3) All records other than the official juvenile court file are
19 confidential and may be released only as provided in this section, RCW
20 13.50.010, 13.40.215, and 4.24.550.

21 (4) Except as otherwise provided in this section and RCW 13.50.010,
22 records retained or produced by any juvenile justice or care agency may
23 be released to other participants in the juvenile justice or care
24 system ((only)) when an investigation or case involving the juvenile in
25 question is being pursued by the other participant or when that other
26 participant is assigned the responsibility for supervising the
27 juvenile.

28 (5) Except as provided in RCW 4.24.550, information not in an
29 official juvenile court file concerning a juvenile or a juvenile's
30 family may be released to the public only when that information could
31 not reasonably be expected to identify the juvenile or the juvenile's
32 family.

33 (6) Notwithstanding any other provision of this chapter, the
34 release, to the juvenile or his or her attorney, of law enforcement and
35 prosecuting attorneys' records pertaining to investigation, diversion,
36 and prosecution of juvenile offenses shall be governed by the rules of
37 discovery and other rules of law applicable in adult criminal
38 investigations and prosecutions.

1 (7) The juvenile court and the prosecutor may set up and maintain
2 a central record-keeping system which may receive information on all
3 alleged juvenile offenders against whom a complaint has been filed
4 pursuant to RCW 13.40.070 whether or not their cases are currently
5 pending before the court. The central record-keeping system may be
6 computerized. If a complaint has been referred to a diversion unit,
7 the diversion unit shall promptly report to the juvenile court or the
8 prosecuting attorney when the juvenile has agreed to diversion. An
9 offense shall not be reported as criminal history in any central
10 record-keeping system without notification by the diversion unit of the
11 date on which the offender agreed to diversion.

12 (8) Upon request of the victim of a crime or the victim's immediate
13 family, the identity of an alleged or proven juvenile offender alleged
14 or found to have committed a crime against the victim and the identity
15 of the alleged or proven juvenile offender's parent, guardian, or
16 custodian and the circumstance of the alleged or proven crime shall be
17 released to the victim of the crime or the victim's immediate family.

18 (9) Subject to the rules of discovery applicable in adult criminal
19 prosecutions, the juvenile offense records of an adult criminal
20 defendant or witness in an adult criminal proceeding shall be released
21 upon request to prosecution and defense counsel after a charge has
22 actually been filed. The juvenile offense records of any adult
23 convicted of a crime and placed under the supervision of the adult
24 corrections system shall be released upon request to the adult
25 corrections system.

26 (10) In any case in which an information has been filed pursuant to
27 RCW 13.40.100 or a complaint has been filed with the prosecutor and
28 referred for diversion pursuant to RCW 13.40.070, the person the
29 subject of the information or complaint may file a motion with the
30 court to have the court vacate its order and findings, if any, and,
31 subject to subsection (24) of this section, order the sealing of the
32 official juvenile court file, the social file, and records of the court
33 and of any other agency in the case.

34 (11) The court shall grant the motion to seal records made pursuant
35 to subsection (10) of this section if it finds that:

36 (a) Two years have elapsed from the later of: (i) Final discharge
37 of the person from the supervision of any agency charged with
38 supervising juvenile offenders; or (ii) from the entry of a court order
39 relating to the commission of a juvenile offense or a criminal offense;

1 (b) No proceeding is pending against the moving party seeking the
2 conviction of a juvenile offense or a criminal offense; and

3 (c) No proceeding is pending seeking the formation of a diversion
4 agreement with that person.

5 (12) The person making a motion pursuant to subsection (10) of this
6 section shall give reasonable notice of the motion to the prosecution
7 and to any person or agency whose files are sought to be sealed.

8 (13) If the court grants the motion to seal made pursuant to
9 subsection (10) of this section, it shall, subject to subsection (24)
10 of this section, order sealed the official juvenile court file, the
11 social file, and other records relating to the case as are named in the
12 order. Thereafter, the proceedings in the case shall be treated as if
13 they never occurred, and the subject of the records may reply
14 accordingly to any inquiry about the events, records of which are
15 sealed. Any agency shall reply to any inquiry concerning confidential
16 or sealed records that records are confidential, and no information can
17 be given about the existence or nonexistence of records concerning an
18 individual.

19 (14) Inspection of the files and records included in the order to
20 seal may thereafter be permitted only by order of the court upon motion
21 made by the person who is the subject of the information or complaint,
22 except as otherwise provided in RCW 13.50.010(8) and subsection (24) of
23 this section.

24 (15) Any adjudication of a juvenile offense or a crime subsequent
25 to sealing has the effect of nullifying the sealing order. Any
26 conviction for any adult felony subsequent to the sealing has the
27 effect of nullifying the sealing order for the purposes of chapter
28 9.94A RCW for any juvenile adjudication of guilt for a class A offense
29 or a sex offense as defined in RCW 9.94A.030.

30 (16) In any case in which an information has been filed pursuant to
31 RCW 13.40.100 or a complaint has been filed with the prosecutor and
32 referred for diversion pursuant to RCW 13.40.070, the person who is the
33 subject of the information or complaint may file a motion with the
34 court to have the court vacate its order and findings, if any, and,
35 subject to subsection (24) of this section, order the destruction of
36 the official juvenile court file, the social file, and records of the
37 court and of any other agency in the case.

38 (17) The court may grant the motion to destroy records made
39 pursuant to subsection (16) of this section if it finds:

1 (a) The person making the motion is at least twenty-three years of
2 age;

3 (b) The person has not subsequently been convicted of a felony;

4 (c) No proceeding is pending against that person seeking the
5 conviction of a criminal offense; and

6 (d) The person has never been found guilty of a serious offense.

7 (18) A person eighteen years of age or older whose criminal history
8 consists of only one referral for diversion may request that the court
9 order the records in that case destroyed. The request shall be
10 granted, subject to subsection (24) of this section, if the court finds
11 that two years have elapsed since completion of the diversion
12 agreement.

13 (19) If the court grants the motion to destroy records made
14 pursuant to subsection (16) or (18) of this section, it shall, subject
15 to subsection (24) of this section, order the official juvenile court
16 file, the social file, and any other records named in the order to be
17 destroyed.

18 (20) The person making the motion pursuant to subsection (16) or
19 (18) of this section shall give reasonable notice of the motion to the
20 prosecuting attorney and to any agency whose records are sought to be
21 destroyed.

22 (21) Any juvenile to whom the provisions of this section may apply
23 shall be given written notice of his or her rights under this section
24 at the time of his or her disposition hearing or during the diversion
25 process.

26 (22) Nothing in this section may be construed to prevent a crime
27 victim or a member of the victim's family from divulging the identity
28 of the alleged or proven juvenile offender or his or her family when
29 necessary in a civil proceeding.

30 (23) Any juvenile justice or care agency may, subject to the
31 limitations in subsection (24) of this section and subparagraphs (a)
32 and (b) of this subsection, develop procedures for the routine
33 destruction of records relating to juvenile offenses and diversions.

34 (a) Records may be routinely destroyed only when the person the
35 subject of the information or complaint has attained twenty-three years
36 of age or older, or is eighteen years of age or older and his or her
37 criminal history consists entirely of one diversion agreement and two
38 years have passed since completion of the agreement.

1 (b) The court may not routinely destroy the official juvenile court
2 file or recordings or transcripts of any proceedings.

3 (24) No identifying information held by the Washington state patrol
4 in accordance with chapter 43.43 RCW is subject to destruction or
5 sealing under this section. For the purposes of this subsection,
6 identifying information includes photographs, fingerprints, palmprints,
7 soleprints, toeprints and any other data that identifies a person by
8 physical characteristics, name, birthdate or address, but does not
9 include information regarding criminal activity, arrest, charging,
10 diversion, conviction or other information about a person's treatment
11 by the criminal justice system or about the person's behavior.

12 (25) Information identifying child victims under age eighteen who
13 are victims of sexual assaults by juvenile offenders is confidential
14 and not subject to release to the press or public without the
15 permission of the child victim or the child's legal guardian.
16 Identifying information includes the child victim's name, addresses,
17 location, photographs, and in cases in which the child victim is a
18 relative of the alleged perpetrator, identification of the relationship
19 between the child and the alleged perpetrator. Information identifying
20 a child victim of sexual assault may be released to law enforcement,
21 prosecutors, judges, defense attorneys, or private or governmental
22 agencies that provide services to the child victim of sexual assault.

23 **Sec. 3.** RCW 13.50.100 and 1990 c 246 s 9 are each amended to read
24 as follows:

25 (1) This section governs records not covered by RCW 13.50.050.

26 (2) Records covered by this section shall be confidential and shall
27 be released only pursuant to this section and RCW 13.50.010.

28 (3) Records retained or produced by any juvenile justice or care
29 agency may be released to other participants in the juvenile justice or
30 care system ((only)) when an investigation or case involving the
31 juvenile in question is being pursued by the other participant or when
32 that other participant is assigned the responsibility of supervising
33 the juvenile. Records covered under this section and maintained by the
34 juvenile courts which relate to the official actions of the agency may
35 be entered in the state-wide juvenile court information system.

36 (4) A juvenile, his or her parents, the juvenile's attorney and the
37 juvenile's parent's attorney, shall, upon request, be given access to

1 all records and information collected or retained by a juvenile justice
2 or care agency which pertain to the juvenile except:

3 (a) If it is determined by the agency that release of this
4 information is likely to cause severe psychological or physical harm to
5 the juvenile or his or her parents the agency may withhold the
6 information subject to other order of the court: PROVIDED, That if the
7 court determines that limited release of the information is
8 appropriate, the court may specify terms and conditions for the release
9 of the information; or

10 (b) If the information or record has been obtained by a juvenile
11 justice or care agency in connection with the provision of counseling,
12 psychological, psychiatric, or medical services to the juvenile, and
13 the juvenile has a legal right to receive those services without the
14 consent of any person or agency, then the information or record may not
15 be disclosed to the juvenile's parents without the informed consent of
16 the juvenile; or

17 (c) That the department of social and health services may delete
18 the name and identifying information regarding persons or organizations
19 who have reported suspected child abuse or neglect.

20 (5) A juvenile or his or her parent denied access to any records
21 following an agency determination under subsection (4) of this section
22 may file a motion in juvenile court requesting access to the records.
23 The court shall grant the motion unless it finds access may not be
24 permitted according to the standards found in subsections (4) (a) and
25 (b) of this section.

26 (6) The person making a motion under subsection (5) of this section
27 shall give reasonable notice of the motion to all parties to the
28 original action and to any agency whose records will be affected by the
29 motion.

30 (7) Subject to the rules of discovery in civil cases, any party to
31 a proceeding seeking a declaration of dependency or a termination of
32 the parent-child relationship and any party's counsel and the guardian
33 ad litem of any party, shall have access to the records of any natural
34 or adoptive child of the parent, subject to the limitations in
35 subsection (4) of this section.

36 (8) Information concerning a juvenile or a juvenile's family
37 contained in records covered by this section may be released to the
38 public only when that information could not reasonably be expected to
39 identify the juvenile or the juvenile's family.

1 NEW SECTION. **Sec. 4.** A new section is added to chapter 13.50 RCW
2 to read as follows:

3 (1) Each juvenile justice or care agency shall implement a policy
4 that facilitates disclosure of information to the extent allowed by
5 federal and state law. The policy shall include, but not be limited to
6 the following:

7 (a) What information may be shared;

8 (b) The conditions for sharing the information;

9 (c) The method for providing the information;

10 (d) Which individuals, by position, at the juvenile justice or care
11 agency are permitted to receive the information;

12 (e) Which individuals, by position, at the juvenile justice or care
13 agency are responsible for providing reasonable safeguards to protect
14 the confidentiality of the information, including limiting disclosure
15 of the information to persons necessary to appropriately place,
16 supervise, and provide support services to the juvenile.

17 (2) Any juvenile justice or care agency, official, or employee who
18 discloses information in compliance with this section is immune from
19 civil liability for damages, unless it is shown that the agency,
20 official, or employee acted with gross negligence or in bad faith.

21 **Sec. 5.** RCW 28A.225.330 and 1994 c 304 s 2 are each amended to
22 read as follows:

23 (1) When enrolling a student who has attended school in another
24 school district, the school enrolling the student may request the
25 parent and the student to briefly indicate in writing whether or not
26 the student has:

27 (a) Any history of placement in special educational programs;

28 (b) Any past, current, or pending disciplinary action;

29 (c) Any history of violent behavior;

30 (d) Any unpaid fines or fees imposed by other schools; and

31 (e) Any health conditions affecting the student's educational
32 needs.

33 (2) The school enrolling the student shall request the school the
34 student previously attended to send the student's permanent record
35 including records of disciplinary action. If the student has not paid
36 a fine or fee under RCW 28A.635.060, the school may withhold the
37 student's official transcript, but shall transmit information about the
38 student's academic performance, special placement, and records of

1 disciplinary action. If the official transcript is not sent due to
2 unpaid fees or fines, the enrolling school shall notify both the
3 student and parent or guardian that the official transcript will not be
4 sent until the obligation is met, and failure to have an official
5 transcript may result in exclusion from extracurricular activities or
6 failure to graduate.

7 (3) If information is requested under subsection (2) of this
8 section, the information shall be transmitted within two school days
9 after receiving the request. Any school district employee who releases
10 the information in compliance with this section is immune from civil
11 liability for damages unless it is shown that the school district
12 employee acted with gross negligence or in bad faith.

13 NEW SECTION. Sec. 6. A new section is added to chapter 28A.320
14 RCW to read as follows:

15 (1) To be eligible to receive records under chapter 13.50 RCW, each
16 school district shall implement a policy that facilitates disclosure of
17 information to the extent allowed by federal and state law. The policy
18 shall include, but not be limited to the following:

19 (a) What information may be shared;

20 (b) The conditions for sharing the information;

21 (c) The method for providing the information;

22 (d) Which individuals, by position, within the school district may
23 receive the information;

24 (e) Which individuals, by position, within the school district are
25 responsible for providing reasonable safeguards to protect the
26 confidentiality of the information, including limiting disclosure of
27 the information to persons necessary to appropriately place, supervise,
28 and provide support services to the juvenile.

29 (2) Any school district or district employee who discloses
30 information in compliance with this section is immune from civil
31 liability for damages unless it is shown that the school district or
32 district employee acted with gross negligence or in bad faith.

33 NEW SECTION. Sec. 7. A new section is added to chapter 28A.300
34 RCW to read as follows:

35 By July 1, 1996, the superintendent of public instruction, the
36 department of social and health services, and the office of the
37 administrator for the courts shall jointly develop a handbook on the

1 current laws and policies governing the disclosure of information
2 related to juveniles among and within juvenile justice or care agencies
3 as defined by RCW 13.50.010. The handbook shall be updated annually.

4 The handbook shall be designed to assist agency personnel in
5 complying with applicable state and federal law when disclosing
6 information. The handbook shall address each of the following:

7 (1) What constitutes juvenile records;

8 (2) Which laws govern disclosure of juvenile records;

9 (3) Who maintains juvenile records;

10 (4) Who can obtain juvenile records; and

11 (5) How juvenile records can be obtained.

12 NEW SECTION. **Sec. 8.** If any provision of this act or its
13 application to any person or circumstance is held invalid, the
14 remainder of the act or the application of the provision to other
15 persons or circumstances is not affected.
