1 AN ACT Relating to registration of contractors; amending RCW
2 18.27.010, 18.27.020, 18.27.030, 18.27.040, 18.27.060, 18.27.090,
3 18.27.100, 18.27.104, 18.27.114, 18.27.117, 18.27.200, 18.27.230,
4 18.27.270, and 18.27.340; reenacting and amending RCW 51.12.020; adding
5 a new section to chapter 18.27 RCW; repealing RCW 18.27.140; and
6 prescribing penalties.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** A new section is added to chapter 18.27 RCW
9 to read as follows:

10 The purposes of this chapter are to protect the general welfare of
11 the residents of this state who purchase construction services and the
12 general economic welfare of contractors conducting business in
13 compliance with this chapter, to enhance state revenue collections, and
14 to promote compliance and enforcement of this chapter by providing
15 swift and meaningful remedies for those failing to register as required
16 by this chapter.

17 This chapter shall be strictly enforced to accomplish these
18 purposes. Therefore, the doctrine of substantial compliance shall not
19 be used in the application and construction of this chapter. Anyone

1 engaged in the activities of a contractor is presumed to know the
2 requirements of this chapter.

3 **Sec. 2.** RCW 18.27.010 and 1993 c 454 s 2 are each amended to read
4 as follows:

5 Unless the context clearly requires otherwise, the definitions in
6 this section apply throughout this chapter.

7 (1) "Contractor" means any person, firm or corporation who or
8 which, in the pursuit of an independent business undertakes to, or
9 offers to undertake, or submits a bid to, construct, alter, repair, add
10 to, subtract from, improve, move, wreck or demolish, for another, any
11 building, highway, road, railroad, excavation or other structure,
12 project, development, or improvement attached to real estate or to do
13 any part thereof including the installation of carpeting or other floor
14 covering, the erection of scaffolding or other structures or works in
15 connection therewith or who installs or repairs roofing or siding; or,
16 who, to do similar work upon his or her own property, employs members
17 of more than one trade upon a single job or project or under a single
18 building permit except as otherwise provided herein.

19 (2) "General contractor" means a contractor whose business
20 operations require the use of more than two unrelated building trades
21 or crafts whose work the contractor shall superintend or do in whole or
22 in part. "General contractor" shall not include an individual who does
23 all work personally without employees or other "specialty contractors"
24 as defined (~~herein~~) in this section. The terms "general contractor"
25 and "builder" are synonymous.

26 (3) "Specialty contractor" means a contractor whose operations (~~as~~
27 ~~such~~) do not fall within the foregoing definition of "general
28 contractor".

29 (4) "Unregistered contractor" means anyone doing work as a
30 contractor without being registered in compliance with state statutes.
31 "Unregistered contractor" includes contractors whose registration has
32 been suspended or is expired for more than thirty days beyond the
33 renewal date.

34 (5) "Department" means the department of labor and industries.

35 (~~(+5)~~) (6) "Director" means the director of the department of
36 labor and industries.

37 (~~(+6)~~) (7) "Verification" means the receipt and duplication by the
38 city, town, or county of a contractor registration card that is current

1 on its face, checking the department's contractor registration data
2 base, or calling the department to confirm that the contractor is
3 registered.

4 **Sec. 3.** RCW 18.27.020 and 1993 c 454 s 6 are each amended to read
5 as follows:

6 (1) Every contractor shall register with the department.

7 (2) It is a misdemeanor for any contractor to:

8 (a) Advertise, offer to do work, submit a bid, or perform any work
9 as a contractor without being registered as required by this chapter;

10 (b) Advertise, offer to do work, submit a bid, or perform any work
11 as a contractor when the contractor's registration is suspended;

12 (c) Use a false or expired registration number in purchasing or
13 offering to purchase an advertisement for which a contractor
14 registration number is required; ~~((or))~~

15 (d) Transfer a valid registration to an unregistered contractor or
16 allow an unregistered contractor to work under a registration issued to
17 another contractor; or

18 (e) Knowingly subcontract work to a person not registered as
19 required under this chapter. A contractor is not liable under this
20 section if a subcontractor becomes unregistered during the course of
21 its work without the knowledge of the contractor.

22 (3) All misdemeanor actions under this chapter shall be prosecuted
23 in the county where the ~~((infraction))~~ violation occurs.

24 (4) Each day beyond the date of citation that a person works
25 without being registered as required by this chapter, works while the
26 contractor's registration is suspended, or works under a registration
27 issued to another contractor is a separate violation. Each worksite at
28 which a person works without being registered as required by this
29 chapter, works while the contractor's registration is suspended, or
30 works under a registration issued to another contractor is a separate
31 violation.

32 (5) The director by rule shall establish a two-year audit and
33 monitoring program for a person not registered under this chapter who
34 becomes registered after receiving an infraction or conviction under
35 this chapter as a person not registered under this chapter. The
36 director shall notify the department of revenue and the employment
37 security department of such infractions or convictions and shall

1 cooperate with such departments in determining whether any taxes or
2 registration, license, or other fees or penalties are owed the state.

3 **Sec. 4.** RCW 18.27.030 and 1992 c 217 s 1 are each amended to read
4 as follows:

5 (1) An applicant for registration as a contractor shall submit an
6 application under oath upon a form to be prescribed by the director and
7 which shall include the following information pertaining to the
8 applicant:

9 (a) Employer social security number.

10 (b) As applicable: (i) The industrial insurance account number
11 covering employees domiciled in Washington; and (ii) evidence of
12 workers' compensation coverage in the applicant's state of domicile for
13 the applicant's employees working in Washington who are not domiciled
14 in Washington.

15 (c) Employment security department number.

16 (d) State excise tax registration number.

17 (e) Unified business identifier (UBI) account number may be
18 substituted for the information required by (b), (c), and (d) of this
19 subsection.

20 (f) Type of contracting activity, whether a general or a specialty
21 contractor and if the latter, the type of specialty.

22 (g) The name and address of each partner if the applicant be a firm
23 or partnership, or the name and address of the owner if the applicant
24 be an individual proprietorship, or the name and address of the
25 corporate officers and statutory agent, if any, if the applicant be a
26 corporation. The information contained in such application shall be a
27 matter of public record and open to public inspection.

28 (2) The department may verify the workers' compensation coverage
29 information provided by the applicant under subsection (1)(b) of this
30 section, including but not limited to information regarding the
31 coverage of an individual employee of the applicant. If coverage is
32 provided under the laws of another state, the department may notify the
33 other state that the applicant is employing employees in Washington.

34 (3) The department shall deny an application for registration
35 ((shall be denied)) if the applicant has been previously registered as
36 a sole proprietor, partnership, or corporation ((, and was a principal
37 or officer of the corporation,)) and ((if)) the applicant has an
38 unsatisfied final judgment in an action based on RCW 18.27.040 ((,))

1 that was incurred during a previous registration under this chapter.
2 The department shall check for unsatisfied judgments under RCW
3 18.27.040 and a history of violations and felonies when application is
4 made. A history of violations, revoked and suspended registrations or
5 licenses, or felonies relating to the construction business may be
6 grounds for denial.

7 **Sec. 5.** RCW 18.27.040 and 1988 c 139 s 1 are each amended to read
8 as follows:

9 (1) ~~Each applicant shall((, at the time of applying for or renewing~~
10 ~~a certificate of registration, file with the department a surety bond~~
11 ~~issued by a surety insurer who meets the requirements of chapter 48.28~~
12 ~~RCW in a form acceptable to the department running to the state of~~
13 ~~Washington if a general contractor, in the sum of six thousand dollars;~~
14 ~~if a specialty contractor, in the sum of four thousand dollars,))~~
15 accompany the application for a certificate of registration with a
16 surety bond or continuation certificate issued by a surety insurer who
17 meets the requirements of chapter 48.28 RCW in the sum of six thousand
18 dollars if the applicant is a general contractor and four thousand
19 dollars if the applicant is a specialty contractor. The bond shall
20 have the state of Washington named as obligee with good and sufficient
21 surety in a form to be approved by the department. The bond shall be
22 continuous and may be canceled by the surety upon the surety giving
23 written notice to the director of its intent to cancel the bond. A
24 cancellation or revocation of the bond or withdrawal of the surety from
25 the bond suspends the registration issued to the registrant until a new
26 bond or reinstatement notice has been filed and approved as provided in
27 this section. Whether or not the bond is renewed, continued,
28 reinstated, reissued, or otherwise extended, replaced, or modified,
29 including increases or decreases in the penal sum, it shall be
30 considered one continuous obligation, and the surety upon the bond
31 shall not be liable in an aggregate or cumulative amount exceeding the
32 penal sum set forth on the face of the bond. In no event shall the
33 penal sum, or a portion thereof, at two or more points in time be added
34 together in determining the surety's liability. The bond shall be
35 conditioned that the applicant will pay all persons performing labor,
36 including employee benefits, for the contractor, will pay all taxes and
37 contributions due to the state of Washington, and will pay all persons
38 furnishing labor or material or renting or supplying equipment to the

1 contractor and will pay all amounts that may be adjudged against the
2 contractor by reason of (~~negligent or improper work or~~) breach of
3 contract including negligent or improper work in the conduct of the
4 contracting business. A change in the name of a business or a change
5 in the type of business entity shall not impair a bond for the purposes
6 of this section so long as one of the original applicants for such bond
7 maintains partial ownership in the business covered by the bond.

8 (2) Any contractor registered as of (~~the effective date of this~~
9 ~~1983 act~~) July 1, 1995, who maintains such registration in accordance
10 with this chapter shall be in compliance with this chapter until the
11 next annual renewal of the contractor's certificate of registration.
12 At that time, the contractor shall provide a bond, cash deposit, or
13 other security deposit as required by this chapter and comply with all
14 of the other provisions of this chapter before the department shall
15 renew the contractor's certificate of registration.

16 (3) Any person, firm, or corporation having a claim against the
17 contractor for any of the items referred to in this section may bring
18 suit upon (~~such~~) the bond or deposit in the superior court of the
19 county in which the work was done or of any county in which
20 jurisdiction of the contractor may be had. The surety issuing the bond
21 shall be named as a party to any suit upon the bond. Action upon
22 (~~such~~) the bond or deposit shall be commenced by filing the summons
23 and complaint with the clerk of the appropriate superior court within
24 one year from the date of expiration of the certificate of registration
25 in force at the time the claimed labor was performed and benefits
26 accrued, taxes and contributions owing the state of Washington became
27 due, materials and equipment were furnished, or the claimed contract
28 work was completed or abandoned. Service of process in an action
29 against the contractor, the contractor's bond, or the deposit shall be
30 exclusively by service upon the department. Three copies of the
31 summons and complaint and a fee of ten dollars to cover the handling
32 costs shall be served by registered or certified mail upon the
33 department at the time suit is started and the department shall
34 maintain a record, available for public inspection, of all suits so
35 commenced. Service is not complete until the department receives the
36 ten-dollar fee and three copies of the summons and complaint. (~~Sueh~~)
37 The service shall constitute service on the registrant and the surety
38 for suit upon the bond or deposit and the department shall transmit the
39 summons and complaint or a copy thereof to the registrant at the

1 address listed in his or her application and to the surety within
2 forty-eight hours after it shall have been received.

3 (4) The surety upon the bond shall not be liable in an aggregate
4 amount in excess of the amount named in the bond nor for any monetary
5 penalty assessed pursuant to this chapter for an infraction. The
6 liability of the surety shall not cumulate where the bond has been
7 renewed, continued, reinstated, reissued or otherwise extended. The
8 surety upon the bond may, upon notice to the department and the
9 parties, tender to the clerk of the court having jurisdiction of the
10 action an amount equal to the claims thereunder or the amount of the
11 bond less the amount of judgments, if any, previously satisfied
12 therefrom and to the extent of such tender the surety upon the bond
13 shall be exonerated but if the actions commenced and pending at any one
14 time exceed the amount of the bond then unimpaired, claims shall be
15 satisfied from the bond in the following order:

16 (a) Employee labor, including employee benefits;

17 (b) Claims for breach of contract by a party to the construction
18 contract;

19 (c) Material and equipment;

20 (d) Taxes and contributions due the state of Washington;

21 (e) Any court costs, interest, and attorney's fees plaintiff may be
22 entitled to recover. The prevailing party in a bond claim action
23 against the contractor and the contractor's bond, required by this
24 section for breach of a construction contract, is entitled to costs,
25 interest, and reasonable attorneys' fees. In no event, however, may
26 the combined costs, interest, attorneys' fees, and bond loss exceed the
27 penal limit of the bond.

28 A payment made by the surety in good faith shall exonerate the bond
29 to extent of any payment made by the surety.

30 (5) In the event that any final judgment shall impair the liability
31 of the surety upon the bond so furnished that there shall not be in
32 effect a bond undertaking in the full amount prescribed in this
33 section, the department shall suspend the registration of ~~((such))~~ the
34 contractor until the bond liability in the required amount unimpaired
35 by unsatisfied judgment claims shall have been furnished. If ~~((such))~~
36 the bond becomes fully impaired, a new bond must be furnished at the
37 ~~((increased))~~ rates prescribed by this section ~~((as now or hereafter~~
38 ~~amended))~~.

1 (6) In lieu of the surety bond required by this section the
2 contractor may file with the department a deposit consisting of cash or
3 other security acceptable to the department.

4 (7) Any person having filed and served a summons and complaint as
5 required by this section having an unsatisfied final judgment against
6 the registrant for any items referred to in this section may execute
7 upon the security held by the department by serving a certified copy of
8 the unsatisfied final judgment by registered or certified mail upon the
9 department within one year of the date of entry of such judgment. Upon
10 the receipt of service of (~~such~~) the certified copy the department
11 shall pay or order paid from the deposit, through the registry of the
12 superior court which rendered judgment, towards the amount of the
13 unsatisfied judgment. The priority of payment by the department shall
14 be the order of receipt by the department, but the department shall
15 have no liability for payment in excess of the amount of the deposit.

16 (8) The director may (~~promulgate~~) adopt rules necessary for the
17 proper administration of the security.

18 **Sec. 6.** RCW 18.27.060 and 1983 1st ex.s. c 2 s 19 are each amended
19 to read as follows:

20 (1) A certificate of registration shall be valid for one year and
21 shall be renewed on or before the expiration date. The department
22 shall issue to the applicant a certificate of registration upon
23 compliance with the registration requirements of this chapter.

24 (2) If the department approves an application, it shall issue a
25 certificate of registration to the applicant. The certificate shall be
26 valid for:

27 (a) One year;

28 (b) Until the bond expires; or

29 (c) Until the insurance expires, whichever comes first. The
30 department shall place the expiration date on the certificate.

31 (3) A contractor may supply a short-term bond or insurance policy
32 to bring its registration period to the full one year.

33 (4) If a contractor's surety bond or other security has an
34 unsatisfied judgment against it or is canceled, or if the contractor's
35 insurance policy is canceled, the contractor's registration shall be
36 automatically suspended on the effective date of the impairment or
37 cancellation. The department shall give notice of the suspension to

1 the contractor by certified and by first class mail within forty-eight
2 hours after suspension.

3 (5) Renewal of registration shall be considered valid upon the date
4 the department receives the required fee and proof of bond and
5 liability insurance, if sent by certified mail or other means requiring
6 proof of delivery. The receipt or proof of delivery shall serve as the
7 contractor's proof of renewed registration until he or she receives
8 verification from the department.

9 **Sec. 7.** RCW 18.27.090 and 1987 c 313 s 1 are each amended to read
10 as follows:

11 This chapter (~~shall~~) does not apply to:

12 (1) An authorized representative of the United States government,
13 the state of Washington, or any incorporated city, town, county,
14 township, irrigation district, reclamation district, or other municipal
15 or political corporation or subdivision of this state;

16 (2) Officers of a court when they are acting within the scope of
17 their office;

18 (3) Public utilities operating under the regulations of the
19 utilities and transportation commission in construction, maintenance,
20 or development work incidental to their own business;

21 (4) Any construction, repair, or operation incidental to the
22 discovering or producing of petroleum or gas, or the drilling, testing,
23 abandoning, or other operation of any petroleum or gas well or any
24 surface or underground mine or mineral deposit when performed by an
25 owner or lessee;

26 (5) The sale or installation of any finished products, materials,
27 or articles of merchandise which are not actually fabricated into and
28 do not become a permanent fixed part of a structure;

29 (6) Any construction, alteration, improvement, or repair of
30 personal property, except this chapter shall apply to all
31 mobile/manufactured housing. A mobile/manufactured home may be
32 installed, set up, or repaired by the registered or legal owner, by a
33 contractor (~~licensed~~) registered under this chapter, or by a
34 mobile/manufactured home retail dealer or manufacturer licensed under
35 chapter 46.70 RCW who shall warranty service and repairs under chapter
36 46.70 RCW;

1 (7) Any construction, alteration, improvement, or repair carried on
2 within the limits and boundaries of any site or reservation under the
3 legal jurisdiction of the federal government;

4 (8) Any person who only furnished materials, supplies, or equipment
5 without fabricating them into, or consuming them in the performance of,
6 the work of the contractor;

7 (9) Any work or operation on one undertaking or project by one or
8 more contracts, the aggregate contract price of which for labor and
9 materials and all other items is less than five hundred dollars, such
10 work or operations being considered as of a casual, minor, or
11 inconsequential nature. The exemption prescribed in this subsection
12 does not apply in any instance wherein the work or construction is only
13 a part of a larger or major operation, whether undertaken by the same
14 or a different contractor, or in which a division of the operation is
15 made into contracts of amounts less than five hundred dollars for the
16 purpose of evasion of this chapter or otherwise. The exemption
17 prescribed in this subsection does not apply to a person who advertises
18 or puts out any sign or card or other device which might indicate to
19 the public that he or she is a contractor, or that he or she is
20 qualified to engage in the business of contractor;

21 (10) Any construction or operation incidental to the construction
22 and repair of irrigation and drainage ditches of regularly constituted
23 irrigation districts or reclamation districts; or to farming, dairying,
24 agriculture, viticulture, horticulture, or stock or poultry raising; or
25 to clearing or other work upon land in rural districts for fire
26 prevention purposes; except when any of the above work is performed by
27 a registered contractor;

28 (11) An owner who contracts for a project with a registered
29 contractor;

30 (12) Any person working on his or her own property, whether
31 occupied by him or her or not, and any person working on his or her
32 personal residence, whether owned by him or her or not (~~but~~).

33 (a) This exemption (~~shall~~) does not apply to any person otherwise
34 covered by this chapter who constructs an improvement on his (~~own~~) or
35 her property with the intention and (~~for the~~) sole purpose of selling
36 the improved property within one year of completion of work.

37 (b) This exemption does not apply to any person who constructs a
38 residence on his or her property for purposes or uses other than a

1 personal residence for a period of at least two years from receipt of
2 occupancy certificate.

3 (c) This exemption is limited to the construction of one residence
4 for personal use by any person in a one-year period, unless registered
5 as a contractor in compliance with this chapter.

6 (d) Sellers of residential property shall make a full disclosure to
7 a bona fide purchaser, lending bank or institution, and the title
8 company of any work, construction, or alteration of the property that
9 the seller performed, commenced, or completed within three years prior
10 to entering into the purchase and sales agreement, and that, except for
11 this exemption, would have been performed by a contractor registered as
12 required under this chapter.

13 (e) This exemption does not apply when used by a person operating
14 a business for the sole purpose of earning income or profiting through
15 sale or resale of personal residences by repeated or frequent use of
16 this exemption, nor shall it apply when used to avoid state taxation
17 and the contractor registration requirements of this chapter;

18 (13) Owners of commercial properties who use their own employees to
19 do maintenance, repair, and alteration work in or upon their own
20 properties;

21 (14) A licensed architect or civil or professional engineer acting
22 solely in his or her professional capacity, an electrician licensed
23 under the laws of the state of Washington, or a plumber licensed under
24 the laws of the state of Washington or licensed by a political
25 subdivision of the state of Washington while operating within the
26 boundaries of such political subdivision. The exemption provided in
27 this subsection is applicable only when the licensee is operating
28 within the scope of his or her license;

29 (15) Any person who engages in the activities herein regulated as
30 an employee of a registered contractor with wages as his or her sole
31 compensation or as an employee with wages as his or her sole
32 compensation;

33 (16) Contractors on highway projects who have been prequalified as
34 required by chapter 13 (~~of the~~), Laws of 1961, RCW 47.28.070, with
35 the department of transportation to perform highway construction,
36 reconstruction, or maintenance work.

37 **Sec. 8.** RCW 18.27.100 and 1993 c 454 s 3 are each amended to read
38 as follows:

1 (1) Except as provided in RCW 18.27.065 for partnerships and joint
2 ventures, no person who has registered under one name as provided in
3 this chapter shall engage in the business, or act in the capacity, of
4 a contractor under any other name unless such name also is registered
5 under this chapter.

6 (2) All advertising and all contracts, correspondence, cards,
7 signs, posters, papers, and documents which show a contractor's name or
8 address shall show the contractor's name or address as registered under
9 this chapter.

10 (3)(a) (~~The alphabetized listing of contractors appearing in the~~
11 ~~advertising section of telephone books or other directories and~~) All
12 advertising that shows the contractor's name or address shall show the
13 contractor's current registration number. The registration number may
14 be omitted in an alphabetized listing of registered contractors stating
15 only the name, address, and telephone number: PROVIDED, That signs on
16 motor vehicles subject to RCW 46.16.010 and on-premise signs shall not
17 constitute advertising as provided in this section. All materials used
18 to directly solicit business from retail customers who are not
19 businesses shall show the contractor's current registration number. A
20 contractor shall not use a false or expired registration number in
21 purchasing or offering to purchase an advertisement for which a
22 contractor registration number is required. A publisher of advertising
23 that shows contractor registration numbers shall print a customer alert
24 notice notifying customers that they should verify the validity of a
25 contractor registration number by calling the Washington department of
26 labor and industries' toll-free hot line. Advertising by airwave or
27 electronic transmission shall not be subject to this subsection if the
28 person selling the advertisement obtains the contractor's current
29 registration number from the contractor.

30 (b) (~~A person selling advertising should not accept advertisements~~
31 ~~for which the contractor registration number is required under (a) of~~
32 ~~this subsection if the contractor fails to provide the contractor~~
33 ~~registration number-)) The director or the director's designee may
34 issue a subpoena to any person or entity selling any advertising for
35 all information provided to the person or entity regarding the
36 purchaser of the advertising. The good-faith compliance by a seller of
37 advertising with a written request of the department for information
38 concerning the purchaser of advertising shall constitute a complete~~

1 defense to any civil or criminal action brought against the seller of
2 advertising arising from such compliance.

3 (4) No contractor shall advertise that he or she is bonded and
4 insured because of the bond required to be filed and sufficiency of
5 insurance as provided in this chapter.

6 (5) A contractor shall not falsify a registration number and use it
7 in connection with any solicitation or identification as a contractor.
8 All individual contractors and all partners, associates, agents,
9 salesmen, solicitors, officers, and employees of contractors shall use
10 their true names and addresses at all times while engaged in the
11 business or capacity of a contractor or activities related thereto.

12 (6) Any advertising by a person or business entity soliciting work
13 as a contractor when that person or business entity is not registered
14 pursuant to this chapter is a violation of this chapter.

15 (7)(a) The finding of a violation of this section by the director
16 at a hearing held in accordance with the Administrative Procedure Act,
17 chapter 34.05 RCW, shall subject the person committing the violation to
18 a penalty of not more than five thousand dollars as determined by the
19 director.

20 (b) Penalties under this section shall not apply to a violation
21 determined to be an inadvertent error.

22 **Sec. 9.** RCW 18.27.104 and 1989 c 175 s 61 are each amended to read
23 as follows:

24 (1) If, upon investigation, the director or the director's designee
25 has probable cause to believe that a person holding a registration, an
26 applicant for registration, or ~~((an unregistered))~~ a person acting in
27 the capacity of a contractor who is not otherwise exempted from this
28 chapter, has violated RCW 18.27.100 by unlawfully advertising for work
29 covered by this chapter ~~((in an alphabetical or classified directory)),~~
30 the department may issue a citation containing an order of correction.
31 Such order shall require the violator to cease the unlawful
32 advertising.

33 (2) If the person to whom a citation is issued under subsection (1)
34 of this section notifies the department in writing that he or she
35 contests the citation, the department shall afford an opportunity for
36 an adjudicative proceeding under chapter 34.05 RCW, the Administrative
