- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 79.08 RCW
- 7 to read as follows:
- 8 Except where deed restrictions or other restrictions preclude the
- 9 sale of publicly owned real property, including trust lands, state
- 10 agencies are encouraged to sell publicly owned real property that is
- 11 not in active use to individuals and private entities so that this
- 12 property will be placed on property tax rolls and put to productive
- 13 private uses.
- As used in this section, the term "state agencies" means every
- 15 state board, commission, department, institution of higher education,
- 16 or office.
- 17 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 35.21 RCW
- 18 to read as follows:

- 1 Except where precluded by deed restrictions or other restrictions,
- 2 cities and towns, including code cities, are encouraged to sell city or
- 3 town real property that is not in active use to individuals and private
- 4 entities so that this property will be placed on property tax rolls and
- 5 put to productive private uses.
- 6 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 36.34 RCW
- 7 to read as follows:
- 8 Except where precluded by deed restrictions or other restrictions,
- 9 counties are encouraged to sell county real property that is not in
- 10 active use to individuals and private entities so that this property
- 11 will be placed on property tax rolls and put to productive private
- 12 uses.
- NEW SECTION. Sec. 4. A new section is added to chapter 53.08 RCW
- 14 to read as follows:
- 15 Except where precluded by deed restrictions or other restrictions,
- 16 port districts are encouraged to sell port district real property that
- 17 is not in active use to individuals and private entities so that this
- 18 property will be placed on property tax rolls and put to productive
- 19 private uses.
