## HOUSE BILL 2225

1 AN ACT Relating to increasing the punishment for rape and indecent 2 liberties; reenacting and amending RCW 9.94A.320; creating a new 3 section; prescribing penalties; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 9.94A RCW 6 to read as follows:

(1) The legislature finds that:

8 (a) Rape and other sex offenses involving forcible compulsion are 9 among the most terrifying and demeaning criminal acts an individual can 10 perpetrate against another human being and the personal trauma and 11 anguish suffered by the victims of rape and indecent liberties and by 12 their families can create devastating difficulties which often take 13 years to overcome;

(b) The pain and complications caused by rape and indecent liberties are even more severe where deadly weapons are involved, where the victim is kidnapped or receives serious physical injuries, where the perpetrator has wrongfully entered the building or vehicle where the victim is situated, or where forcible compulsion is used; and

1 (c) The severity of punishment for those who commit rape or 2 indecent liberties should be commensurate with the crime the 3 perpetrators have forced upon their victims and strict penalties for 4 such cruel and humiliating violations of a person's dignity and honor 5 are both appropriate and just.

6 (2) The legislature hereby intends to ensure that the penalties 7 imposed for rape and indecent liberties are significant and that the 8 victims of rape and indecent liberties will be better able to lead 9 lives free of fear knowing that the perpetrators of such crimes against 10 them will be incarcerated for a substantial length of time.
