3 Any member of the Washington state bar association who has been certified by a lending agency and reported to the bar association for 4 5 nonpayment or default on a federally or state-guaranteed educational loan shall be immediately suspended from membership. Membership shall 6 7 not be reinstated until the person provides the Washington state bar 8 association a written release issued by the lending agency stating that 9 the person is making payments on the loan. If the person has continued 10 to meet all other requirements for membership during the suspension, 11 reinstatement shall be automatic upon receipt of the notice and payment of any reinstatement fee the association may impose. 12

The board shall immediately suspend the license or certificate of any person who has been certified by a lending agency and reported to the board for nonpayment or default on a federally or state-guaranteed educational loan. The person's license or certificate shall not be reissued until the person provides the board a written release issued by the lending agency stating that the person is making payments on the loan. If the person has continued to meet all other requirements for licensure or certification during the suspension, reinstatement shall be automatic upon receipt of the notice and payment of any reinstatement fee the board may impose.
