- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.08 RCW
- 7 to read as follows:
- 8 (1) The tax levied by RCW 82.08.020 shall not apply to sales to
- 9 local agencies of the labor portion of capital construction projects
- 10 for parks, trails, water access, and habitat areas, if:
- 11 (a) State funds are not used to purchase land for the park, trail,
- 12 water access, or habitat area;
- 13 (b) State funds are not used for any portion of the capital
- 14 construction project, or any related capital construction project at
- 15 the park, trail, water access, or habitat area; and
- 16 (c) The legislative body of the local agency, or the equivalent
- 17 governing body or director, certifies in a form determined by the
- 18 department of revenue that the local agency will not apply for,
- 19 request, or receive state funding for land acquisition, planning,

- 4 (2) For the purpose of this section "local agency" means a city,

- 8 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.12 RCW
- 9 to read as follows:
- 10 (1) The provisions of this chapter shall not apply in respect to
- 11 the use by local agencies of the labor portion of capital construction
- 12 projects for parks, trails, water access, and habitat areas, if:
- 13 (a) State funds are not used to purchase land for the park, trail,
- 14 water access, or habitat area;
- 15 (b) State funds are not used for any portion of the capital
- 16 construction project, or any related capital construction project at
- 17 the park, trail, water access, or habitat area; and
- 18 (c) The legislative body of the local agency, or the equivalent
- 19 governing body or director, certifies in a form determined by the
- 20 department of revenue that the local agency will not apply for,
- 21 request, or receive state funding for land acquisition, planning,
- 22 design, or construction activities for the park, trail, water access,
- 23 or habitat area in perpetuity, except in cases of emergency, following
- 24 the granting of a use tax exemption under this section.
- 25 (2) For the purpose of this section "local agency" means a city,
- 26 county, special purpose district, port district, or other political
- 27 subdivision of the state providing services to less than the entire
- 28 state.
- 29 <u>NEW SECTION.</u> **Sec. 3.** This act is necessary for the immediate
- 30 preservation of the public peace, health, or safety, or support of the
- 31 state government and its existing public institutions, and shall take
- 32 effect immediately.
