- 7 (1) A person is guilty of rape of a child in the fourth degree when
- 8 the person has sexual intercourse with another who is at least sixteen
- 9 years old but less than eighteen years old and not married to the
- 10 perpetrator and the perpetrator is at least sixty months older than the
- 11 victim.
- 12 (2) Rape of a child in the fourth degree is a class C felony.
- NEW SECTION. Sec. 2. A new section is added to chapter 9A.44 RCW
- 14 to read as follows:
- 15 (1) A person is guilty of child molestation in the fourth degree
- 16 when the person has, or knowingly causes another person under the age
- 17 of eighteen to have, sexual contact with another who is at least
- 18 sixteen years old but less than eighteen years old and not married to
