AN ACT Relating to attempting to elude a pursuing police vehicle; amending RCW 46.61.024; reenacting and amending RCW 9.94A.320; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 46.61.024 and 1983 c 80 s 1 are each amended to read 6 as follows:

7 ((Any)) (1) A driver of a motor vehicle who willfully fails or refuses to immediately bring his or her vehicle to a stop and who 8 drives his or her vehicle in a manner indicating a wanton or willful 9 10 disregard for the lives or property of others while attempting to elude a pursuing police vehicle, after being given a visual or audible signal 11 12 to bring the vehicle to a stop, $\left(\frac{shall be}{b}\right)$ is guilty of a class $\left(\left(\frac{e}{b}\right)\right)$ 13 B felony. The signal given by the police officer may be by hand, 14 voice, emergency light, or siren. The officer giving such a signal 15 shall be in uniform and his or her vehicle shall be appropriately marked showing it to be an official police vehicle. 16

17 (2) A person is guilty of murder in the second degree if a death 18 occurs while attempting to elude a police vehicle as set out under 19 subsection (1) of this section.

(3) A person is guilty of assault in the first degree if the 1 2 elements of that crime are met while attempting to elude a police 3 vehicle as set out under subsection (1) of this section. 4 (4) Neither a police officer nor a municipality may be held civilly liable for damage or injury that occurs as the result of a person 5 attempting to elude a police vehicle as set out under subsection (1) of б 7 this section. 8 The license or permit to drive or any nonresident driving privilege 9 of a person convicted of a violation of this section shall be revoked 10 by the department of licensing.
