1 AN ACT Relating to associations of local governments; adding a new 2 section to chapter 42.17 RCW; adding a new section to chapter 27.12 3 RCW; adding a new section to chapter 28A.320 RCW; adding a new section 4 to chapter 35.21 RCW; adding a new section to chapter 36.32 RCW; adding a new section to chapter 52.12 RCW; adding a new section to chapter 5 53.06 RCW; adding a new section to chapter 54.16 RCW; adding a new 6 section to chapter 56.08 RCW; adding a new section to chapter 57.08 7 RCW; and adding a new section to chapter 87.76 RCW. 8

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

10 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 42.17 RCW 11 to read as follows:

12 (1) A local government may not pay membership dues or provide 13 compensation to a private entity for local government association purposes if the total amount of dues or compensation paid to the 14 15 private entity by local governments, including interest earned on 16 investment of such dues or compensation, constitutes two-thirds or more 17 of the gross revenues of the private entity, unless, as a condition of 18 receipt of the dues or compensation, the private entity agrees to the following conditions: 19

1 (a) The private entity submits to a periodic audit by the state 2 auditor, as if the private entity were a local government;

3 (b) The records of the private entity are made available to the 4 public for inspection and copying under the provisions of this chapter, 5 as if the records were public records and the entity were a local 6 government;

7 (c) Meetings of the board of directors or any committee of the 8 board of directors are open to the public under the provisions of 9 chapter 42.30 RCW, as if the private entity were a public agency and 10 the board of directors were a governing body; and

(d) The funds of the private entity and its facilities may not be used for campaign purposes under the provisions of RCW 42.17.130, as if the private entity were a local government.

(2) Unless the context clearly requires otherwise, the definitionsin this subsection apply throughout this section.

16 (a) "Association purposes" means the coordination of administrative programs, preparation of annual reports, furnishing information to the 17 legislature and governor, acting as a coordinating agency, promoting 18 19 the efficient operations of local governments, submitting reports and 20 recommendations, and communicating with the legislature and state agencies on positions of, and requests by, members, whether the members 21 22 are units of local government or elected or appointed officials of 23 units of local government.

(b) "Local government" means a county, city, town, port district,
school district, irrigation district, fire protection district, public
utility district, or any other municipal or quasi-municipal
corporation.

30 Library districts are subject to the provisions of section 1 of 31 this act.

32 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 28A.320 33 RCW to read as follows:

34 School districts are subject to the provisions of section 1 of this 35 act.

<u>NEW SECTION.</u> sec. 4. A new section is added to chapter 35.21 RCW
to read as follows:

3 Cities and towns, including code cities, are subject to the 4 provisions of section 1 of this act.

5 <u>NEW SECTION.</u> Sec. 5. A new section is added to chapter 36.32 RCW 6 to read as follows:

7 Counties are subject to the provisions of section 1 of this act.

8 <u>NEW SECTION.</u> Sec. 6. A new section is added to chapter 52.12 RCW 9 to read as follows:

10 Fire protection districts are subject to the provisions of section 11 1 of this act.

12 <u>NEW SECTION.</u> Sec. 7. A new section is added to chapter 53.06 RCW 13 to read as follows:

14 Port districts are subject to the provisions of section 1 of this 15 act.

16 <u>NEW SECTION.</u> Sec. 8. A new section is added to chapter 54.16 RCW 17 to read as follows:

Public utility districts are subject to the provisions of section 19 1 of this act.

20 <u>NEW SECTION.</u> Sec. 9. A new section is added to chapter 56.08 RCW 21 to read as follows: 22 Sewer districts are subject to the provisions of section 1 of this 23 act.

24 <u>NEW SECTION.</u> **Sec. 10.** A new section is added to chapter 57.08 RCW 25 to read as follows:

Water districts are subject to the provisions of section 1 of this act.

28 <u>NEW SECTION.</u> **Sec. 11.** A new section is added to chapter 87.76 RCW 29 to read as follows:

1 Irrigation districts are subject to the provisions of section 1 of 2 this act.
