- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON: 8
- 9 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 42.17 RCW 10 to read as follows:
- (1) A local government may not pay membership dues or provide 11 12 compensation to a private entity for local government association 13 purposes if the total amount of dues or compensation paid to the 14 private entity by local governments constitutes seventy-five percent or 15 more of the gross revenues of the private entity, unless, as a condition of receipt of the dues or compensation, the private entity

- 17 agrees to the following conditions:
- (a) The private entity submits to a periodic audit by the state 18 19 auditor, as if the private entity were a local government;

- 1 (b) The records of the private entity are made available to the
- 2 public for inspection and copying under the provisions of this chapter,
- 3 as if the records were public records and the entity were a local
- 4 government;
- 5 (c) Meetings of the board of directors or any committee of the
- 6 board of directors are open to the public under the provisions of
- 7 chapter 42.30 RCW, as if the private entity were a public agency and
- 8 the board of directors were a governing body; and
- 9 (d) The funds of the private entity and its facilities may not be
- 10 used for campaign purposes under the provisions of RCW 42.17.130, as if
- 11 the private entity were a local government.
- 12 (2) Unless the context clearly requires otherwise, the definitions
- 13 in this subsection apply throughout this section.
- 14 (a) "Association purposes" means the coordination of administrative
- 15 programs, preparation of annual reports, furnishing information to the
- 16 legislature and governor, acting as a coordinating agency, promoting
- 17 the efficient operations of local governments, submitting reports and
- 18 recommendations, and communicating with the legislature and state
- 19 agencies on positions of, and requests by, members.
- 20 (b) "Local government" means a county, city, town, port district,
- 21 irrigation district, fire protection district, public utility district,
- 22 or any other municipal or quasi-municipal corporation.
