- 1 AN ACT Relating to attempting to elude a pursuing police vehicle;
- 2 amending RCW 46.20.285 and 46.61.024; reenacting and amending RCW
- 3 9.94A.320; and prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 46.20.285 and 1990 c 250 s 43 are each amended to read 6 as follows:
- 7 The department shall forthwith revoke the license of any driver for
- 8 the period of one calendar year unless otherwise provided in this
- 9 section, upon receiving a record of the driver's conviction of any of
- 10 the following offenses, when the conviction has become final:
- 11 (1) For vehicular homicide the period of revocation shall be two
- 12 years;
- 13 (2) Vehicular assault;
- 14 (3) Driving a motor vehicle while under the influence of
- 15 intoxicating liquor or a narcotic drug, or under the influence of any
- 16 other drug to a degree which renders the driver incapable of safely
- 17 driving a motor vehicle, upon a showing by the department's records
- 18 that the conviction is the second such conviction for the driver within
- 19 a period of five years. Upon a showing that the conviction is the

- third such conviction for the driver within a period of five years, the
 period of revocation shall be two years;
- 3 (4) For attempting to elude a pursuing police vehicle the period of 4 revocation shall be two years;
- 5 <u>(5)</u> Any <u>other</u> felony in the commission of which a motor vehicle is 6 used;
- 7 (((5))) <u>(6)</u> Failure to stop and give information or render aid as 8 required under the laws of this state in the event of a motor vehicle 9 accident resulting in the death or personal injury of another or 10 resulting in damage to a vehicle that is driven or attended by another;
- (((6))) <u>(7)</u> Perjury or the making of a false affidavit or statement under oath to the department under Title 46 RCW or under any other law relating to the ownership or operation of motor vehicles;
- $((\frac{7}{)})$ (8) Reckless driving upon a showing by the department's records that the conviction is the third such conviction for the driver within a period of two years.
- 17 **Sec. 2.** RCW 46.61.024 and 1983 c 80 s 1 are each amended to read 18 as follows:
- Any driver of a motor vehicle who willfully fails or refuses to 19 immediately bring his vehicle to a stop and who drives his vehicle in 20 a manner indicating a wanton or willful disregard for the lives or 21 22 property of others while attempting to elude a pursuing police vehicle, 23 after being given a visual or audible signal to bring the vehicle to a 24 stop, shall be guilty of a class ((e)) (B) felony. The signal given by 25 the police officer may be by hand, voice, emergency light, or siren. The officer giving such a signal shall be in uniform and his vehicle 26 27 shall be appropriately marked showing it to be an official police vehicle. 28
- The license or permit to drive or any nonresident driving privilege of a person convicted of a violation of this section shall be revoked by the department of licensing.
