20 159) are each amended to read as follows:

21 (1) A person is guilty of theft in the second degree if he or she
22 commits theft of:

23 (a) Property or services which exceed(s) two hundred and fifty
24 dollars in value other than a firearm as defined in RCW 9.41.010, but
25 does not exceed one thousand five hundred dollars in value; or

26 (b) A public record, writing, or instrument kept, filed, or
27 deposited according to law with or in the keeping of any public office
28 or public servant; or

29 (c) An access device(~~(+ or~~

30 ~~(d) A motor vehicle, of a value less than one thousand five hundred~~
31 ~~dollars)).~~

32 (2) Theft in the second degree is a class C felony.
