- 1 TO THE HONORABLE WILLIAM J. CLINTON, PRESIDENT OF THE UNITED
- 2 STATES, AND TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE
- 3 OF REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF
- 4 THE UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, More than ninety percent of the reactor-produced medical
- 9 isotopes currently used in the United States are imported; and
- 10 WHEREAS, The Hanford Fast Flux Test Facility is capable of
- 11 providing a wide variety of high quality medical isotopes for
- 12 diagnosing and treating cancer, and relieving pain caused by cancer,
- 13 and in 1986 produced the purest form ever made of gadolinium-153, an
- 14 isotope used to diagnose osteoporosis; and
- 15 WHEREAS, The Hanford Fast Flux Test Facility could also produce
- 16 isotopes for agricultural, industrial, and business applications; and
- 17 WHEREAS, Opportunities for research and clinical trials with
- 18 isotopes are severely limited; and
- 19 WHEREAS, A private business group has presented a formal offer to
- 20 the United States Department of Energy to operate the Hanford Fast Flux

- 1 Test Facility at a cost less than the cost to shut down the Facility;
- 2 and
- 3 WHEREAS, The Hanford Fast Flux Test Facility is an irreplaceable
- 4 national asset given the current regulatory climate and construction
- 5 costs;
- 6 NOW THEREFORE, Your Memorialists respectfully call on the President
- 7 of the United States and Congress to ensure the restart and continued
- 8 operation of the Hanford Fast Flux Test Facility, and preservation of
- 9 this valuable national asset.
- 10 BE IT RESOLVED, That copies of this Memorial be immediately
- 11 transmitted to the Honorable William J. Clinton, President of the
- 12 United States, the President of the United States Senate, the Speaker
- 13 of the House of Representatives, and each member of Congress from the
- 14 State of Washington.
