- (1) The attorney general shall report each fiscal year on actual legal services expenditures and actual attorney staffing levels for each agency receiving legal services. The report shall be submitted to the office of financial management and the fiscal committees of the senate and house of representatives no later than ninety days after the end of each fiscal year.
- 12 (2) The attorney general shall include, at a minimum, the following 13 information with each bill sent to agencies receiving legal services: (a) The number of hours and cost of attorney services provided during 14 15 the billing period; (b) cost of support staff services provided during 16 the billing period; (c) attorney general overhead and central support 17 costs charged to the agency for the billing period; (d) direct legal costs, such as filing and docket fees, charged to the agency for the 18 19 billing period; and (e) other costs charged to the agency for the billing period. The attorney general may, with approval of the office 20 21 of financial management change its billing system to meet the needs of 22 its user agencies.
- (3) \$4,000,000 from the state investment board expense account appropriation is provided solely for attorney general costs and related expenses in aggressively pursuing litigation related to real estate investments on behalf of the state investment board. - (1) \$6,065,000 of the general fund--state appropriation is provided solely for a contract with the Washington technology center. For work essential to the mission of the Washington technology center and conducted in partnership with universities, the center shall not pay any increased indirect rate nor increases in other indirect charges above the absolute amount paid during the 1993-95 biennium.

If at the end of 27 the first year any portion of the \$2,000,000 is unspent, the department shall combine the remaining balance with the amount provided under this 28 subsection to fund ongoing planning, integration, and implementation 29 30 issues.
- 31 (4) In order to offset reductions in federal community services 32 block grant funding for community action agencies, the department shall 33 set aside \$4,800,000 of federal community development block grant funds 34 for distribution to local governments to allocate to community action 35 agencies state-wide.
- 36 (5) \$8,915,000 of the general fund--federal appropriation is 37 provided solely for the drug control and system improvement formula 38 grant program, to be distributed in state fiscal year 1996 as follows:

- 1 (a) \$3,603,250 to local units of government to continue 2 multijurisdictional drug task forces;
- 3 (b) \$934,000 to the Washington state patrol for coordination, 4 technical assistance, and investigative and supervisory staff support 5 for multijurisdictional narcotics task forces;
- 6 (c) \$500,000 to the department of community, trade, and economic 7 development to continue the state-wide drug prosecution assistance 8 program;
- 9 (d) \$93,000 to the department of community, trade, and economic 10 development to continue a substance-abuse treatment in jails program, 11 to test the effect of treatment on future criminal behavior;

- (f) \$250,000 to the department of community, trade, and economic development for grants to support tribal law enforcement needs;

- (h) \$661,000 to the department of community, trade, and economic development for grant administration and program evaluation, monitoring, and reporting, pursuant to federal requirements;

The board shall consult with the human rights commission in the development of rules pertaining to affirmative action. If the tax imposed under RCW 82.23B.020(2) 25 is suspended during two consecutive biennia, the department shall by November 1st after the end of the second biennium, recommend to the 26 27 appropriate standing committees an adjustment in the tax rate. For the biennium ending June 30,  $((\frac{1995}{1997}))$  1997, the state treasurer may 28 29 transfer funds from the oil spill response account to the oil spill 30 administration account in amounts necessary to support appropriations made from the oil spill administration account in the omnibus 31 appropriations act adopted not later than June 30,  $((\frac{1994}{}))$  1995. 32

(2) Expenditures from the oil spill administration account shall be used exclusively for the administrative costs related to the purposes of this chapter, and chapters 90.48, 88.40, and 88.46 RCW. Starting with the 1995-1997 biennium, the legislature shall give activities of state agencies related to prevention of oil spills priority in funding
