1       AN ACT Relating to economic and employment impact of natural  
2 resources harvest variation in rural communities; amending RCW  
3 43.31.601, 43.31.611, 43.31.621, 43.31.641, 50.22.090, 43.31.651,  
4 43.63A.600, 43.63A.440, 43.160.076, 28B.50.030, 28B.50.258, 28B.50.262,  
5 28B.80.570, 28B.80.575, 28B.80.580, 28B.80.585, 43.17.065, 43.20A.750,  
6 43.21J.010, 43.168.020, 43.168.140, 43.210.110, 50.12.270, 50.70.010,  
7 and 50.70.020; amending 1993 c 316 s 5 (uncodified); amending 1993 c  
8 320 s 10 (uncodified); amending 1993 c 316 s 7 (uncodified); amending  
9 1993 c 320 s 11 (uncodified); reenacting and amending RCW 43.160.020  
10 and 43.160.200; adding a new section to chapter 43.63A RCW; adding new  
11 sections to chapter 43.131 RCW; creating a new section; repealing RCW  
12 43.31.661 and 43.31.631; providing an effective date; and declaring an  
13 emergency.

14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

15       **Sec. 1.** RCW 43.31.601 and 1992 c 21 s 2 are each amended to read  
16 as follows:

17       For the purposes of RCW 43.31.601 through 43.31.661:

18       (1) (~~"Board" means the economic recovery coordination board;~~  
19       ~~(2))~~) "Timber impact area" means((÷

1       ~~(a))~~ a county having a population of less than five hundred  
2 thousand, or a city or town located within a county having a population  
3 of less than five hundred thousand, and meeting two of the following  
4 three criteria, as determined by the employment security department,  
5 for the most recent year such data is available: ~~((+i))~~ (a) A lumber  
6 and wood products employment location quotient at or above the state  
7 average; ~~((+ii))~~ (b) projected or actual direct lumber and wood  
8 products job losses of one hundred positions or more, except counties  
9 having a population greater than two hundred thousand but less than  
10 five hundred thousand must have direct lumber and wood products job  
11 losses of one thousand positions or more; or ~~((+iii))~~ (c) an annual  
12 unemployment rate twenty percent or more above the state average~~((+or~~  
13 ~~(b) Additional communities as the economic recovery coordinating~~  
14 ~~board, established in RCW 43.31.631, designates based on a finding by~~  
15 ~~the board that each designated community is socially and economically~~  
16 ~~integrated with areas that meet the definition of a timber impact area~~  
17 ~~under (a) of this subsection)).~~

18       (2)(a) "Rural natural resources impact area" means:

19       (i) A nonmetropolitan county, as defined by the 1990 decennial  
20 census, that meets two of the five criteria set forth in (b) of this  
21 subsection; or

22       (ii) A nonurbanized area, as defined by the 1990 decennial census,  
23 that is located in a metropolitan county that meets two of the five  
24 criteria set forth in (b) of this subsection.

25       (b) For the purposes of designating rural natural resources impact  
26 areas, the following criteria shall be considered:

27       (i) A lumber and wood products employment location quotient at or  
28 above the state average;

29       (ii) A commercial salmon fishing employment location quotient at or  
30 above the state average;

31       (iii) Projected or actual direct lumber and wood products job  
32 losses of one hundred positions or more;

33       (iv) Projected or actual direct commercial salmon fishing job  
34 losses of one hundred positions or more; and

35       (v) An unemployment rate twenty percent or more above the state  
36 average.

37       The counties that meet these criteria shall be determined by the  
38 employment security department for the most recent year for which data  
39 is available. For the purposes of administration of programs under

1 this chapter, the United States post office five-digit zip code  
2 delivery areas will be used to determine residence status for  
3 eligibility purposes. For the purpose of this definition, a zip code  
4 delivery area that is located wholly or partially in an urbanized area  
5 or within two miles of an urbanized area is considered urbanized. The  
6 office of financial management shall make available a zip code listing  
7 of the areas to all agencies and organizations providing services under  
8 this chapter.

9       **Sec. 2.** RCW 43.31.611 and 1993 c 316 s 1 are each amended to read  
10 as follows:

11       (1) The governor shall appoint a ~~((timber-recovery))~~ rural  
12 community assistance coordinator. The coordinator shall coordinate the  
13 state and federal economic and social programs targeted to ~~((timber))~~  
14 rural natural resources impact areas.

15       (2) The coordinator's responsibilities shall include but not be  
16 limited to:

17       (a) ~~((Serving as executive secretary of the economic recovery~~  
18 ~~coordination board and directing staff associated with the board.~~

19       ~~((b))~~ Chairing the agency ~~((timber))~~ rural community assistance  
20 task force and directing staff associated with the task force.

21       ~~((c))~~ (b) Coordinating and maximizing the impact of state and  
22 federal assistance to ~~((timber))~~ rural natural resources impact areas.

23       ~~((d))~~ (c) Coordinating and expediting programs to assist  
24 ~~((timber))~~ rural natural resources impact areas.

25       ~~((e))~~ (d) Providing the legislature with a status and impact  
26 report on the ~~((timber-recovery))~~ rural community assistance program in  
27 January ~~((1992))~~ 1996.

28       (3) To assist in carrying out the duties set out under this  
29 section, the coordinator shall consult with the Washington state rural  
30 development council and may appoint an advisory body that has  
31 representation from local governments and natural resources interest  
32 groups representing impacted rural communities.

33       (4) This section shall expire June 30, ~~((1995))~~ 1997.

34       **Sec. 3.** RCW 43.31.621 and 1994 c 264 s 18 are each amended to read  
35 as follows:

36       (1) There is established the agency ~~((timber))~~ rural community  
37 assistance task force. The task force shall be chaired by the ~~((timber~~

1 ~~recovery~~) rural community assistance coordinator. It shall be the  
2 responsibility of the coordinator that all directives of chapter 314,  
3 Laws of 1991 are carried out expeditiously by the agencies represented  
4 in the task force. The task force shall consist of the directors, or  
5 representatives of the directors, of the following agencies: The  
6 department of community, trade, and economic development, employment  
7 security department, department of social and health services, state  
8 board for community and technical colleges, ~~((state))~~ work force  
9 training and education coordinating board, ~~((or its replacement~~  
10 ~~entity,))~~ department of natural resources, department of  
11 transportation, state energy office, department of fish and wildlife,  
12 University of Washington center for international trade in forest  
13 products, department of agriculture, and department of ecology. The  
14 task force shall solicit and consider input from the rural development

16 resources impacted communities. The task force may consult and enlist  
17 the assistance of the following: The higher education coordinating  
18 board, University of Washington college of forest resources, University  
19 of Washington school of fisheries, Washington State University school  
20 of forestry, Northwest policy center, state superintendent of public  
21 instruction, Washington state labor council, the Evergreen partnership,  
22 Washington state association of counties, and ~~((rural development~~  
23 ~~council))~~ others as needed.

24 (2) The task force, in conjunction with the rural development  
25 council, shall undertake a study to determine whether additional  
26 communities and industries are impacted, or are likely to be impacted,  
27 by salmon preservation and recovery efforts. The task force shall  
28 consider possible impacts in the following industries and associated  
29 communities: Barge transportation, irrigation dependent agriculture,  
30 food processing, aluminum, charter recreational fishing, boatbuilding,  
31 and other sectors suggested by the task force. The task force shall  
32 report its findings and recommendations to the legislature by January  
33 1996.

34 (3) This section shall expire June 30, ~~((1995))~~ 1997.

35 **Sec. 4.** RCW 43.31.641 and 1993 c 280 s 50 are each amended to read  
36 as follows:

1 The department of community, trade, and economic development, as a  
2 member of the agency (~~(timber)~~) rural community assistance task force  
3 (~~(and in consultation with the board)~~), shall:

4 (1) Implement an expanded value-added forest products development  
5 industrial extension program. The department shall provide technical  
6 assistance to small and medium-sized forest products companies to  
7 include:

8 (a) Secondary manufacturing product development;

9 (b) Plant and equipment maintenance;

10 (c) Identification and development of domestic market  
11 opportunities;

12 (d) Building products export development assistance;

13 (e) At-risk business development assistance;

14 (f) Business network development; and

15 (g) Timber impact area industrial diversification.

16 (2) Provide local contracts for small and medium-sized forest  
17 product companies, start-ups, and business organizations for business  
18 feasibility, market development, and business network contracts that  
19 will benefit value-added production efforts in the industry.

20 (3) Contract with local business organizations in timber impact  
21 areas for development of programs to promote industrial  
22 diversification. The department shall provide local capacity-building  
23 grants to local governments and community-based organizations in timber  
24 impact areas, which may include long-range planning and needs  
25 assessments.

26 For the 1991-93 biennium, the department of community, trade, and  
27 economic development shall use funds appropriated for this section for  
28 contracts and for no more than two additional staff positions.

29 **Sec. 5.** RCW 50.22.090 and 1993 c 316 s 10 are each amended to read  
30 as follows:

31 (1) An additional benefit period is established for (~~(counties~~  
32 ~~identified under subsection (2) of this section beginning on the first~~  
33 ~~Sunday after July 1, 1991, and for the forest products industry~~  
34 ~~beginning with the third week after the first Sunday after July 1,~~  
35 ~~1991)) rural natural resources impact areas, defined in RCW 43.31.601,  
36 and determined by the office of financial management and the employment  
37 security department. Benefits shall be paid as provided in subsection~~

1 (3) of this section to exhaustees eligible under subsection (4) of this

17 (3) Additional benefits shall be paid as follows:

18 (a) No new claims for additional benefits shall be accepted for  
19 weeks beginning after July 1, (~~(1995)~~) 1997, but for claims established  
20 on or before July 1, (~~(1995)~~) 1997, weeks of unemployment occurring  
21 after July 1, (~~(1995)~~) 1997, shall be compensated as provided in this  
22 section.

23 (b) The total additional benefit amount shall be one hundred four  
24 times the individual's weekly benefit amount, reduced by the total  
25 amount of regular benefits and extended benefits paid, or deemed paid,  
26 with respect to the benefit year. Additional benefits shall not be  
27 payable for weeks more than two years beyond the end of the benefit  
28 year of the regular claim for an individual whose benefit year ends on  
29 or after July 27, 1991, and shall not be payable for weeks ending on or  
30 after two years after March 26, 1992, for individuals who become  
31 eligible as a result of chapter 47, Laws of 1992.

32 (c) Notwithstanding the provisions of (b) of this subsection,  
33 individuals will be entitled to up to five additional weeks of benefits  
34 following the completion or termination of training.

35 (d) Notwithstanding the provisions of (b) of this subsection,  
36 individuals enrolled in prerequisite remedial education for a training  
37 program expected to last at least one year will be entitled to up to  
38 thirteen additional weeks of benefits which shall not count toward the  
39 total in (b) of this subsection.

1       (e) The weekly benefit amount shall be calculated as specified in  
2 RCW 50.22.040.

3       ~~((e))~~ (f) Benefits paid under this section shall be paid under  
4 the same terms and conditions as regular benefits and shall not be  
5 charged to the experience rating account of individual employers. The  
6 additional benefit period shall be suspended with the start of an  
7 extended benefit period, or any totally federally funded benefit  
8 program, with eligibility criteria and benefits comparable to the  
9 program established by this section, and shall resume the first week  
10 following the end of the federal program.

11       ~~((f))~~ (g) The amendments in chapter 316, Laws of 1993 affecting  
12 subsection (3) (b) and (c) of this section shall apply in the case of  
13 all individuals determined to be monetarily eligible under this section  
14 without regard to the date eligibility was determined.

15       (4) An additional benefit eligibility period is established for any  
16 exhaustee who:

17       (a)(i) At the time of last separation from employment, resided in  
18 or was employed in a ~~((county identified under subsection (2) of this  
19 section))~~ rural natural resources impact area defined in RCW 43.31.601  
20 and determined by the office of financial management and the employment  
21 security department; or

22       (ii) During his or her base year, earned wages in at least six  
23 hundred eighty hours in either the forest products industry, which  
24 shall be determined by the department but shall include the industries  
25 assigned the major group standard industrial classification codes "24"  
26 and "26" and the industries involved in the harvesting and management  
27 of logs, transportation of logs and wood products, processing of wood  
28 products, and the manufacturing and distribution of wood processing and  
29 logging equipment or the fishing industry assigned the standard  
30 industrial classification code "0912". The commissioner may adopt  
31 rules further interpreting the industries covered under this  
32 subsection. For the purposes of this subsection, "standard industrial  
33 classification code" means the code identified in RCW 50.29.025(6)(c);

35       (b)(i) Has received notice of termination or layoff; and

36       (ii) Is unlikely to return to employment in his or her principal  
37 occupation or previous industry because of a diminishing demand within  
38 his or her labor market for his or her skills in the occupation or  
39 industry; and

1 (c)(i)(~~(A)~~) Is notified by the department of the requirements of  
2 this section and develops an individual training program that is  
3 submitted to the commissioner for approval not later than sixty days  
4 after the individual is notified of the requirements of this section,  
5 and enters the approved training program not later than ninety days  
6 after the date of the individual's termination or layoff, or ninety  
7 days after July 1, 1991, whichever is later, unless the department  
8 determines that the training is not available during the ninety-day  
9 period, in which case the individual shall enter training as soon as it  
10 is available; or

11 (~~(B) Is unemployed as the result of a plant closure that occurs  
12 after November 1, 1992, in a county identified under subsection (2) of  
13 this section, did not comply with the requirements of (c)(i)(A) of this  
14 subsection due to good cause as demonstrated to the department, such as  
15 ambiguity over possible sale of the plant, develops a training program

27 (5) For the purposes of this section:

28 (a) "Training program" means:

29 (i) A remedial education program determined to be necessary after  
30 counseling at the educational institution in which the individual  
31 enrolls pursuant to his or her approved training program; or

32 (ii) A vocational training program at an educational institution  
33 that:

34 (A) Is training for a labor demand occupation; and

35 (B) Is likely to facilitate a substantial enhancement of the  
36 individual's marketable skills and earning power(~~(; and~~

37 ~~(C) Does not include on-the-job training or other training under  
38 which the individual is paid by an employer for work performed by the~~

1 individual during the time that the individual receives additional  
2 benefits under subsection (1) of this section)).

3 (b) "Educational institution" means an institution of higher  
4 education as defined in RCW 28B.10.016 or an educational institution as  
5 defined in RCW 28C.04.410(3).

6 (c) "Training allowance or stipend" means discretionary use, cash-  
7 in-hand payments available to the individual to be used as the  
8 individual sees fit, but does not mean direct or indirect compensation  
9 for training costs, such as tuition or books and supplies.

10 (6) The commissioner shall adopt rules as necessary to implement  
11 this section.

12 (7) ((For the purpose of this section, an individual who has a  
13 benefit year beginning after January 1, 1989, and ending before July  
14 27, 1991, shall be treated as if his or her benefit year ended on July  
15 27, 1991)) The provisions of RCW 50.22.010(10) shall not apply to  
16 anyone who establishes eligibility for additional benefits under this  
17 section and whose benefit year ends after the effective date of this  
18 act. These individuals will have the option of remaining on the  
19 original claim or filing a new claim.

21 (1) For the period beginning July 1, 1991, and ending June 30,

23 public works board may award low-interest or interest-free loans to  
24 local governments for construction of new or expanded public works  
25 facilities that stimulate economic growth or diversification.

28 (a) "Public facilities" means bridge, road and street, domestic  
29 water, sanitary sewer, and storm sewer systems.

15       **Sec. 9.** 1993 c 320 s 11 (uncodified) is amended to read as  
16 follows:

17       RCW 43.160.210 shall take effect (~~(July 1, 1995)~~) June 30, 1997.

18       **Sec. 10.** RCW 43.31.651 and 1993 c 280 s 51 are each amended to  
19 read as follows:

20       The department of community, trade, and economic development as a  
21 part of the agency (~~(timber)~~) rural community assistance task force  
22 (~~(and in consultation with the board,~~) shall implement a community  
23 assistance program to enable communities to build local capacity for  
24 sustainable economic development efforts. The program shall provide  
25 resources and technical assistance to (~~(timber)~~) rural natural  
26 resources impact areas.

27       NEW SECTION. **Sec. 11.** A new section is added to chapter 43.63A  
28 RCW to read as follows:

29       Unless the context clearly requires otherwise, the definitions in  
30 this section apply throughout this chapter.

31       (1) "Dislocated forest products worker" means a forest products  
32 worker who: (a)(i) Has been terminated or received notice of  
33 termination from employment and is unlikely to return to employment in  
34 the individual's principal occupation or previous industry because of

1 a diminishing demand for his or her skills in that occupation or  
2 industry; or (ii) is self-employed and has been displaced from his or  
3 her business because of the diminishing demand for the business's  
4 services or goods; and (b) at the time of last separation from  
5 employment, resided in or was employed in a rural natural resources  
6 impact area.

7 (2) "Forest products worker" means a worker in the forest products  
8 industries affected by the reduction of forest fiber enhancement,  
9 transportation, or production. The workers included within this  
10 definition shall be determined by the employment security department,  
11 but shall include workers employed in the industries assigned the major  
12 group standard industrial classification codes "24" and "26" and the  
13 industries involved in the harvesting and management of logs,  
14 transportation of logs and wood products, processing of wood products,  
15 and the manufacturing and distribution of wood processing and logging  
16 equipment. The commissioner may adopt rules further interpreting these  
17 definitions. For the purposes of this subsection, "standard industrial  
18 classification code" means the code identified in RCW 50.29.025(6)(c).

19 (3) "Dislocated salmon fishing worker" means a salmon products  
20 worker who: (a)(i) Has been terminated or received notice of  
21 termination from employment and is unlikely to return to employment in  
22 the individual's principal occupation or previous industry because of  
23 a diminishing demand for his or her skills in that occupation or  
24 industry; or (ii) is self-employed and has been displaced from his or  
25 her business because of the diminishing demand for the business's  
26 services or goods; and (b) at the time of last separation from  
27 employment, resided in or was employed in a rural natural resources  
28 impact area.

29 (4) "Salmon fishing worker" means a worker in the salmon industry  
30 affected by 1994 or future salmon disasters. The workers included  
31 within this definition shall be determined by the employment security  
32 department, but shall include workers employed in the industries  
33 involved in the commercial and recreational harvesting of salmon  
34 including buying and processing salmon. The commissioner may adopt  
35 rules further interpreting these definitions.

36 **Sec. 12.** RCW 43.63A.600 and 1994 c 114 s 1 are each amended to  
37 read as follows:

1 (1) The department of community, trade, and economic development,  
2 as a member of the agency ((timber)) rural community assistance task  
3 force (~~and in consultation with the economic recovery coordination~~  
4 ~~board,~~) shall establish and administer the emergency mortgage and  
5 rental assistance program. The department shall identify the  
6 communities most adversely affected by reductions in timber and salmon  
7 harvest levels and shall prioritize assistance under this program to  
8 these communities. The department shall work with the department of  
9 social and health services and the ((timber)) rural community  
10 assistance recovery coordinator to develop the program in ((timber))  
11 rural natural resources impact areas. Organizations eligible to  
12 receive grant funds for distribution under the program are those  
13 organizations that are eligible to receive assistance through the  
14 Washington housing trust fund. The department shall disburse the funds
