## SUBSTITUTE SENATE BILL 5905

## State of Washington 54th Legislature 1995 Regular Session

1 AN ACT Relating to persistent prison misbehavior; reenacting and 2 amending RCW 9.94A.320; adding a new section to chapter 9.94 RCW; and 3 prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 9.94 RCW 6 to read as follows:

7 (1) An inmate of a state correctional institution who is serving a
8 sentence for an offense committed on or after August 1, 1995, commits
9 the crime of persistent prison misbehavior if the inmate:

(a) Has been found in formal prison disciplinary hearings held
under RCW 72.09.130 to have committed one or more serious infractions;
(b) Has lost all of the potential earned early release time credits
for his or her sentence as a result of those serious infractions; and
(c) Knowingly commits another serious infraction after all
potential earned early release time credit has been lost.

16 (2) "Serious infraction" means misconduct that has been designated 17 as a serious infraction by department of corrections rules adopted 18 under RCW 72.09.130 and chapter 34.05 RCW. (3) "State correctional institution" has the same meaning as in RCW
 9.94.049.

3 (4) The crime of persistent prison misbehavior is a class C felony 4 punishable as provided in RCW 9A.20.021. The sentence imposed for this 5 crime must be served consecutive to any sentence being served at the 6 time the crime is committed.
