- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9.94 RCW 6 to read as follows:
- 7 Whenever an inmate of a state correctional facility sentenced for
- 8 an offense committed after August 1, 1995, commits persistent prison
- 9 misbehavior as demonstrated by multiple serious infractions of the
- 10 department of corrections rules adopted under RCW 72.09.130, the
- 11 persistent misbehavior is documented in writing by findings at a formal
- 12 disciplinary proceeding, and the inmate's sentence has not been reduced
- 13 by earned early release time under RCW 9.94A.150, the inmate is quilty
- 14 of a class C felony and, upon conviction, shall be punished by
- 15 imprisonment in a state correctional facility. The sentence imposed
- 16 under this section is in addition to any sentence being served.
