- 1 AN ACT Relating to the recruitment, preparation, and continuing
- 2 education of vocational agriculture teachers; adding a new section to
- 3 chapter 28A.415 RCW; creating a new section; and making an
- 4 appropriation.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. The legislature recognizes that the state of
- 7 Washington has a rich agricultural history and that agriculture
- 8 continues to be one of the most basic and important industries of the
- 9 state. The legislature finds that the growth of this vital industry
- 10 requires that students continue to receive vocational agriculture
- 11 instruction from trained and qualified vocational agriculture
- 12 instructors. The legislature further finds that the number of
- 13 qualified vocational agriculture educators is declining. The
- 14 legislature finds that a vocational agriculture teacher recruitment
- 15 program is necessary to protect the educational and career
- 16 opportunities for students with interests in vocational agriculture.
- 17 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.415
- 18 RCW to read as follows:

p. 1 SSB 6707

- (1) The Washington state vocational agriculture teacher recruitment 1 2 program is established. The program shall be designed by the state board of education, in consultation with the higher education 3 4 coordinating board, representatives of institutions of 5 education, education organizations having an interest in teacher recruitment issues, state-wide agricultural business organizations, 6 7 organizations having an interest in agriculture education, the 8 superintendent of public instruction, the state board for community and 9 technical colleges, and the department of agriculture. The program
- 9 technical colleges, and the department of agriculture. The program 10 shall be designed to recruit students who are in grades nine through 11 twelve and adults who have entered other occupations to be future 12 vocational agriculture teachers.
  - (2) The program shall include the following:
- (a) Encouraging students in grades nine through twelve to acquire the academic and related skills necessary to prepare for the study of vocational agriculture at an institution of higher education;
- (b) Promoting vocational agriculture teaching career opportunities to develop an awareness of the opportunities in the education profession;
- 20 (c) Providing opportunities for students to experience the 21 application of regular high school course work to activities related to 22 a teaching career in vocational agriculture;
- (d) Providing information on the transferability of skills learned in other occupations and professions to activities related to a teaching career in vocational agriculture;
- (e) Providing opportunities for underrepresented populations to participate in activities related to a teaching career in vocational agriculture; and
- (f) Providing for increased cooperation among institutions of higher education including community colleges, the superintendent of public instruction, the state board of education, and local school districts in working toward the goals of the program.
- NEW SECTION. Sec. 3. The sum of forty-nine thousand five hundred dollars, or as much thereof as may be necessary, is appropriated for the biennium ending June 30, 1997, from the general fund to the state board of education for the purposes of section 2 of this act.
