1 AN ACT Relating to inactive licenses for dentists; and adding a new
2 section to chapter 18.32 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 18.32 RCW
5 to read as follows:

6 The commission may adopt rules under this section authorizing an
7 inactive license status.

8 (1) An individual licensed under chapter 18.32 RCW may place his or
9 her license on inactive status. The holder of an inactive license must
10 not practice dentistry in this state without first activating the
11 license.

12 (2) The inactive renewal fee must be established by the secretary
13 under RCW 43.70.250. Failure to renew an inactive license shall result
14 in cancellation of the inactive license in the same manner as an active
15 license.

16 (3) An inactive license may be placed in an active status upon
17 compliance with rules established by the commission.

18 (4) Provisions relating to disciplinary action against a person
19 with a license are applicable to a person with an inactive license,

1 except that when disciplinary proceedings against a person with an
2 inactive license have been initiated, the license will remain inactive
3 until the proceedings have been completed.
