1 AN ACT Relating to the merger of special districts; and amending
2 RCW 85.08.850 and 36.93.800.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 85.08.850 and 1957 c 94 s 4 are each amended to read
5 as follows:

6 The petition requesting the merger shall be signed by the board of
7 supervisors of, or by ten owners of land located within, the drainage
8 improvement district, joint drainage improvement district, or
9 consolidated drainage improvement district and presented to the clerk
10 or clerks of the appropriate ((~~board or boards of county~~
11 ~~commissioners~~)) county legislative authority or authorities, at a
12 regular or special meeting ((~~of the board or boards~~)).

13 **Sec. 2.** RCW 36.93.800 and 1993 c 235 s 10 are each amended to read
14 as follows:

15 This chapter does not apply to the merger of irrigation districts
16 authorized under RCW 87.03.530(2) and 87.03.845 through 87.03.855 or to
17 the merger of a drainage improvement district, joint drainage
18 improvement district, or consolidated drainage improvement district

1 into an irrigation district authorized by RCW 87.03.720 through
2 87.03.745 and 85.08.830 through 85.08.890.
