3 Strike everything after the enacting clause and insert the following:

4 **Sec. 1.** RCW 66.08.026 and 1997 c 148 s 1 are each amended to read as follows:

5 All administrative expenses of the board incurred on and after April 1, 1963 shall be
6 appropriated and paid from the liquor revolving fund. These administrative expenses shall include,
7 but not be limited to: The salaries and expenses of the board and its employees, the cost of
8 establishing, leasing, maintaining, and operating state liquor stores and warehouses, legal services,
9 pilot projects, annual or other audits, and other general costs of conducting the business of the board.
10 The administrative expenses shall not, however, be deemed to include costs of liquor and lottery
11 tickets purchased, the cost of transportation and delivery to the point of distribution, other costs
12 pertaining to the acquisition and receipt of liquor and lottery tickets, packaging and repackaging of
13 liquor, (~~transaction fees associated with credit card purchases pursuant to RCW 66.16.040 and~~
14 ~~66.16.041,)~~ sales tax, and those amounts distributed pursuant to RCW 66.08.180, 66.08.190,
15 66.08.200, 66.08.210 and 66.08.220.

16 **Sec. 2.** RCW 66.16.040 and 1996 c 291 s 1 are each amended to read as follows:

17 Except as otherwise provided by law, an employee in a state liquor
18 store or agency may sell liquor to any person of legal age to purchase
19 alcoholic beverages and may also sell to holders of permits such liquor
20 as may be purchased under such permits.

21 Where there may be a question of a person's right to purchase
22 liquor by reason of age, such person shall be required to present any
23 one of the following officially issued cards of identification which
24 shows his/her correct age and bears his/her signature and photograph:

25 (1) Liquor control authority card of identification of any state
26 or province of Canada.

27 (2) Driver's license, instruction permit or identification card of
28 any state or province of Canada, or "identocard" issued by the
29 Washington state department of licensing pursuant to RCW 46.20.117.

30 (3) United States armed forces identification card issued to
31 active duty, reserve, and retired personnel and the personnel's
32 dependents.

1 (4) Passport.

2 (5) Merchant Marine identification card issued by the United
3 States Coast Guard.

4 The board may adopt such regulations as it deems proper covering
5 the acceptance of such cards of identification.

6 No liquor sold under this section shall be delivered until the
7 purchaser has paid for the liquor in cash(~~(, except as allowed under~~
8 ~~RCW 66.16.041. The use of a personal credit card does not rely upon~~
9 ~~the credit of the state as prohibited by Article VIII, section 5 of the~~
10 ~~state Constitution))~~).

11 **Sec. 3.** RCW 66.16.041 and 1997 c 148 s 2 & 1996 c 291 s 2 are each repealed.-

EFFECT: All provisions authorizing the use of personal credit cards for liquor purchases are stricken or repealed.
