5 On page 7, after line 12 of the amendment, insert the following:

6 "NEW SECTION. **Sec. 12.** A new section is added to chapter 39.29  
7 RCW to read as follows:

8 No member of the legislature may enter into a personal service  
9 contract as defined in this chapter.

10 **Sec. 13.** RCW 42.52.030 and 1996 c 213 s 3 are each amended to read  
11 as follows:

12 (1) No state officer or state employee, except as provided in  
13 subsections (2) and (3) of this section, may be beneficially  
14 interested, directly or indirectly, in a contract, sale, lease,  
15 purchase, or grant that may be made by, through, or is under the  
16 supervision of the officer or employee, in whole or in part, or accept,  
17 directly or indirectly, any compensation, gratuity, or reward from any  
18 other person beneficially interested in the contract, sale, lease,  
19 purchase, or grant.

20 (2) No officer or employee of an institution of higher education or  
21 of the Spokane intercollegiate research and technology institute,  
22 except as provided in subsection (3) of this section, may be  
23 beneficially interested, directly or indirectly, in a contract or grant  
24 that may be made by, through, or is under the supervision of the  
25 officer or employee, in whole or in part, or accept, directly or  
26 indirectly, any compensation, gratuity, or reward from any other person  
27 beneficially interested in the contract or grant, unless the  
28 institution of higher education or the Spokane intercollegiate research  
29 and technology institute has in effect a written administrative process  
30 to identify and manage, reduce, or eliminate conflicting interests with  
31 respect to such transactions as adopted pursuant to the national  
32 science investigator financial disclosure (GPM 510) 1995 and the public  
33 health service regulations, 42 C.F.R. Part 50 and 45 C.F.R. Subtitle A  
34 as each of those regulations existed on June 6, 1996, and the state  
35 employee or state officer has complied with such policy.

1 (3) No state officer or state employee may participate in a  
2 transaction involving the state in his or her official capacity with a  
3 person of which the officer or employee is an officer, agent, employee,  
4 or member, or in which the officer or employee owns a beneficial  
5 interest, except that an officer or employee of an institution of  
6 higher education or the Spokane intercollegiate research and technology  
7 institute may serve as an officer, agent, employee, or member, or on  
8 the board of directors, board of trustees, advisory board, or committee  
9 or review panel for any nonprofit institute, foundation, or fundraising  
10 entity; and may serve as a member of an advisory board, committee, or  
11 review panel for a governmental or other nonprofit entity.

12 (4) No member of the legislature may enter into a personal service  
13 contract as defined in RCW 39.29.006."

14 Renumber the remaining section consecutively.
