1 AN ACT Relating to special fuel tax; amending RCW 35A.82.010,  
2 82.04.4285, 82.38.020, 82.38.030, 82.38.070, 82.38.080, 82.38.090,  
3 82.38.100, 82.38.110, 82.38.120, 82.38.130, 82.38.150, 82.38.160,  
4 82.38.170, 82.38.180, 82.38.190, 82.38.210, 82.38.220, 82.38.230,  
5 82.38.235, 82.38.240, 82.38.260, 43.05.110, 82.47.010, and 82.80.010;  
6 reenacting and amending RCW 82.08.0255, 82.12.0256, and 82.38.140;  
7 adding new sections to chapter 82.38 RCW; creating new sections;  
8 repealing RCW 82.38.040, 82.38.082, and 82.38.086; prescribing  
9 penalties; and providing an effective date.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11 NEW SECTION. **Sec. 1.** The legislature finds and declares that:  
12 (1) The health, safety, and welfare of the people of the state of  
13 Washington are dependent on the state's ability to properly collect the  
14 taxes enacted by the legislature;  
15 (2) The current system for collecting special fuel taxes has  
16 allowed many parties to fraudulently evade paying the special fuel  
17 taxes due the state; and  
18 (3) By changing the point of collection of the special fuel taxes  
19 from distributors to suppliers, the department of licensing will have

1 fewer parties to collect tax from and enforcement will be enhanced,  
2 thus leading to greater revenues for the state.

3 **Sec. 2.** RCW 35A.82.010 and 1995 c 274 s 4 are each amended to read  
4 as follows:

5 A code city shall collect, receive and share in the distribution of  
6 state collected and distributed excise taxes to the same extent and  
7 manner as general laws relating thereto apply to any class of city or  
8 town including, but not limited to, funds distributed to cities under  
9 RCW 82.36.020 relating to motor vehicle fuel tax, RCW 82.38.290  
10 relating to use fuel tax, and RCW 82.36.275 and 82.38.080(~~(+9)~~) (3).

11 **Sec. 3.** RCW 82.04.4285 and 1980 c 37 s 6 are each amended to read  
12 as follows:

13 In computing tax there may be deducted from the measure of tax so  
14 much of the sale price of motor vehicle fuel as constitutes the amount  
15 of tax imposed by the state under chapters 82.36 and 82.38 RCW or the  
16 United States government, under 26 U.S.C., Subtitle D, chapters 31 and  
17 32, upon the sale thereof.

18 **Sec. 4.** RCW 82.08.0255 and 1983 1st ex.s. c 35 s 2 and 1983 c 108  
19 s 1 are each reenacted and amended to read as follows:

20 (1) The tax levied by RCW 82.08.020 shall not apply to sales of:

21 (a) Motor vehicle fuel used in aircraft by the manufacturer thereof  
22 for research, development, and testing purposes; and

23 (b) Motor vehicle and special fuel if:

24 (i) The fuel is purchased for the purpose of public transportation  
25 and the purchaser is entitled to a refund or an exemption under RCW  
26 82.36.275 or 82.38.080(~~(+9)~~) (3); or

27 (ii) The fuel is purchased by a private, nonprofit transportation  
28 provider certified under chapter 81.66 RCW and the purchaser is  
29 entitled to a refund or an exemption under RCW 82.36.285 or  
30 82.38.080(~~(+8)~~) (1)(h); or

31 (iii) The fuel is taxable under chapter 82.36 or 82.38 RCW.

32 (2) Any person who has paid the tax imposed by RCW 82.08.020 on the  
33 sale of special fuel delivered in this state shall be entitled to a  
34 credit or refund of such tax with respect to fuel subsequently  
35 established to have been actually transported and used outside this  
36 state by persons engaged in interstate commerce. The tax shall be

1 claimed as a credit or refunded through the tax reports required under  
2 RCW 82.38.150.

3 **Sec. 5.** RCW 82.12.0256 and 1983 1st ex.s. c 35 s 3 and 1983 c 108  
4 s 2 are each reenacted and amended to read as follows:

5 The provisions of this chapter shall not apply in respect to the  
6 use of:

7 (1) Motor vehicle fuel used in aircraft by the manufacturer thereof  
8 for research, development, and testing purposes; and

9 (2) Special fuel purchased in this state upon which a refund is  
10 obtained as provided in RCW 82.38.180(2); and

11 (3) Motor vehicle and special fuel if:

12 (a) The fuel is used for the purpose of public transportation and  
13 the purchaser is entitled to a refund or an exemption under RCW  
14 82.36.275 or 82.38.080(~~(+9)~~) (3); or

15 (b) The fuel is purchased by a private, nonprofit transportation  
16 provider certified under chapter 81.66 RCW and the purchaser is  
17 entitled to a refund or an exemption under RCW 82.36.285 or  
18 82.38.080(~~(+8)~~) (1)(h); or

19 (c) The fuel is taxable under chapter 82.36 or 82.38 RCW:  
20 PROVIDED, That the use of motor vehicle and special fuel upon which a  
21 refund of the applicable fuel tax is obtained shall not be exempt under  
22 this subsection (3)(c), and the director of licensing shall deduct from  
23 the amount of such tax to be refunded the amount of tax due under this  
24 chapter and remit the same each month to the department of revenue.

25 **Sec. 6.** RCW 82.38.020 and 1995 c 287 s 3 are each amended to read  
26 as follows:

27 (~~As used in this chapter:~~

28 ~~(1) "Person" means every natural person, fiduciary, association, or~~  
29 ~~corporation. The term "person" as applied to an association means and~~  
30 ~~includes the partners or members thereof, and as applied to~~  
31 ~~corporations, the officers thereof.~~

32 ~~(2) "Department" means the department of licensing.~~

33 ~~(3) "Highway" means every way or place open to the use of the~~  
34 ~~public, as a matter of right, for the purpose of vehicular travel.~~

35 ~~(4) "Motor vehicle" means every self-propelled vehicle designed for~~  
36 ~~operation upon land utilizing special fuel as the means of propulsion.~~

1       ~~(5) "Special fuel" means and includes all combustible gases and~~  
2 ~~liquids suitable for the generation of power for propulsion of motor~~  
3 ~~vehicles, except that it does not include motor vehicle fuel as defined~~  
4 ~~in chapter 82.36 RCW.~~

5       ~~(6) "Bulk storage" means the placing of special fuel by a special~~  
6 ~~fuel dealer into a receptacle other than the fuel supply tank of a~~  
7 ~~motor vehicle.~~

8       ~~(7) "Special fuel dealer" means any person engaged in the business~~  
9 ~~of delivering special fuel into the fuel supply tank or tanks of a~~  
10 ~~motor vehicle not then owned or controlled by him, or into bulk storage~~  
11 ~~facilities for subsequent use in a motor vehicle. For this purpose the~~  
12 ~~term "fuel supply tank or tanks" does not include cargo tanks even~~  
13 ~~though fuel is withdrawn directly therefrom for propulsion of the~~  
14 ~~vehicle.~~

15       ~~(8) "Special fuel user" means any person purchasing special fuel~~  
16 ~~into bulk storage without payment of the special fuel tax for~~  
17 ~~subsequent use in a motor vehicle, or any person engaged in interstate~~  
18 ~~commercial operation of motor vehicles any part of which is within this~~  
19 ~~state.~~

20       ~~(9) "Service station" means any location at which fueling of motor~~  
21 ~~vehicles is offered to the general public.~~

22       ~~(10) "Unbonded service station" means any service station at which~~  
23 ~~an unbonded special fuel dealer regularly makes sales of special fuel~~  
24 ~~by means of delivery thereof into the fuel supply tanks of motor~~  
25 ~~vehicles.~~

26       ~~(11) "Bond" means: (a) A bond duly executed by such special fuel~~  
27 ~~dealer or special fuel user as principal with a corporate surety~~  
28 ~~qualified under the provisions of chapter 48.28 RCW which bond shall be~~  
29 ~~payable to the state of Washington conditioned upon faithful~~  
30 ~~performance of all requirements of this chapter, including the payment~~  
31 ~~of all taxes, penalties, and other obligations of such dealer, arising~~  
32 ~~out of this chapter; or (b) a deposit with the state treasurer by the~~  
33 ~~special fuel dealer or special fuel user, under such terms and~~  
34 ~~conditions as the department may prescribe, a like amount of lawful~~  
35 ~~money of the United States or bonds or other obligations of the United~~  
36 ~~States, the state of Washington, or any county of said state, of an~~  
37 ~~actual market value not less than the amount so fixed by the~~  
38 ~~department; or (c) such other instruments as the department may~~

1 determine and prescribe by rule to protect the interests of the state  
2 and to insure compliance of the requirements of this chapter.

3 (12) "Lessor" means any person (a) whose principal business is the  
4 bona fide leasing or renting of motor vehicles without drivers for  
5 compensation to the general public, and (b) who maintains established  
6 places of business and whose lease or rental contracts require such  
7 motor vehicles to be returned to the established places of business.

8 (13) "Natural gas" means naturally occurring mixtures of  
9 hydrocarbon gases and vapors consisting principally of methane, whether  
10 in gaseous or liquid form.

11 (14) "Standard pressure and temperature" means fourteen and  
12 seventy-three hundredths pounds of pressure per square inch at sixty  
13 degrees Fahrenheit.

14 (15) "Evasion" or "evade" means to diminish or avoid the  
15 computation, assessment, or payment of authorized taxes or fees  
16 through:

17 (a) A knowing: False statement, misrepresentation of fact, or  
18 other act of deception; or

19 (b) An intentional: Omission, failure to file a return or report,  
20 or other act of deception.) The definitions in this section apply  
21 throughout this chapter unless the context clearly requires otherwise.

22 (1) "Blended fuel" means a mixture of undyed diesel fuel and  
23 another liquid, other than a de minimus amount of the liquid, that can  
24 be used as a fuel to propel a motor vehicle.

25 (2) "Blender" means a person who produces blended special fuel  
26 outside the bulk transfer-terminal system.

27 (3) "Bond" means a bond duly executed with a corporate surety  
28 qualified under chapter 48.28 RCW which bond shall be payable to the  
29 state of Washington conditioned upon faithful performance of all  
30 requirements of this chapter, including the payment of all taxes,  
31 penalties, and other obligations arising out of this chapter.

32 (4) "Bulk transfer-terminal system" means the special fuel  
33 distribution system consisting of refineries, pipelines, vessels, and  
34 terminals. Special fuel in a refinery, pipeline, vessel, or terminal  
35 is in the bulk transfer-terminal system. Special fuel in the fuel tank  
36 of an engine, motor vehicle, or in a railcar, trailer, truck, or other  
37 equipment suitable for ground transportation is not in the bulk  
38 transfer-terminal system.

1       (5) "Bulk transfer" means a transfer of special fuel by pipeline or  
2 vessel.

3       (6) "Bulk storage" means the placing of special fuel into a  
4 receptacle other than the fuel supply tank of a motor vehicle.

5       (7) "Department" means the department of licensing.

6       (8) "Dyed special fuel user" means a person authorized by the  
7 internal revenue code to operate a motor vehicle on the highway using  
8 dyed special fuel, in which the use is not exempt from the special fuel  
9 tax.

10       (9) "Evasion" or "evade" means to diminish or avoid the  
11 computation, assessment, or payment of authorized taxes or fees  
12 through:

13       (a) A knowing: False statement; misrepresentation of fact; or  
14 other act of deception; or

15       (b) An intentional: Omission; failure to file a return or report;  
16 or other act of deception.

17       (10) "Export" means to obtain special fuel in this state for sales  
18 or distribution outside the state.

19       (11) "Highway" means every way or place open to the use of the  
20 public, as a matter of right, for the purpose of vehicular travel.

21       (12) "Import" means to bring special fuel into this state by any  
22 means of conveyance other than the fuel supply tank of a motor vehicle.

23       (13) "International fuel tax agreement licensee" means a special  
24 fuel user operating qualified motor vehicles in interstate commerce and  
25 licensed by the department under the international fuel tax agreement.

26       (14) "Lessor" means any person: (a) Whose principal business is  
27 the bona fide leasing or renting of motor vehicles without drivers for  
28 compensation to the general public; and (b) who maintains established  
29 places of business and whose lease or rental contracts require such  
30 motor vehicles to be returned to the established places of business.

31       (15) "Licensee" means a person holding a license issued under this  
32 chapter.

33       (16) "Motor vehicle" means every self-propelled vehicle designed  
34 for operation upon land utilizing special fuel as the means of  
35 propulsion.

36       (17) "Natural gas" means naturally occurring mixtures of  
37 hydrocarbon gases and vapors consisting principally of methane, whether  
38 in gaseous or liquid form.

1       (18) "Person" means every natural person, fiduciary, association,  
2 or corporation. The term "person" as applied to an association means  
3 and includes the partners or members thereof, and as applied to  
4 corporations, the officers thereof.

5       (19) "Position holder" means a person who holds the inventory  
6 position in special fuel, as reflected by the records of the terminal  
7 operator. A person holds the inventory position in special fuel if the  
8 person has a contractual agreement with the terminal for the use of  
9 storage facilities and terminaling services at a terminal with respect  
10 to special fuel. "Position holder" includes a terminal operator that  
11 owns special fuel in their terminal.

12       (20) "Rack" means a mechanism for delivering special fuel from a  
13 refinery or terminal into a truck, trailer, railcar, or other means of  
14 nonbulk transfer.

15       (21) "Refiner" means a person who owns, operates, or otherwise  
16 controls a refinery.

17       (22) "Removal" means a physical transfer of special fuel other than  
18 by evaporation, loss, or destruction.

19       (23) "Special fuel supplier" means a person who owns and stores  
20 special fuel in a terminal facility or who refines and stores special  
21 fuel at a refinery.

22       (24) "Special fuel exporter" means a person, who purchases special  
23 fuel in this state and exports such fuel by any means other than the  
24 bulk transfer-terminal system to a destination outside of the state.

25       (25) "Special fuel importer" means a person who imports special  
26 fuel into the state by any means other than the bulk transfer-terminal  
27 system. If the importer of record is acting as an agent, the person  
28 for whom the agent is acting is the importer. If there is no importer  
29 of record, the owner of the special fuel at the time of importation is  
30 the importer.

31       (26) "Special fuel user" means any person engaged in uses of  
32 special fuel that are not specifically exempted from the special fuel  
33 tax imposed under this chapter.

34       (27) "Special fuel" means and includes all combustible gases and  
35 liquids suitable for the generation of power for propulsion of motor  
36 vehicles, except that it does not include motor vehicle fuel as defined  
37 in chapter 82.36 RCW.

1       (28) "Special fuel distributor" means a person who acquires special  
2 fuel from a supplier or another distributor for subsequent sale and  
3 distribution.

4       (29) "Standard pressure and temperature" means fourteen and  
5 seventy-three hundredths pounds of pressure per square inch at sixty  
6 degrees Fahrenheit.

7       (30) "Terminal operator" means a person who owns, operates, or  
8 otherwise controls a terminal.

9       (31) "Terminal" means a special fuel storage and distribution  
10 facility that has been assigned a terminal control number by the  
11 internal revenue service, is supplied by pipeline or vessel, and from  
12 which reportable special fuel is removed at a rack.

13       (32) "Two-party exchange" means a transaction in which taxable  
14 special fuel is transferred from one licensed supplier to another  
15 licensed supplier under an exchange agreement whereby the supplier that  
16 is the position holder agrees to deliver taxable special fuel to the  
17 other supplier or the other supplier's customer at the rack of the  
18 terminal at which the delivering supplier is the position holder.

19       **Sec. 7.** RCW 82.38.030 and 1996 c 104 s 7 are each amended to read  
20 as follows:

21       (1) There is hereby levied and imposed upon special fuel users a  
22 tax at the rate computed in the manner provided in RCW 82.36.025  
23 (~~(per)) on each gallon of special fuel, or each one hundred cubic feet~~  
24 ~~of compressed natural gas, measured at standard pressure and~~  
25 ~~temperature ((on the use of special fuel in any motor vehicle operated~~  
26 ~~upon the highways of this state during the fiscal year for which such~~  
27 ~~rate is applicable)).~~

28       (2) The tax (~~shall be collected by the special fuel dealer and~~  
29 ~~shall be paid over to the department as hereinafter provided: (a) With~~  
30 ~~respect to all special fuel delivered by a special fuel dealer into~~  
31 ~~supply tanks of motor vehicles or into storage facilities used for the~~  
32 ~~fueling of motor vehicles at unbonded service stations in this state;~~  
33 ~~or (b) in all other transactions where the purchaser is not the holder~~  
34 ~~of a valid special fuel license issued pursuant to this chapter~~  
35 ~~allowing the purchase of untaxed special fuel, except sales of special~~  
36 ~~fuel for export. To claim an exemption on account of sales by a~~  
37 ~~licensed special fuel dealer for export, the purchaser shall obtain~~  
38 ~~from the selling special fuel dealer, and such selling special fuel~~



1 dealer must furnish the purchaser, an invoice giving such details of  
2 the sale for export as the director may require, copies of which shall  
3 be furnished the department and the entity of the state or foreign  
4 jurisdiction of destination which is charged by the laws of that state  
5 or foreign jurisdiction with the control or monitoring or both, of the  
6 sales or movement of special fuel in that state or foreign  
7 jurisdiction.

8 (3) The tax shall be paid over to the department by the special  
9 fuel user as hereinafter provided with respect to the taxable use of  
10 special fuel upon which the tax has not previously been imposed.

11 It is expressly provided that delivery of special fuel may be made  
12 without collecting the tax otherwise imposed, when such deliveries are  
13 made by a bonded special fuel dealer to special fuel users who are  
14 authorized by the department as hereinafter provided, to purchase fuel  
15 without payment of tax to the bonded special fuel dealer.

16 ~~(4))~~ imposed by subsection (1) of this section is imposed when:

17 (a) Special fuel is removed in this state from a terminal if the  
18 special fuel is removed at the rack;

19 (b) Special fuel is removed in this state from a refinery if either  
20 of the following applies:

21 (i) The removal is by bulk transfer and the refiner or the owner of  
22 the special fuel immediately before the removal is not a licensee; or

23 (ii) The removal is at the refinery rack;

24 (c) Special fuel enters into this state for sale, consumption, use,  
25 or storage if either of the following applies:

26 (i) The entry is by bulk transfer and the importer is not a  
27 licensee; or

28 (ii) The entry is not by bulk transfer;

29 (d) Special fuel is removed in this state to an unlicensed entity  
30 unless there was a prior taxable removal, entry, or sale of the special  
31 fuel;

32 (e) Blended special fuel is removed or sold in this state by the  
33 blender of the fuel. The number of gallons of blended special fuel  
34 subject to tax is the difference between the total number of gallons of  
35 blended special fuel removed or sold and the number of gallons of  
36 previously taxed special fuel used to produced the blended special  
37 fuel; and

1        (f) Dyed special fuel is used on highway, as authorized by the  
2 internal revenue code, unless the use is exempt from the special fuel  
3 tax.

4        (3) The tax (~~(required)~~) imposed by this chapter, if required to be  
5 collected by the (~~(seller)~~) licensee, is held in trust by the  
6 (~~(seller)~~) licensee until paid to the department, and a (~~(seller)~~)  
7 licensee who appropriates or converts the tax collected to his or her  
8 own use or to any use other than the payment of the tax to the extent  
9 that the money required to be collected is not available for payment on  
10 the due date as prescribed in this chapter is guilty of a felony, or  
11 gross misdemeanor in accordance with the theft and anticipatory  
12 provisions of Title 9A RCW. A person, partnership, corporation, or  
13 corporate officer who fails to collect the tax imposed by this section,  
14 or who has collected the tax and fails to pay it to the department in  
15 the manner prescribed by this chapter, is personally liable to the  
16 state for the amount of the tax.

17        NEW SECTION.    **Sec. 8.**    The tax under RCW 82.38.030, if not  
18 previously imposed and paid, shall be paid over to the department by  
19 special fuel users and persons licensed under the international fuel  
20 tax agreement or other fuel tax reciprocity agreements entered into  
21 with the state of Washington, on the use of special fuel to operate  
22 motor vehicles on the highways of this state, unless the use is exempt  
23 from the tax under this chapter.

24        NEW SECTION.    **Sec. 9.**    (1) A position holder shall remit tax to the  
25 department on special fuel removed from a terminal as provided in RCW  
26 82.38.030(2)(a). On a two-party exchange, the receiving exchange  
27 partner becomes the position holder, who shall remit the tax.

28        (2) A refiner shall remit tax to the department on special fuel  
29 removed from a refinery as provided in RCW 82.38.030(2)(b).

30        (3) An importer shall remit tax to the department on special fuel  
31 imported into this state as provided in RCW 82.38.030(2)(c).

32        (4) A blender shall remit tax to the department on the removal or  
33 sale of blended special fuel as provided in RCW 82.38.030(2)(e).

34        (5) A dyed special fuel user shall remit tax to the department on  
35 the use of dyed special fuel as provided in RCW 82.38.030(2)(f).

1        NEW SECTION.    **Sec. 10.**    A terminal operator is jointly and  
2 severally liable for remitting the tax imposed under RCW 82.38.030(1)  
3 if, at the time of removal:

4        (1) The position holder with respect to the special fuel is a  
5 person other than the terminal operator and is not a special fuel  
6 licensee;

7        (2) The terminal operator is not a special fuel licensee;

8        (3) The position holder has an expired internal revenue service  
9 notification certificate issued under chapter 26, C.F.R. Part 48; or

10       (4) The terminal operator had reason to believe that information on  
11 the notification certificate was false.

12       NEW SECTION.    **Sec. 11.**    A terminal operator is jointly and  
13 severally liable for remitting the tax imposed under RCW 82.38.030(1)  
14 if, in connection with the removal of special fuel that is not dyed or  
15 marked in accordance with the United States environmental protection  
16 agency or internal revenue service requirements, the terminal operator  
17 provides any person with a bill of lading, shipping paper, or similar  
18 document indicating that the special fuel is dyed or marked in  
19 accordance with the United States environmental protection agency or  
20 internal revenue service requirements.

21       NEW SECTION.    **Sec. 12.**    A person may not operate or maintain a  
22 motor vehicle on a public highway of this state with dyed special fuel  
23 in the fuel supply tank unless the use is authorized by the internal  
24 revenue code. The special fuel tax set forth in RCW 82.38.030 is  
25 imposed on users of dyed special fuel authorized by the internal  
26 revenue code to operate on-highway motor vehicles using dyed special  
27 fuel, unless the use is exempt from the special fuel tax.

28       NEW SECTION.    **Sec. 13.**    (1) Special fuel that is dyed satisfies the  
29 dyeing requirements of this chapter if it meets the dyeing requirements  
30 of the United States environmental protection agency and the internal  
31 revenue service, including, but not limited to, requirements respecting  
32 type, dosage, and timing.

33       (2) Marking must meet the marking requirements of the internal  
34 revenue service.

1 (3) As required by the internal revenue service, notice is required  
2 with respect to dyed special fuel. A notice stating "DYED DIESEL FUEL,  
3 NONTAXABLE USE ONLY, PENALTY FOR TAXABLE USE" must be:

4 (a) Provided by the terminal operator to a person who receives dyed  
5 special fuel at a terminal rack of that terminal operator;

6 (b) Provided by a seller of dyed special fuel to its buyer if the  
7 special fuel is located outside the bulk transfer-terminal system and  
8 is not sold from a retail pump posted in accordance with the  
9 requirements of this subsection; or

10 (c) Posted by a seller on a retail pump where it sells dyed special  
11 fuel for use by its buyer.

12 **Sec. 14.** RCW 82.38.070 and 1990 c 250 s 83 are each amended to  
13 read as follows:

14 A special fuel (~~dealer~~) supplier shall be entitled(~~(, under rules~~  
15 ~~and regulations prescribed by the department,)~~) to a credit of the tax  
16 paid over to the department on those sales of special fuel for which  
17 the (~~dealer~~) supplier has received no consideration from or on behalf  
18 of the purchaser(~~(, which have been declared by the dealer to be~~  
19 ~~worthless accounts receivable, and which have been claimed as bad debts~~  
20 ~~for federal income tax purposes)~~). The amount of the tax (~~refunded~~)  
21 credit shall not exceed the amount of tax imposed by this chapter on  
22 such sales. If a (~~refund~~) credit has been granted under this

34 or she has not already filed a claim, is notified by the department  
35 that a claim may be filed or the date upon which the claim is approved  
36 by the department, whichever date is earlier.

37 (b) In the case of a credit, to the same date as that to which  
38 interest is computed on the tax or amount against which the credit is  
39 applied.

1 If the department determines that any overpayment has been made  
2 intentionally or by reason of carelessness, it shall not allow any  
3 interest thereon.

4 (6) The department shall pay interest of one percent per month on  
5 any refund payable under RCW 82.38.180 (1), (2), or (6) that is issued  
6 more than thirty business days after the receipt of a claim properly  
7 filed and completed in accordance with this section.

8 (7) No injunction or writ of mandate or other legal or equitable  
9 process shall issue in any suit, action or proceeding in any court  
10 against this state or against any officer of the state to prevent or  
11 enjoin the collection under this chapter of any tax or any amount of  
12 tax required to be collected.

13 **Sec. 31.** RCW 82.38.210 and 1979 c 40 s 15 are each amended to read  
14 as follows:

15 If any special fuel (~~dealer, supplier, or user~~) licensee liable  
16 for the remittance of tax imposed by this chapter fails to pay the  
17 same, the amount thereof, including any interest, penalty, or addition  
18 to such tax, together with any costs that may accrue in addition  
19 thereto, shall be a lien in favor of the state upon all franchises,  
20 property, and rights to property, whether real or personal, then  
21 belonging to or thereafter acquired by such person, whether such  
22 property is employed by such person for personal or business use or is  
23 in the hands of a trustee, or receiver, or assignee for the benefit of  
24 creditors, from the date the taxes were due and payable, until the  
25 amount of the lien is paid or the property sold in payment thereof.  
26 The lien shall have priority over any lien or encumbrance whatsoever,  
27 except the lien of other state taxes having priority by law, and except  
28 that such lien shall not be valid as against any bona fide mortgagee,  
29 pledgee, judgment creditor, or purchaser whose rights have attached  
30 prior to the time the department has filed and recorded notice of such  
31 lien as hereinafter provided.

32 In order to avail itself of the lien hereby created, the department  
33 shall file with any county auditor a statement of claim and lien  
34 specifying the amount of delinquent taxes, penalties and interest  
35 claimed by the department. From the time of filing for record, the  
36 amount required to be paid shall constitute a lien upon all franchises,  
37 property and rights to property, whether real or personal, then  
38 belonging to or thereafter acquired by such person in the county. Any

1 lien as provided in this section may also be filed in the office of the  
2 secretary of state. Filing in the office of the secretary of state  
3 shall be of no effect, however, until the lien or copy thereof shall  
4 have been filed with the county auditor in the county where the  
5 property is located. When a lien is filed in compliance herewith and  
6 with the secretary of state, such filing shall have the same effect as  
7 if the lien had been duly filed for record in the office of the auditor  
8 in each county of this state.

9 **Sec. 32.** RCW 82.38.220 and 1994 c 262 s 26 are each amended to  
10 read as follows:

11 In the event any special fuel (~~(user or special fuel dealer)~~)  
12 licensee is delinquent in the payment of any obligation imposed under  
13 this chapter, the department may give notice of the amount of such  
14 delinquency by registered or certified mail to all persons having in  
15 their possession or under their control any credits or other personal  
16 property belonging to (~~such user or dealer~~) the special fuel licensee  
17 or owing any debts to (~~such user or dealer~~) the special fuel  
18 licensee, at the time of the receipt by them of such notice. Any  
19 person so notified shall neither transfer nor make other disposition of  
20 such credits, personal property, or debts until the department consents  
21 to a transfer or other disposition. All persons so notified must,  
22 within twenty days after receipt of the notice, advise the department  
23 of any and all such credits, personal property, or debts in their  
24 possession, under their control or owing by them, as the case may be,  
25 and shall immediately deliver such credits, personal property, or debts

28 Upon service, the notice and order to withhold and deliver  
29 constitutes a continuing lien on property of the taxpayer. The  
30 department shall include in the caption of the notice to withhold and  
31 deliver "continuing lien." The effective date of a notice to withhold  
32 and deliver served under this section is the date of service of the  
33 notice.

34 If a person fails to answer the notice within the time prescribed  
35 by this section, it is lawful for the court, upon application of the  
36 department and after the time to answer the notice has expired, to  
37 render judgment by default against the party named in the notice to

1 withhold and deliver for the full amount claimed by the department in  
2 the notice to withhold and deliver, together with costs.

3 **Sec. 33.** RCW 82.38.230 and 1979 c 40 s 17 are each amended to read  
4 as follows:

5 Whenever any special fuel (~~((user, supplier or dealer))~~) licensee is  
6 delinquent in the payment of any obligation imposed hereunder, and such  
7 delinquency continues after notice and demand for payment by the  
8 department, the department shall proceed to collect the amount due from  
9 the (~~((user, supplier or dealer))~~) special fuel licensee in the following  
10 manner: The department shall seize any property subject to the lien of  
11 said excise tax, penalty, and interest and thereafter sell it at public  
12 auction to pay said obligation and any and all costs that may have been  
13 incurred on account of the seizure and sale. Notice of such intended  
14 sale and the time and place thereof shall be given to such delinquent  
15 (~~((user, supplier or dealer))~~) special fuel licensee and to all persons  
16 appearing of record to have an interest in such property. The notice  
17 shall be given in writing at least ten days before the date set for the  
18 sale by enclosing it in an envelope addressed to (~~((such user, supplier~~

21 of any person appearing of record to have an interest in such property,

16 in this section, the department may first serve upon the (~~((user's,~~  
17 ~~supplier's, or dealer's))~~) special fuel licensee's bondsman a notice of  
18 the delinquency, with a demand for the payment of the amount due.

19 **Sec. 34.** RCW 82.38.235 and 1979 c 40 s 22 are each amended to read  
20 as follows:

21 Whenever any assessment shall have become final in accordance with  
22 the provisions of this chapter, the department may file with the clerk  
23 of any county within the state a warrant in the amount of the  
24 assessment of taxes, penalties plus interest and a filing fee of five  
25 dollars. The clerk of the county wherein the warrant is filed shall  
26 immediately designate a superior court cause number for such warrant,  
27 and the clerk shall cause to be entered in the judgment docket under  
28 the superior court cause number assigned to the warrant, the name of  
29 the special fuel (~~((user, supplier or dealer))~~) licensee mentioned in the

1 the court shall be entitled to a filing fee of five dollars, which  
2 shall be added to the amount of the warrant.

3 **Sec. 35.** RCW 82.38.240 and 1971 ex.s. c 175 s 25 are each amended  
4 to read as follows:

5 Whenever any special fuel (~~(user or special fuel dealer)~~) licensee  
6 is delinquent in the payment of any obligation hereunder the department  
7 may transmit notice of such delinquency to the attorney general who  
8 shall at once proceed to collect by appropriate legal action the amount  
9 due the state from (~~(such user or dealer)~~) the special fuel licensee.  
10 In any suit brought to enforce the rights of the state hereunder, a  
11 certificate by the department showing the delinquency shall be prima  
12 facie evidence of the amount of the obligation, of the delinquency  
13 thereof and of compliance by the department with all provisions of this  
14 chapter relating to such obligation.

15 **Sec. 36.** RCW 82.38.260 and 1995 c 274 s 25 are each amended to  
16 read as follows:

17 The department shall enforce the provisions of this chapter, and  
18 may prescribe, adopt, and enforce reasonable rules and regulations  
19 relating to the administration and enforcement thereof. The Washington  
20 state patrol and its officers shall aid the department in the  
21 enforcement of this chapter, and, for this purpose, are declared to be  
22 peace officers, and given police power and authority throughout the  
23 state to arrest on sight any person known to have committed a violation  
24 of the provisions of this chapter.

25 The department or its authorized representative is hereby empowered  
26 to examine the books, papers, records and equipment of any special fuel  
27 (~~(dealer, special fuel user,)~~) licensee or any person dealing in,  
28 transporting, or storing special fuel as defined in this chapter and to  
29 investigate the character of the disposition which any person makes of  
30 such special fuel in order to ascertain and determine whether all taxes  
31 due hereunder are being properly reported and paid. The fact that such  
32 books, papers, records and equipment are not maintained in this state  
33 at the time of demand shall not cause the department to lose any right  
34 of such examination under this chapter when and where such records  
35 become available.

36 The department or its authorized representative is further  
37 empowered to investigate the disposition of special fuel by any person



1 where the department has reason to believe that untaxed special fuel  
2 has been diverted to a use subject to the taxes imposed by this chapter  
3 without said taxes being paid in accordance with the requirements of  
4 this chapter.

5 For the purpose of enforcing the provisions of this chapter it  
6 shall be presumed that all special fuel delivered to service stations  
7 as well as all special fuel otherwise received (~~((by a special fuel  
8 dealer or a special fuel user))~~) into storage and dispensing equipment  
9 designed to fuel motor vehicles is delivered (~~((by the special fuel  
10 dealer or special fuel user))~~) into the fuel supply tanks of motor  
11 vehicles and consumed in the propulsion of motor vehicles on the  
12 highways of this state, unless the contrary is established by  
13 satisfactory evidence.

14 The department shall, upon request from the officials to whom are  
15 entrusted the enforcement of the special fuel tax law of any other  
16 state, the District of Columbia, the United States, its territories and  
17 possessions, the provinces or the Dominion of Canada, forward to such  
18 officials any information which he or she may have relative to the  
19 receipt, storage, delivery, sale, use, or other disposition of special  
20 fuel by any special fuel (~~((dealer or special fuel user, provided such))~~)  
21 licensee if the other state or states furnish like information to this  
22 state.

23 Returns required by this chapter, exclusive of schedules, itemized  
24 statements and other supporting evidence annexed thereto, shall at all  
25 reasonable times be open to the public.

26 NEW SECTION. **Sec. 37.** It is intended that the ultimate liability  
27 for the tax imposed under this chapter be upon the user, regardless of  
28 the manner in which collection of the tax is provided for in this  
29 chapter. However, this section shall not apply to agreements between  
30 the department and federally recognized Indian tribes entered into  
31 under RCW 82.38.310, nor shall it apply to the consent decrees entered  
32 in confederated tribes of the *Colville Reservation v. Washington*  
33 *Department of Licensing*, No. CS-92-248-JLQ (E.D. Wash.) and *Teo v.*  
34 *Steffenson*, No. CY-93-3050-AAM (E.D. Wash.).

35 NEW SECTION. **Sec. 38.** A special fuel distributor who incurs  
36 liability in December 1997 for the special fuel tax imposed under this

1 chapter shall report the liability and pay the tax in January 1998 in  
2 the manner required by this chapter before January 1, 1998.

3 A special fuel distributor or special fuel user shall inventory all  
4 special fuel that is on hand or in the person's possession as of 12:01  
5 a.m. on January 1, 1998, and is not in the bulk transfer-terminal  
6 system and shall report the results of the inventory to the department  
7 no later than the last business day of February 1998. The report of  
8 inventory must be made on a form prescribed by the department.

9 A special fuel distributor may pay the tax due on fuel in inventory  
10 any time before February 28, 1999, but at least one-twelfth of the  
11 amount due must be paid by the last day of each month starting with  
12 February 1998. Payments not received in accordance with this section  
13 are late and are subject to the interest and penalty provisions of this  
14 chapter. Payments made after February 1999 are late and are subject to

16 A special fuel user shall pay the tax due on fuel in inventory in  
17 accordance with the filing frequency assigned to the user before the  
18 effective date of this act. Payments not received in accordance with  
19 the filing frequency are late and are subject to the interest and  
20 penalty provisions of this chapter.

21 NEW SECTION. **Sec. 39.** A licensee holding both a special fuel user  
22 and international fuel tax agreement license issued under this chapter  
23 as of December 31, 1997, is entitled to a credit of five percent of the  
24 licensee's special fuel tax liability on net taxable gallons reported  
25 on the licensee's fourth quarter 1997 international fuel tax agreement  
26 tax return. In addition to accepting the credit, the licensee may  
27 elect to enter into a deferred payment contract with the department.  
28 The contract shall allow the licensee to defer payment of the  
29 licensee's fourth quarter 1997 Washington special fuel tax liability

5 by law without first issuing a notice of correction if: (1) The person  
6 has previously been subject to an enforcement action for the same or  
7 similar type of violation of the same statute or rule or has been given  
8 previous notice of the same or similar type of violation of the same  
9 statute or rule; or (2) compliance is not achieved by the date  
10 established by the department in a previously issued notice of

32       (2) "Special fuel" has the meaning given in RCW 82.38.020(~~(+5)~~).

33       (3) "Motor vehicle" has the meaning given in RCW 82.36.010(~~(+1)~~).

34       **Sec. 42.** RCW 82.80.010 and 1991 c 339 s 12 are each amended to  
35 read as follows:

36       (1) Subject to the conditions of this section, any county may levy,  
37 by approval of its legislative body and a majority of the registered

1 voters of the county voting on the proposition at a general or special  
2 election, additional excise taxes equal to ten percent of the state-  
3 wide motor vehicle fuel tax rate under RCW 82.36.025 on each gallon of  
4 motor vehicle fuel as defined in RCW 82.36.010(~~(+2)~~) and on each  
5 gallon of special fuel as defined in RCW 82.38.020(~~(+5)~~) sold within

5        NEW SECTION.    **Sec. 44.** The department of licensing, in cooperation  
6 with the fuel tax advisory committee, shall prepare and submit a report  
7 to the legislative transportation committee containing recommendations  
8 for special fuel and motor vehicle fuel recordkeeping and tax reporting

25        NEW SECTION.    **Sec. 48.** This act takes effect January 1, 1998.
