- 1 AN ACT Relating to training for state investigators; creating a new
- 2 section; and providing an expiration date.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislature finds that there is a
- 5 need for more coordinated and uniform training and protocols for state
- 6 investigators. State investigators are employed by numerous state
- 7 agencies and separately elected offices. Currently there is minimal
- 8 training on policies and procedures for investigations, enforcement,
- 9 and scope of duties and responsibilities. It is the intent of the
- 10 legislature to commission a study group to develop mandatory training,
- 11 policies, and procedures for state investigators.
- 12 (2) The study group shall focus on state investigators in the
- 13 following agencies: Attorney general's office; auditor's office;
- 14 department of corrections; department of health; department of labor
- 15 and industries; department of licensing; department of revenue; liquor
- 16 control board; public disclosure commission; and Washington state
- 17 patrol.
- 18 (3) The study group shall consist of: The attorney general; chief
- 19 of the state patrol; state auditor; one legislator from each caucus of

- 1 the senate and house of representatives, as appointed by leaders of the
- 2 caucuses; a representative from the governor's office; two
- 3 representatives of state agencies appointed by the governor; a
- 4 representative appointed by the Washington association of prosecuting
- 5 attorneys; a representative appointed by the Washington association of
- 6 sheriffs and police chiefs; and a representative appointed by the
- 7 criminal justice program at Washington State University. The study
- 8 group shall be cochaired by the attorney general and the chief of the
- 9 state patrol.
- 10 (4) The study group shall:
- 11 (a) Develop minimum ongoing training requirements for state
- 12 investigators. Training must include education in civil investigations
- 13 and recognition of crimes for transfer to appropriate law enforcement
- 14 agencies;
- 15 (b) Evaluate current training requirements, policies, and
- 16 procedures for state investigators;
- 17 (c) Recommend who will provide training, how it will be done, and
- 18 minimal training requirements;
- 19 (d) Recommend basic policies and procedures for state
- 20 investigators;
- 21 (e) Develop cost estimates for mandatory training;
- 22 (f) Make recommendations on the scope of duties and
- 23 responsibilities for state investigators; and
- 24 (g) Include other issues related to state investigators, as desired
- 25 by the study group.
- 26 (5) The study group shall deliver its recommendations to the
- 27 legislature by December 1, 1997.
- 28 (6) This section shall expire June 1, 1998.
