## HOUSE BILL 1902

State of Washington 55th Legislature 1998 Regular Session

AN ACT Relating to offenses involving the taking of a motor vehicle; amending RCW 9A.56.040; reenacting and amending RCW 9.94A.320; adding a new section to chapter 9A.56 RCW; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 9A.56 RCW 6 to read as follows:

7 (1) A person is guilty of motor vehicle theft if the person commits8 theft of a motor vehicle, regardless of its value.

9 (2) Motor vehicle theft is a class B felony.

Sec. 2. RCW 9.94A.320 and 1996 c 302 s 6, 1996 c 205 s 3, and 1996 c 36 s 2 are reenacted and each amended to read as follows:
