- 1 AN ACT Relating to excise tax exemptions for home-based instruction
- 2 supplies; adding a new section to chapter 82.08 RCW; adding a new
- 3 section to chapter 82.12 RCW; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.08 RCW 6 to read as follows:
- 7 (1) A person is entitled to an exemption in the form of a
- 8 remittance of all or part of the tax imposed by RCW 82.08.020 on
- 9 educational supplies used in home-based instruction. A person claiming
- 10 an exemption under this section shall pay the tax imposed by RCW
- 11 82.08.020 to the seller. The buyer may then apply to the department
- 12 for remittance of the tax. The amount of remittance under this section
- 13 shall not exceed the tax paid on three thousand dollars per year of
- 14 educational supplies purchased during a school year by the person's
- 15 household. Taxes imposed under chapter 82.14 RCW are not subject to
- 16 exemption under this section.
- 17 (2) A person shall file a claim for reimbursement under this
- 18 section on forms as prescribed by the department and within ninety days
- 19 after the close of the school year. The claim must be accompanied by

- 1 a copy of the declaration of intent for home-based instruction filed
- 2 under RCW 28A.200.010 for the school year, and other supporting
- 3 information as required by the department.
- 4 (3) For purposes of this section:
- 5 (a) "Educational supplies" means supplies used only in providing
- 6 home-based instruction and includes textbooks, instructional materials,
- 7 and related supplies comparable to those typically used in classroom
- 8 instruction.
- 9 (b) "Home-based instruction" means home-based instruction under RCW
- 10 28A.225.010(4).
- 11 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.12 RCW
- 12 to read as follows:
- 13 The provisions of this chapter do not apply in respect to the use
- 14 of educational supplies used in home-based instruction. For purposes
- 15 of this section "educational supplies" and "home-based instruction" are
- 16 defined as provided in section 1 of this act.
- 17 <u>NEW SECTION.</u> **Sec. 3.** This act takes effect October 1, 1997.
