1 AN ACT Relating to ethics in public service; and amending RCW
2 42.52.030.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 42.52.030 and 1996 c 213 s 3 are each amended to read
5 as follows:

6 (1) No state officer or state employee, except as provided in
7 subsections (2) ~~((and))~~, (3), (4), and (5) of this section, may be
8 beneficially interested, directly or indirectly, in a contract, sale,
9 lease, purchase, or grant that may be made by, through, or is under the
10 supervision of the officer or employee, in whole or in part, or accept,
11 directly or indirectly, any compensation, gratuity, or reward from any
12 other person beneficially interested in the contract, sale, lease,
13 purchase, or grant.

14 (2) No officer or employee of an institution of higher education or
15 of the Spokane intercollegiate research and technology institute,
16 except as provided in subsection (3) of this section, may be
17 beneficially interested, directly or indirectly, in a contract or grant
18 that may be made by, through, or is under the supervision of the
19 officer or employee, in whole or in part, or accept, directly or

1 indirectly, any compensation, gratuity, or reward from any other person
2 beneficially interested in the contract or grant, unless the
3 institution of higher education or the Spokane intercollegiate research
4 and technology institute has in effect a written administrative process
5 to identify and manage, reduce, or eliminate conflicting interests with
6 respect to such transactions as adopted pursuant to the national
7 science investigator financial disclosure (GPM 510) 1995 and the public
8 health service regulations, 42 C.F.R. Part 50 and 45 C.F.R. Subtitle A
9 as each of those regulations existed on June 6, 1996, and the state
10 employee or state officer has complied with such policy.

11 (3) No state officer or state employee, except as provided in
12 subsections (4) and (5) of this section, may participate in a
13 transaction involving the state in his or her official capacity with a
14 person of which the officer or employee is an officer, agent, employee,
15 or member, or in which the officer or employee owns a beneficial
16 interest, except that an officer or employee of an institution of
17 higher education or the Spokane intercollegiate research and technology
18 institute may serve as an officer, agent, employee, or member, or on
19 the board of directors, board of trustees, advisory board, or committee
20 or review panel for any nonprofit institute, foundation, or fundraising
21 entity; and may serve as a member of an advisory board, committee, or
22 review panel for a governmental or other nonprofit entity.

23 (4) This section does not apply to a state officer or employee who
24 is a member of a board, commission, or committee if the officer's or
25 employee's beneficial interest in the person involved in the
26 transaction is ten thousand dollars or less or is less than one percent
27 of the value of the person involved in the transaction, whichever is
28 less.

29 (5) A state officer or employee who is a member of a board,
30 commission, or committee and whose beneficial interest in the person
31 involved in the transaction exceeds ten thousand dollars or one percent
32 of the value of the person involved in the transaction must: (a)
33 Disclose the interest; (b) recuse himself or herself from voting on the
34 transaction; and (c) not influence or attempt to influence the vote of
35 any other member of the board, commission, or committee.
