## ENGROSSED SUBSTITUTE HOUSE BILL 2730

State of Washington 55th Legislature 1998 Regular Session

By House Committee on Transportation Policy & Budget (originally sponsored by Representatives Robertson, Hatfield, Mitchell, Fisher, Hankins, Romero, Cairnes, O'Brien, Zellinsky, Scott, Johnson, Wood, Sterk, Ogden, Radcliff, Hickel, Skinner, Ballasiotes, Delvin, Cooke, Anderson, Sullivan, Thompson, Gardner and Kenney)

- AN ACT Relating to security of drivers' licenses; amending RCW 46.20.091, 46.20.117, 46.20.161, and 46.20.181; reenacting and amending
- 3 RCW 46.63.020; adding a new section to chapter 46.04 RCW; adding new
- 4 sections to chapter 46.20 RCW; adding a new section to chapter 42.17
- 5 RCW; creating a new section; prescribing penalties; and providing an
- 6 effective date.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that while the 9 driver's license was designed to be a declaration of the privilege to
- 10 operate a motor vehicle, drivers' licenses and identicards issued by
- 11 the department of licensing have become the most widely accepted forms
- 12 of personal identification used by Washington residents. There is an
- 13 increasing use of false drivers' licenses and identicards to purchase
- 14 liquor, to cash bad checks, and to obtain food stamps and other
- 15 benefits, often at the expense of law-abiding residents. In
- 16 recognition of these losses that are borne by taxpayers, businesses,
- 17 and government, Congress has recently directed the states to produce
- 18 counterfeit-resistant drivers' licenses. It is the purpose of this act
- 19 to require effective means of rendering drivers' licenses and

- 1 identicards as immune as possible from alteration and counterfeiting in
- 2 order to promote the public health and safety of the people of this
- 3 state.
- 4 NEW SECTION. Sec. 2. A new section is added to chapter 46.04 RCW
- 5 to read as follows:
- 6 "Biometrics" means physical attributes that are unique to
- 7 individual persons. Biometrics includes but is not limited to finger
- 8 images, iris/retinal scans, vein patterns, facial images, and
- 9 hand/finger geometry.
- 10 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 46.20 RCW
- 11 to read as follows:
- By July 1, 1999, the department shall enter into a contract for the
- 13 procurement of a new state driver's license and identicard. The
- 14 contract shall incorporate, but not be limited to, the following
- 15 features subject to the listed restrictions:
- 16 (1) A digital imaging system. A digital imaging system permits a
- 17 person's photograph and signature to be stored and displayed by
- 18 computer, which allows for improved file management, flexibility,
- 19 responsiveness, and fraud protection. Facial recognition technology
- 20 that would allow a one-to-many search may not be applied by the
- 21 department or any subsequent user of the digital photograph. A one-to-
- 22 many search compares the photograph to all of the other photographs to
- 23 determine if there is a match. However, the department may compare the
- 24 photograph against the individual applying for a license, license
- 25 renewal, or identicard.
- 26 (2) Machine-readable technologies, including a one-dimensional bar
- 27 code, two-dimensional bar code, or a magnetic stripe. Through
- 28 encryption, both the magnetic stripe and two-dimensional bar code offer
- 29 additional levels of security against alteration and counterfeiting.
- 30 (a) Information included on a driver's license in machine-readable
- 31 form may be accessed by the director, the chief of the Washington state
- 32 patrol, commissioned law enforcement officers, district courts,
- 33 municipal courts, superior courts, and city and county prosecuting
- 34 attorneys.
- 35 (b) Except as authorized by this section, a person accessing
- 36 information encrypted in machine-readable form on a driver's license is
- 37 guilty of a gross misdemeanor.

- 1 (3) A central issuance system. A central issuance system requires 2 the issuance of permanent licenses and identicards from one central, 3 secure location. Upon verification of eligibility, the license or 4 identicard will be mailed to the resident.
- 5 (4) A second picture of the card holder printed on the license or 6 identicard in ultraviolet ink. Digital printing enables the 7 applicant's ultraviolet picture to be added to the license or 8 identicard at the time of issuance for presentation of information that 9 is uniquely tied to the card holder.
- 10 **Sec. 4.** RCW 46.20.091 and 1996 c 287 s 5 are each amended to read 11 as follows:
- (1) Every application for an instruction permit or for an original 12 13 driver's license shall be made upon a form prescribed and furnished by 14 the department which shall be sworn to and signed by the applicant 15 before a person authorized to administer oaths. An applicant making a 16 false statement under this subsection is quilty of false swearing, a gross misdemeanor, under RCW 9A.72.040. Every application for an 17 18 instruction permit containing a photograph shall be accompanied by a fee of five dollars. The department shall forthwith transmit the fees 19 collected for instruction permits and temporary drivers' permits to the 20 21 state treasurer.

- (2) Every such application shall state the full name, date of birth, sex, and Washington residence address of the applicant, and briefly describe the applicant, and shall state whether the applicant has theretofore been licensed as a driver or chauffeur, and, if so, when and by what state or country, and whether any such license has ever been suspended or revoked, or whether an application has ever been refused, and, if so, the date of and reason for such suspension, revocation, or refusal, and shall state such additional information as the department shall require, including a statement that identifying documentation presented by the applicant is valid. Except for submitting a digital photograph as authorized by section 3 of this act, the department shall neither request nor require an applicant to submit biometrics as part of an application under this section.
- 35 (3) Whenever application is received from a person previously 36 licensed in another jurisdiction, the department shall request a copy 37 of such driver's record from such other jurisdiction. When received,

- 1 the driving record shall become a part of the driver's record in this 2 state.
- 3 (4) Whenever the department receives request for a driving record 4 from another licensing jurisdiction, the record shall be forwarded 5 without charge if the other licensing jurisdiction extends the same 6 privilege to the state of Washington. Otherwise there shall be a 7 reasonable charge for transmittal of the record, the amount to be fixed 8 by the director of the department.
- 9 **Sec. 5.** RCW 46.20.117 and 1993 c 452 s 3 are each amended to read 10 as follows:
- (1) The department shall issue "identicards," containing a picture, 11 12 to nondrivers for a fee of ((four)) six dollars. However, the fee shall be the actual cost of production to recipients of continuing 13 14 public assistance grants under Title 74 RCW who are referred in writing 15 to the department by the secretary of social and health services. fee shall be deposited in the highway safety fund. To be eligible, 16 each applicant shall produce evidence as required in RCW 46.20.035 that 17 18 positively proves identity. The "identicard" shall be distinctly designed so that it will not be confused with the official driver's 19 license. The identicard shall expire on the fifth anniversary of the 20 21 applicant's birthdate after issuance.
- (2) The department may cancel an "identicard" upon a showing by its records or other evidence that the holder of such "identicard" has committed a violation relating to "identicards" defined in RCW 46.20.336.
- 26 **Sec. 6.** RCW 46.20.161 and 1990 c 250 s 40 are each amended to read 27 as follows:
- 28 (1) The department, upon receipt of a fee of ((fourteen)) twenty 29 dollars, which includes the fee for the required photograph, shall issue to every applicant qualifying therefor a driver's license, which 30 license shall bear thereon a distinguishing number assigned to the 31 32 licensee, the full name, date of birth, Washington residence address, 33 and a brief description of the licensee, and either a facsimile of the signature of the licensee or a space upon which the licensee shall 34 35 write his usual signature with pen and ink immediately upon receipt of the license. No license is valid until it has been so signed by the 36

licensee.

- 1 (2) As authorized by section 3 of this act, the department may also
- 2 include the information specified by subsection (1) of this section,
- 3 <u>but no other information</u>, on a <u>driver's license in machine-readable</u>
- 4 form. Any information included on a driver's license in a form that
- 5 can only be read by machine must be encrypted.
- 6 **Sec. 7.** RCW 46.20.181 and 1990 c 250 s 41 are each amended to read 7 as follows:
- 8 Every driver's license expires on the fourth anniversary of the
- 9 licensee's birthdate following the issuance of the license. Every such
- 10 license is renewable on or before its expiration upon application
- 11 prescribed by the department and the payment of a fee of ((fourteen))
- 12 twenty dollars. This fee includes the fee for the required photograph.
- NEW SECTION. Sec. 8. A new section is added to chapter 46.20 RCW to read as follows:
- Beginning October 1, 2000, the federal Illegal Immigration Control
- 16 Act, P.L. 104-208, requires states to either place drivers' social
- 17 security numbers on the face of their licenses, or to complete a social
- 18 security verification process. The legislature finds that requiring
- 19 the placement of social security numbers on drivers' licenses means
- 20 that whenever someone shows his or her driver's license, the person
- 21 will also be exposing his or her social security number. With the
- 22 social security number accessible to so many people, it will be
- 23 relatively easy for someone to fraudulently use another's social
- 24 security number to assume that person's identity and gain access to
- 25 bank accounts, credit services, billing information, driving history,
- 26 and other sources of personal information. The new federal law will
- 27 compound and exacerbate the disturbing trend of social security number-
- 28 related fraud. In order to prevent fraud and curtail invasions of
- 29 privacy, the governor, through the department of licensing, shall seek
- 30 a waiver to the federal mandate. If a waiver is not granted, the
- 31 department shall rely only upon the verification process prescribed in
- 32 the federal law. In no event may the social security number be placed
- 33 on the driver's license or identicard.
- 34 Sec. 9. RCW 46.63.020 and 1997 c 229 s 13 and 1997 c 66 s 8 are

- 16 effect July 1, 1999.
