- 1 AN ACT Relating to distribution of lottery revenues to the state
- 2 general fund; and amending RCW 67.70.040.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 67.70.040 and 1994 c 218 s 4 are each amended to read 5 as follows:
- 6 The commission shall have the power, and it shall be its duty:
- 7 (1) To promulgate such rules governing the establishment and
- 8 operation of a state lottery as it deems necessary and desirable in
- 9 order that such a lottery be initiated at the earliest feasible and
- 10 practicable time, and in order that such lottery produce the maximum
- 11 amount of net revenues for the state consonant with the dignity of the
- 12 state and the general welfare of the people. Such rules shall include,
- 13 but shall not be limited to, the following:
- 14 (a) The type of lottery to be conducted which may include the
- 15 selling of tickets or shares. The use of electronic or mechanical
- 16 devices or video terminals which allow for individual play against such
- 17 devices or terminals shall be prohibited. Approval of the legislature
- 18 shall be required before entering any agreement with other state
- 19 lotteries to conduct shared games;

- (b) The price, or prices, of tickets or shares in the lottery; 1
- 2 (c) The numbers and sizes of the prizes on the winning tickets or shares; 3
 - (d) The manner of selecting the winning tickets or shares;

- (e) The manner and time of payment of prizes to the holder of 5 winning tickets or shares which, at the director's option, may be paid 6 7 in lump sum amounts or installments over a period of years;
- 8 (f) The frequency of the drawings or selections of winning tickets 9 or shares. Approval of the legislature is required before conducting 10 any on-line game in which the drawing or selection of winning tickets occurs more frequently than once every twenty-four hours; 11
- (g) Without limit as to number, the type or types of locations at 12 13 which tickets or shares may be sold;
 - (h) The method to be used in selling tickets or shares;
- 15 (i) The licensing of agents to sell or distribute tickets or shares, except that a person under the age of eighteen shall not be 16 17 licensed as an agent;
- (j) The manner and amount of compensation, if any, to be paid 18 19 licensed sales agents necessary to provide for the adequate 20 availability of tickets or shares to prospective buyers and for the convenience of the public. A bonus or marketing incentive may not be 21 given in the form of cash unless the omnibus appropriations act 22 specifically appropriates moneys for such cash incentives; 23
 - (k) The apportionment of the total revenues accruing from the sale of lottery tickets or shares and from all other sources among: (i) Transfer to the state's general fund, which shall not be less than the proportion of gross annual revenue specified in the omnibus appropriations act, (ii) the payment of prizes to the holders of winning tickets or shares, which shall not be less than forty-five percent of the gross annual revenue from such lottery, (((ii))) and (iii) transfers to the lottery administrative account created by RCW 67.70.260((, and (iii) transfer to the state's general fund)). Transfers to the state general fund shall be made in compliance with
- 33 34 RCW 43.01.050;
- 35 (1) Such other matters necessary or desirable for the efficient and economical operation and administration of the lottery and for the 36 convenience of the purchasers of tickets or shares and the holders of 37 winning tickets or shares. 38

- 1 (2) To ensure that in each place authorized to sell lottery tickets 2 or shares, on the back of the ticket or share, and in any advertising 3 or promotion there shall be conspicuously displayed an estimate of the 4 probability of purchasing a winning ticket.
- 5 (3) To amend, repeal, or supplement any such rules from time to 6 time as it deems necessary or desirable.
- 7 (4) To advise and make recommendations to the director for the 8 operation and administration of the lottery.
